Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the SSMG 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the SSMG 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of the Senior Solutions Management Group (the "Company", "Employer" or "Plan Sponsor") who have completed 1,000 hours of service within one year following the date of hire and have attained age 21. Effective July 1, 2022, the Plan was amended to change the service requirement to 60 days of service, and employees may enter the Plan on the first day of the month coinciding with or following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. For the year ending December 31, 2024, the Plan Sponsor contributed 25% of the first 4% of elective deferrals that a participant contributed to the Plan. The Company may make non-elective contributions equal to a portion of all participant pre-tax annual compensation or a non-elective discretionary amount. For the year ending December 31, 2024, there was no non-elective contribution. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations established by the Internal Revenue Service (IRS).

Participant Accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately fully vested in their contributions and actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. As of February 24, 2023, the Plan Sponsor amended the Plan to change Company match and non-elective contributions to be immediately 100% vested. Prior to the amendment, Company contributions were vested on an incremental scale with full vesting after 6 years of service.

Payment of Benefits - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount equal to the value of the participant's vested interest, or installment payments over a period of time of not more than the participant's assumed life expectancy. If the participant's account balance is \$5,000 or less, then the vested account balance may only be distributed in a lump sum and will be distributed regardless of participant consent.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6 and \$1,035, respectively. These accounts will be used to reduce employer contributions or pay expenses. In 2024, \$1,039 of plan expenses were paid by forfeitures.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan and allocated to participants, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. The Plan recognized administrative expenses of \$37,155 in 2024.

Subsequent Events - The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure.

NOTE 3 - INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Lincoln National Life Insurance Company, the custodian, that the information in the accompanying financial statements and supplementary schedule of assets held at year end with respect to investments and related investment activity, is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The information certified by the custodian is presented based upon their certifications.

There are no participant redemption restrictions for these investments. The redemption notice period is applicable only to the Plan.

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments totaling \$2,112,519 and \$1,900,748 at December 31, 2024 and 2023, respectively, are managed by Lincoln National Life Insurance Company. Lincoln National Life Insurance Company is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

The Plan Sponsor provides the Plan with certain accounting, auditing and administrative services for which no fees are charged to the Plan.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - TAX STATUS

The Plan Sponsor adopted a non-standardized preapproved plan sponsored by Tennessee Pension Administrators, LLC. The Internal Revenue Service has determined and informed the creator of the preapproved plan by letter dated June 30, 2020, that the preapproved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not applied for its own opinion letter and has been amended since receiving the determination letter, the plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company was considered delinquent in remitting multiple employee contributions totaling \$41,648 during the years ended December 31, 2023 and 2022. The Company has remitted all employee contributions, but has not yet corrected lost earnings for these delinquent contributions as of December 31, 2024.
