Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental Schedule H, Line 4a – Schedule of Delinquent Participant Contributions and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of or for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of Plan

The following brief description of the KML Law Group, P.C. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all of the employees of KML Law Group, P.C. (the Company and the plan sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan trustee is responsible for oversight of the Plan. The plan trustee also determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All of the employees of the Company, except nonresident aliens, independent contractors, residents of Puerto Rico, leased employees, and employees subject to a collective bargaining agreement, who have completed one year of service are eligible to enroll in the Plan. New participants may enroll on the first day of the plan year or the first day of the seventh month of the plan year upon meeting the service requirements.

Contributions

Each year participants may contribute up to 100% of their pretax annual compensation or after-tax (Roth) annual compensation, as defined by the Plan, not to exceed the limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions and their allocated employer contributions into various investment options offered by the Plan. In addition, the Plan contains a permitted disparity provision under which the Company may elect to make its profit sharing contribution. Additional profit sharing and safe harbor amounts may be contributed at the option of the Company's board of directors. The Plan exercised its option to make discretionary profit sharing contributions to certain employees during the plan year ended December 31, 2024. In 2024, the Plan exercised its option to make a 3% safe harbor contribution on behalf of all employees who were participants during the plan year ended December 31, 2024. The employer contributions amounted to \$283,449 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings, and charged with an allocation of administrative expenses. Allocations of the Company's contributions are based on the participant's compensation and allocations of administrative expenses are based on the participant's account balance or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts is based on continuous years of service. A participant becomes fully vested upon the completion of six years of credited service, with profit sharing contributions first being vested after two years of credited service. A credited year of service is defined by the Plan as any calendar year in which an employee completes a minimum of one thousand hours of compensated service with the Company.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for a loan used to acquire a principal residence. The loans are secured by the balance in the participants' account and bear interest at the rate of 1% above the prime rate, as defined. A participant may only have two loans outstanding at a time. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts total \$104 and \$102, respectively. These accounts may be used to reduce future employer contributions or pay administrative expenses. There were no forfeiture amounts used to reduce employer contributions or pay administrative expenses in 2024.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Contributions

Contributions from plan participants and the safe harbor and profit sharing contributions from the Company, as applicable, are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investment contracts held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan trustee determines the Plan's valuation policies utilizing information provided by the investment advisers, the custodians, and the trustee. See Note 4 for discussion of fair value measurements. Investments in life insurance policies are valued at the policy account value as stated by the insurance company. These assets are held in variable life insurance policies and are invested in pooled separate accounts. The value of the interest in these policies is the cash surrender value of the policies based on the underlying investments.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(2) Summary of Significant Accounting Policies, Continued

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

(3) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ending December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Empower Trust Company, LLC (Empower) and Empower Annuity Insurance Company of America (EAICA), qualified institutions. Cash surrender value of life insurance policies are excluded from the certifications.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are an open end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Guaranteed Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with EAICA totaling \$148,125 and \$223,006 at December 31, 2024 and 2023, respectively. EAICA maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest rate guarantees of the EAICA investment contract are backed by assets held by the EAICA general account. Credited rates are set based on yields earned each quarter. The average yield earned by the Plan for 2024 is 1.66%.

Subsequent renewal rates are based on the investment performance of the general account at the time of renewal. Credited rates are guaranteed for the duration of the guaranteed period, and do not vary with the subsequent performance of assets of the general account which back these guarantees.

Certain events may limit the ability of the plan sponsor and/or plan participants to transact at contract value with EAICA. Examples of these events would include (but would not be limited to) premature termination of this contract and termination of the Plan. In these events, the contract value could be reduced by any applicable surrender charges upon distribution of the contract's funds. The plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

(6) Related Party Transactions and Party-In-Interest Transactions

The Plan invests in a guaranteed investment contract managed by EAICA and registered investment companies. The custodian and trustee of the Plan transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments. Fees paid by the Plan for participant initiated transactions and recordkeeping services amounted to \$41,692 for the year ended December 31, 2024. The Company pays directly any other fees related to the Plan's operations.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

(8) Tax Status

The Plan uses a non-standardized pre-approved plan document sponsored by MandMarblestone PC (Mand). Mand received a letter from the IRS dated June 30, 2020, as to the prototype plan's qualified status. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risk and Uncertainties

The Plan invests in various investments. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(10) Nonexempt Transactions

During 2022, the Company failed to remit to the Plan's custodian certain participant contributions and loan repayments totaling \$24,148 within the period prescribed by the Department of Labor's regulations. Delays in remitting contributions and loan repayments were due to administrative errors, and the Company is in the process of making contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays.
