## Independent Auditors' Report

### The Board of Directors of Isabella Employee Retirement Plan

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the Isabella Employee Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (liquidation basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (liquidation basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Emphasis of Matters – Plan Termination and Liquidation Basis of Accounting***

As discussed in Note 1 to the financial statements, the Isabella Geriatric Center ("Employer") became an affiliated agency of the MJHS Health System and as a result, the Plan terminated effective November 15, 2019. As a result of the termination, the Plan changed its basis of accounting to the liquidation basis on November 15, 2019.

As discussed in Note 1 to the financial statements, in December 2017, the Employer became an affiliated agency of the MJHS Health System. The Employer will remain a separate entity. In March 2019, a substantial portion of the Plan's assets were transferred into the Metropolitan Jewish Health System, Inc. 403(b) Plan ("MJHS 403(b) Plan"). Eligible employees of the Employer became participants in the MJHS 403(b) Plan.

Effective December 31, 2024, all remaining assets of the Plan were transferred to the MJHS 403(b) Plan. As a result, the Plan ceased to exist as of this date.

Our opinion is not modified with respect to these matters.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### **1. Description of Plan**

The following description of the Isabella Employee Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan was a defined contribution plan covering substantially all employees of Isabella Geriatric Center (the "Sponsor" or "Employer"). An employee was eligible for participation in the Plan upon their date of hire. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In December 2017, the Employer became an affiliated agency of the MJHS Health System. The Employer will remain a separate entity. In March 2019, a substantial portion of the Plan's assets were transferred into the Metropolitan Jewish Health System, Inc. 403(b) Plan ("MJHS 403(b) Plan"). Eligible employees of the Employer became participants in the MJHS 403(b) Plan. As a result, the Plan terminated effective November 15, 2019.

Effective December 31, 2024, all remaining assets of the Plan were transferred to the MJHS 403(b) Plan. As a result, the Plan ceased to exist as of this date.

#### ***Contributions***

As a result of the Plan's termination, no participant or Employer contributions were made to the Plan during the 2024 Plan year.

#### ***Vesting***

A participant was 100% vested in their contributions and Employer contributions including allocated earnings thereon at all times.

#### ***Participant Accounts***

Each participant's account was credited with the participant's contributions and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations were based on a participant's earnings, account balances, or specific participant transactions, as defined in the Plan document.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant was entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. As a result of the Plan's termination, the Plan no longer had any active participants as of December 31, 2024.

## 1. Description of Plan *(continued)*

### ***Loans to Participants/Collateralized Assets***

The Plan offered a collateralized loan feature whereby a participant (borrower) enrolled in the Plan could borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant were made directly from Lincoln Life and Annuity Company of New York ("Lincoln Life"). The participant's account was not reduced by the loan amount, but served as security for the loan, the loan amount was moved into a fixed income collateral account within the borrower's account. The loan had to be repaid directly to Lincoln Life within a five-year period in substantially equal payments (not less frequently than quarterly). The five-year repayment period did not apply to a loan that was used to acquire a principal residence of the borrower.

If the borrower did not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan was deemed in default and the borrower was not eligible to take out any new loans.

At December 31, 2024 and 2023, there were 7 loans outstanding with principal balances due of \$61,561 which represent a collateralization of participant accounts. All of these loan balances were in default as of December 31, 2024 and 2023. Interest rates on these loans range from 5.45% to 6.45%. As a result of the transfer of assets (see note 1), these loans are collateralized by the assets transferred to the MJHS 403(b) Plan.

## 2. Summary of Significant Accounting Policies

### ***Basis of Accounting***

The financial statements of the Plan have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

### ***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

### **2. Summary of Significant Accounting Policies (*continued*)**

#### ***Investment Valuation and Income Recognition***

All investments of the Plan were stated at fair value except for the guaranteed investment contracts, which were stated at contract value.

Mutual funds were valued at fair value based on the daily closing price as reported by the funds. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (“NAV”) and to transact at that price and were actively traded.

The guaranteed investments contracts were valued at contract value, which represented deposits made to the contracts, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Investments in pooled separate accounts were reported at fair value based on the value reported to the Plan by the insurance company, which represented the fair value of the underlying investments comprising the accounts.

Unrealized and realized appreciation of investments during the year was included in net appreciation in value of investments in the statements of change in net assets available for benefits. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

#### ***Payment of Benefits***

Benefits were recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan were paid by the Employer and were excluded from these financial statements. Investment related expenses were included in net appreciation in value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 6, 2025.

### 3. Information Certified (Unaudited) and Uncertified and Audited

Certain information related to investments disclosed in the accompanying financial statements (liquidation basis) and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (liquidation basis), including investments held at December 31, 2023, and net appreciation in value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company (“Empower”), and Lincoln Life and Annuity Company of New York (“Lincoln Life”), qualified institutions.

Invesco held a portion of the Plan’s investment assets at December 31, 2023 (uncertified) and executed certain investment transactions for the year ended December 31, 2024 and such investment balances and transactions have not been certified.

### **5. Benefit-Responsive Contracts with Insurance Company**

#### ***Guaranteed Interest Account***

The Plan had a Guaranteed Interest Account (the “Account”) with Empower. Under the group annuity account that supports this Account, participants could ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. The Account was effected directly between the plan sponsor (or their trustee) and the issuer. The repayment of principal and interest credited to participants was a financial obligation of the issuer. Given these provisions, the Account was fully benefit-responsive.

When establishing crediting interest rates, Empower considered current economic and market conditions, the general interest rate environment and the experience within the Empower general account. The crediting interest rates were announced in advance and were guaranteed for at least one year and could not be less than the minimum rate.

#### ***Lincoln Fixed Account***

The Lincoln Fixed Account provided a guarantee of principal and interest. Assets in the Fixed Account were part of the general assets of the issuing company and were subject to the claims-paying ability of that company.

Contributions allocated to the Lincoln Fixed Account were guaranteed to be credited with a minimum interest rate, as specified in the contract. The Lincoln National Life Insurance Company (“Lincoln”) has an internal committee that reviewed and set interest rates quarterly based on a variety of proprietary factors. Lincoln’s standard crediting methodology was to apply a portfolio interest rate to the Lincoln Fixed Account. That is, a single interest rate applied to the entire balance of the participant’s Lincoln Fixed Account. The declared portfolio interest rate was published quarterly in advance of the quarter for which the rate was effective.

### **6. Tax Status**

The Employer has adopted a plan document effective January 1, 2009 which is intended to satisfy the Internal Revenue Service’s (“IRS”) final 403(b) regulations. The Plan has since been amended, however, the Employer believes that the Plan, as amended, is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **7. Party-in-Interest Transactions**

Certain Plan investments were managed by Empower, Lincoln Life and Invesco. Empower, Lincoln Life, Invesco were the custodians and trustees as defined by the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

### 7. Party-in-Interest Transactions (*continued*)

Participants could obtain loans that were issued directly from Lincoln Life to the participant. As security, a portion of the participant's account in the Plan served as collateral for the loan in case of default. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.
