Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Openview Products Employees Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1. Description of Plan

The following description of the Openview Products Employees Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Openview Products, LLC (Openview) (formerly known as Hayfield Window and Door Co, LLC). The Plan became effective January 1, 1986, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the Internal Revenue Code (IRC).

The Plan was administered by Hayfield Window and Door Company through August 5, 2019, when Openview became the plan sponsor and assumed all employees of the former plan sponsor. The trustee of the Plan's assets is the Ascensus Trust Company (the Trustee). The Trustee executes transactions based upon direction from the Plan Administrator and the Plan's participants.

All employees of Openview Products, LLC are eligible to participate in the Plan if they meet the Plan's requirements. Effective January 1, 2022, Showcase Window and Door Co., LLC, an Openview subsidiary, was added as a participating employer to the Plan.

Eligibility: Participants will be eligible to participate in the Plan when they reach 18 years of age or older and have completed 60 days of employment, as defined by the plan. Eligible employees may enter the Plan on the first day of the month following the completion of the initial requirements. Participants will be eligible to participate in the employer match under the Plan if they reach 18 years of age or older and have completed 60 days of employment, as defined by the Plan. Each plan year, the plan sponsor may make a contribution to the Plan as a discretionary matching contribution on behalf of the employee which will be determined each year. Participants will be eligible to participate in the profit-sharing contribution under the Plan if they reach 18 years of age or older and have completed 60 days of employment, as defined by the Plan. The plan sponsor may make a contribution to the Plan as a discretionary profit-sharing contribution on behalf of the employee, which will be determined each year.

Contributions: Participants may contribute up to 100% percent of their eligible compensation to the Plan on a pretax basis, subject to IRC limits, as defined by the Plan. Participants are also allowed to make Roth 401k contributions. Participants may roll over amounts representing distributions from other qualified plans into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Participants direct the investment of contributions into various investment options offered by the Plan. All participants making salary reduction contributions to the Plan share in discretionary match contributions regardless of service completed during the plan year or employment status at the end of the plan year. Each year, management of the Company determines the formula for determining matching contributions. For 2024, the match formula was based on an amount of the deferral that the participant made. Openview Products Employees Retirement Plan's discretionary match was 100% of the first 3% of eligible compensation for the year ended December 31, 2024. The Plan Sponsor can elect to make a discretionary profit sharing contribution. Eligible participants are allocated their portion of profit sharing contributions based upon their compensation using a formula that is integrated with the federal social security wage base. Each year, management of the Company determines the amount of the profit-sharing contribution, if any. There were no non-elective profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to a compensation ceiling and annual limitations prescribed by the IRC.

Note 1. Description of Plan (Continued)

Participant accounts: Each participant's account is credited with the participant's contribution, the Plan's matching contribution, profit sharing contribution, and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses and administrative costs incurred in connection with the general administration of the Plan are paid out of Plan assets.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer matching contributions and employer profit sharing contributions are subject to a graded vesting schedule during which the employee vests 25% after one year and then 25% each subsequent year of service until fully vested after four years of service.

Notes receivable from participants: Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Only two notes may be outstanding at any given time. Interest is charged on the notes based on similar market rates charged by other lenders. Notes outstanding at December 31, 2024, had interest rates ranging from 4.25% to 9.5% and have various maturities through September 2046. Minimum participant payments are required to be made at least quarterly. Notes receivable are secured by the balance in the participant's account. Principal and interest are paid via payroll deduction according to the amortization schedule prepared by the Company.

Payment of benefits: On termination of service due to death, disability, retirement or termination of employment, a participant's vested benefit is distributed as soon as administratively feasible following the date on which a distribution is requested or otherwise payable in a single lump-sum payment. The distribution will be in the form of a lump-sum payment if the participant's vested benefit is \$5,000 or less, unless the participant timely elects a direct rollover of the vested account balance. Pre-retirement distributions are allowed under the Plan after attaining the age of 59 ½. Hardship withdrawals are also available subject to certain limitations.

Forfeitures: If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future Employer contributions to the Plan or pay Plan expenses. Forfeitures of nonvested accounts totaled approximately \$18,000 and \$10,000 as of December 31, 2024 and 2023, respectively. No forfeitures were used to reduce employer contributions or pay administrative expenses during the year ended December 31, 2024.

Subsequent events: The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be recognized to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Payment of benefits: Benefits are recorded when paid.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Note 3. Information Certified and Provided by Ascensus Trust Company

Note 4. Fair Value Measurements

The framework for measuring fair value provides fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices for the asset or liability that are observable
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, Level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: A stable value fund that is comprised primarily of fully benefit-responsive investment contracts that is valued at the net asset value (NAV) of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5. Related-Party and Party-in-Interest Transactions

Fees paid by the Plan to the Trustee for investment management services amounted to \$21,391 for the year ended December 31, 2024. ERISA regulations provide an exemption for such transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Plan sponsor contributions.

Note 7. Tax Status

The Plan adopted the Ascensus, Inc. Prototype Plan. The prototype plan obtained its latest Internal Revenue Service opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan's management, Trustee, and tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
