**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of OACAC Matching Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of OACAC Matching Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

**Opinion**

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about OACAC Matching Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

# OACAC MATCHING PLAN

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

1. Description of plan

The following description of the OACAC (“Agency”) Matching Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan’s provisions.

a. General

The Plan is a defined contribution plan covering all participating employees of the Agency. Ozarks Area Community Action Corporation (OACAC) is a not-for-profit corporation established in 1965 for the purpose of alleviating the causes and conditions of poverty in a ten county area of Southwest Missouri. Administrative offices of OACAC are located in Springfield, Missouri. OACAC provides various programs operated through federal, state and other grants. All permissible employees of the Agency, as defined in the universal availability standards, are eligible. The Plan is a defined contribution plan subject to the provision of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the requirements of Section 403(b) of the Internal Revenue Code for employees of the Agency.

b. Contributions

Employees are eligible to participate in the Plan immediately upon hire and may contribute up to the limits set forth by the Internal Revenue Service. Upon completion of twenty-four months of service, the Agency contributes an amount equal to 50% of the participants’ contributions up to 5% of gross wages.

d. Participants’ accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Agency’s contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

e. Vesting

Participants are immediately vested in their contributions and the Agency match plus actual earnings thereon.

f. Notes receivable from participants

Participants may borrow from their fund account the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant’s account and bear interest at varying rates from 1.0 to 3.0 percent.

1. Description of plan (continued)

g. Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual, quarterly, or monthly installments if his vested account balance is at least \$5,000. If the vested account balance is less than \$5,000, the distribution will automatically be in the form of a lump-sum payment.

h. Parties-In-Interest

Corebridge Retirement Services is the trustee/custodian of the Plan investments and executing transactions therein. The Plan is administered by the plan sponsor (OACAC) in conjunction with Future Plan by Ascensus serving as the third-party administrator. Roberts, McKenzie, Mangan & Cummings, PC is the independent auditor. Each of these entities is classified as a party-in-interest with respect to the Plan.

i. In-Service Withdrawals

Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's elective deferrals.

Participants who have obtained the age of 59½ are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

j. Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

k. Forfeitures

Forfeitures of unvested Agency matching contributions from terminated participant accounts can be used to offset Agency matching contributions or to pay Plan administrative expenses, as determined by the Plan Administrator. At December 31, 2024, there were no forfeited unvested accounts and the Plan did not use any forfeitures to offset Agency matching contributions.

2. Summary of significant accounting policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

2. Summary of significant accounting policies (continued)

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases making loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

3. Plan termination

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

4. Administrative costs

During the year ended December 31, 2024, \$13,725 of administrative expenses were paid by the Plan. All other administrative costs are paid by the Plan sponsor.

5. Tax status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Plan operated under a standardized adoption agreement in connection with a volume submitter retirement plan and trust document sponsored by United Retirement, Inc. This volume submitter plan document has been filed with the appropriate agency

5. Tax status (continued)

and has obtained its latest advisory letter dated March 31, 2017. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Information prepared and certified by Qualified Institution

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part from information certified by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments in mutual funds, group annuity contracts, and notes receivable from participants of \$8,316,364 and \$8,059,377 at December 31, 2024 and 2023, respectively, and related income of \$835,741, for the year ended December 31, 2024.

7. Fair value measurements

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Group annuity contract

The Plan has entered into a benefit-responsive investment contract with Variable Annuity Life Insurance Co. (VALIC), a subsidiary of AIG Retirement Services. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative

expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$2,549,315 and \$2,946,155, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The minimum guaranteed interest rate varies by participant and depends on the date the participant established his/her account. Participant accounts set up before December 1, 2003 have a minimum guaranteed interest rate of 3.00%. The minimum guaranteed interest rate for accounts set up on or after December 1, 2003 is 2.00%. Effective January 1, 2011, contracts issued to new participants have an indexed guaranteed minimum interest rate.

9. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Separated participants

At December 31, 2024, \$282,574 of the net assets available for benefits are for those participants who have separated from active service with the Plan sponsor.

11. Subsequent event

The Plan has evaluated subsequent events through September 25, 2025, the date which the financial statements were available to be issued. There were no significant events noted that did not exist at the date of the statements of net assets available for benefits but arose subsequent to that date.
