## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants and Beneficiaries  
Tube Processing Corp. Employee's 401(k) Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Tube Processing Corp. Employees' 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2024 Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, Charles Schwab Trust Bank, as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

**NOTE 1 PLAN DESCRIPTION**

The following description of Tube Processing Corp. Employees' 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was organized effective January 1, 1987, as a defined contribution retirement savings plan covering all eligible employees of Tube Processing Corp., (the "Company") who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors of the Employer is responsible for oversight of the Plan. The 401(k) Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions

Participants may authorize the Employer to contribute to the Plan up to 75% of their eligible annual compensation, subject to the maximum annual amount permitted under Section 402(g) of the Internal Revenue Code (IRC). Participants who are highly-compensated employees, as defined in the Plan Agreement, may be subject to a separate limit as established by the Plan Administrator. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from amounts representing distributions from other qualified plans and certain Individual Retirement Accounts (IRA) as defined in the Plan Agreement. Contributions are subject to certain limitations under the IRC.

The Plan includes an auto-enrollment provision whereby certain eligible employees are automatically enrolled in the Plan unless an affirmative election not to participate in the Plan is executed. Automatically enrolled participants have their contribution rate set at 5% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. The Plan also provides for an automatic savings increase feature in which a participant's contribution rate will increase by 1% per year up to a maximum of 15% of eligible compensation until an election is made by the respective participant. As noted above, the participant may contribute up to 75% of eligible compensation if they so elect up to the statutory limits.

The Employer may elect to make discretionary matching contributions to the Plan. In 2024 and 2023, the Employer made matching contributions equal to 50% of the first 2% and 30% of the next 5% of compensation that each participant contributed to the Plan.

Participants direct the investment of their contributions, as well as those made by the Employer, into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's matching contributions, as well as allocations of Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses of the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their account is based on years of service. A participant becomes 20% vested after one year of service, increasing by 20% per additional year, with full vesting after five years of credited service.

At December 31, 2024 and 2023, forfeited nonvested accounts of terminated participants totaled \$12,151 and \$4,153, respectively. These accounts will be used to reduce future Employer contributions, pay Plan expenses, and/or be allocated or reinstated to the accounts of eligible participants, as defined in the Plan Agreement. In 2024 and 2023, amounts forfeited were \$11,926 and \$3,643 and forfeited nonvested accounts of \$4,153 and \$50,020 were used to pay Employer contributions, respectively.

Payment of Benefits

Upon the occurrence of a distributable event due to separation from service by termination, death, disability, or retirement, as defined by the Plan Agreement, a participant may elect to receive a lump-sum cash distribution equal to the value of the participant's vested interest in their account, substantially equal installments, or partial payments. Hardship and in-service withdrawals, as well as required minimum distributions, rollover contribution accounts, and automatic distributions to former participants, as defined in the Plan Agreement, are also permitted from a participant's account.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment terms of the notes cannot exceed 58 months except for the purchase of the participant's principal residence, for which the terms may exceed 58 months per the Plan Agreement. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through regular payroll deductions.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Concentration of Credit Risk

The Plan invests primarily in mutual funds and collective trust funds. Valuations of these investments with equity and fixed income securities are affected by market fluctuations in the underlying stocks and bonds in which the fund managers have invested.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustees. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

The Plan's notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make repayments and the Plan Administrator deems the note receivable from the participant to be in default, the balance of the note receivable from the participant is reduced and a benefit payment is recorded per the Plan Agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses for maintaining the Plan may be paid by the Employer or the Plan, at the Employer's discretion. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Reclassifications

Certain prior year balances have been reclassified to conform with current year classifications and presentations.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025 the Plan was amended to adopt the following provisions of the SECURE 2.0 Act of 2022:

- A participant may request one or more in-service domestic abuse victim distributions from the vested portion of his or her accounts and each distribution will be made in a single payment that may be less than the participant's full account balance. No withdrawal restrictions (e.g., minimum withdrawal amount or maximum number of withdrawals per year) will apply.
  
- Qualified Disaster Recovery Distributions ("QDRDs") will be permitted under the Plan up to \$22,000 from a participant's vested account balance, on or after the first day of the Incident Period of a Qualified Disaster and before the date that is 180 days after the Applicable Date with respect to such Qualified Disaster. A participant who receives a QDRD, at any time during the 3-year period beginning on the day after receipt of the distribution, may make one or more repayments to the Plan, as Rollover Contributions, in an aggregate amount not to exceed the amount of such distribution provided that the Participant is eligible to make Rollover Contributions to the Plan at the time they want to make the repayment.
  
- The maximum a participant may borrow from their account under the Plan's loan program is increased from \$50,000 to \$100,000. The percent available for a participant may borrow also increased from 50% to 100% of their vested account balance.
  
- Participants who are Qualified Individuals will be permitted to request loan repayment suspensions under the Plan if a participant with respect to the Qualified Disaster has an outstanding loan from the Plan on or after the Applicable Date and the due date for any repayment of such loan occurs during the period beginning on the first day of such Incident Period and ending on the date which is 180 days after the last day of such Incident Period, then such due date may be delayed for up to one year. The Plan will adjust any subsequent repayments to reflect the delay in the due date under this suspension period and any interest accrued during the suspension. The Plan will disregard the suspension period in determining the 5-year period and the loan under Code §72(p)(2)(B) or (C).

- Recontributions of hardship withdrawals for home purchases will be permitted under the Plan. A Participant who receives a Qualified Distribution may, during the period beginning on the first day of the Incident Period of such Qualified Disaster and ending on the date which is 180 days after the Applicable Date with respect to such disaster, make one or more contributions to the Plan, as Rollover Contributions, in an aggregate amount not to exceed the amount of such Qualified Distribution provided that the Participant is eligible to make Rollover Contributions to the Plan at the time they want to make the contribution. A Qualified Distribution means any distribution (a) which was to be used to purchase or construct a principal residence in a Qualified Disaster Area, but which was not so used on account of the Qualified Disaster with respect to such area, and (b) which was received during the period beginning on the date which is 180 days before the first day of the Incident Period of such Qualified Disaster and ending on the date which is 30 days after the last day of such Incident Period.

**NOTE 3 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

**NOTE 4 PARTIES IN INTEREST**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan has arrangements with several third-party service providers. The Plan pays certain expenses related to the Plan's operation, administration, and investment activity. The Plan's expenses may be paid directly to the respective service provider or indirectly through the Plan's investments returns. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

The Plan may receive revenue-sharing compensation from certain Plan investment options. This revenue, if any, is used to offset certain recordkeeping and administration services to the Plan and/or allocated to participant accounts as additional earnings.

The Employer provides certain accounting, administrative, and investment management services to the Plan for which it receives no compensation.

Notes receivable from participants are permitted party-in-interest transactions.

**NOTE 5 INCOME TAX STATUS**

The Plan is based on a pre-approved defined contribution plan document whose sponsor has received an opinion letter from the Internal Revenue Service (IRS) dated September 21, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with the applicable sections of the IRC. Although the pre-approved defined contribution plan document has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

**NOTE 6 INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

**NOTE 7 FAIR VALUE MEASUREMENTS**

The Plan has categorized its assets and liabilities that are measured at fair value into a three-level fair value hierarchy. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

**Level 1**            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2**            Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used by the Plan for assets that are measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (Mutual funds) and money market funds* : Valued at the net asset value ("NAV") of the shares held by the Plan at year end, and are readily determinable.

*Collective trust funds* : Valued at the unit price reported by the sponsoring trust company. The underlying investments owned by the funds can include money market funds, stable value funds, fixed-income securities, registered investment companies, common stocks, corporate bonds, U.S. Government securities, other collective trust funds, or guaranteed investment contracts priced by the sponsoring insurance company using applicable interest rates and contract provisions. The unit price is based on the fair value of these underlying investments owned, less any accrual of fees and expenses borne by the fund, and divided by the number of units outstanding.

*Collective trust funds (continued)* : The unit price is readily determinable and quoted on the active private market on which participants can transact daily with no redemption restrictions on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
