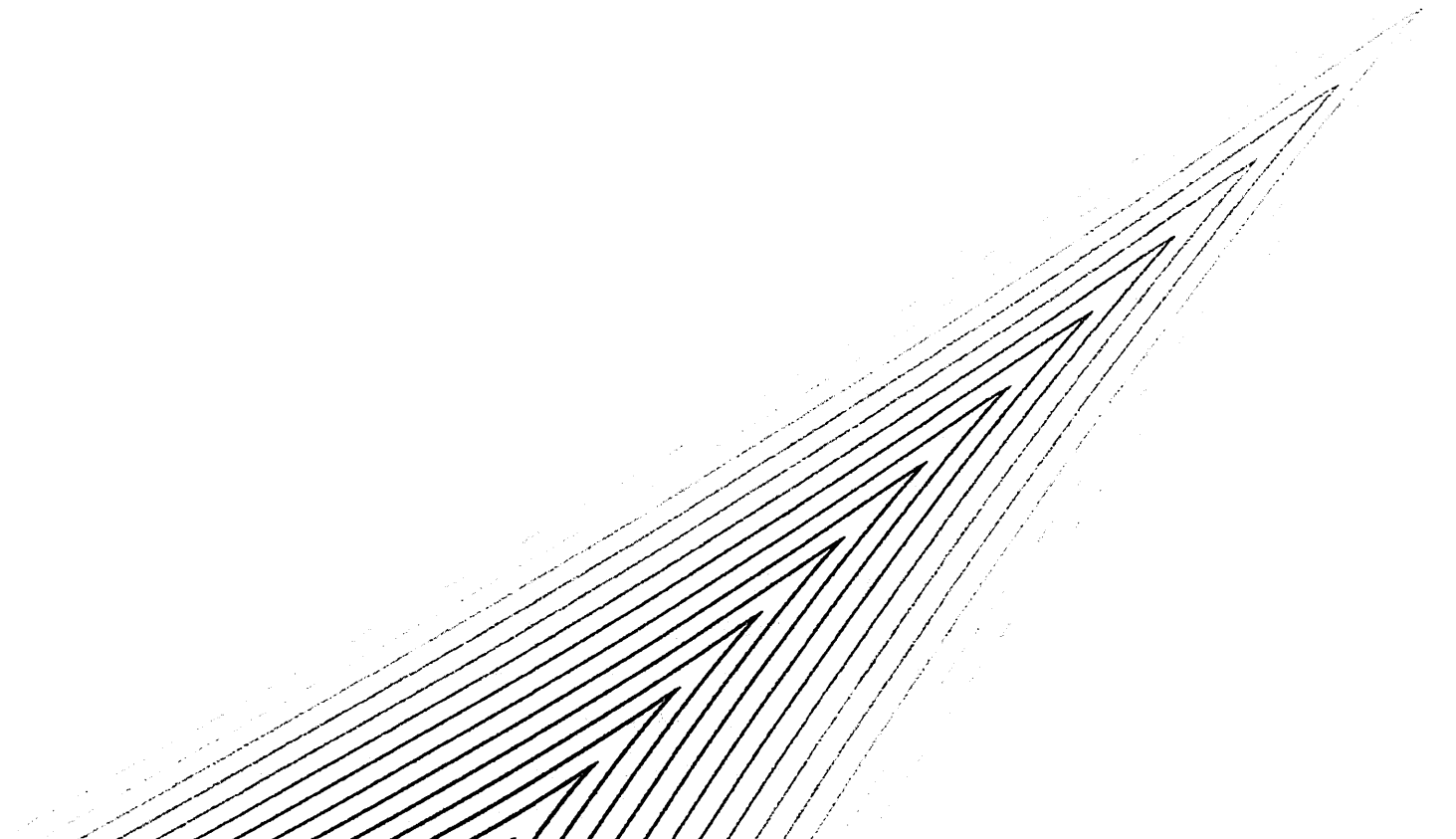

## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Bedoukian Research, Inc. 401(k) Savings and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan, which commenced on September 1, 1983, covering all eligible employees of Bedoukian Research, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Eligibility**

All employees (as defined) of the Company who have completed six months of service are eligible to participate in the Plan.

**Contributions**

Each year, eligible participants may elect to make pre-tax contributions to the Plan up to 100% of their annual compensation, as defined, not to exceed the maximum amount allowable under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various mutual funds, collective investment trusts, pooled separate accounts and one stable value fund as investment options for participants.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year up to a maximum of 10% of eligible compensation.

Company matching contributions to the Plan are discretionary. For 2024, the Company has elected to make matching contributions. For the year ended December 31, 2024, the Company's matching contributions equal 50% of each participant's elective deferral, up to 3% of the participant's eligible compensation, and totaled \$366,410. Additional profit sharing amounts may be contributed at the discretion of the Company. For the year ended December 31, 2024, the Company elected to make a profit sharing contribution to the Plan of \$579,888. The profit sharing contribution was paid in October 2025.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching and profit sharing contributions, and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account, as defined.

**Allocation of Investments**

Participants make an election designating the proportion in which contributions are to be allocated among the specific assets, funds or other investments permitted under the Plan (participant-directed investment program). Participants may change their allocations and make transfers among funds.

**Notes Receivable from Participants**

Eligible participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with market prevailing rates as determined by the Plan administrator, and must be repaid within five years. Principal and interest are paid ratably through payroll deductions and are monitored by the Plan administrator. The Plan will not approve more than two loans for a participant in any twelve month period. A loan that is considered in default is reported as a deemed distribution, which may be a taxable event for the participant.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

**Vesting**

The Plan provides that participants shall always be fully vested in funds that they contribute to the Plan. Employer contributions are subject to the following vesting schedule:

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant, or their beneficiary, or for termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship and in-service withdrawals are available pursuant to specific guidelines as set forth in the Plan.

**Rollovers**

Participants may roll over amounts representing distributions from other qualified plans into the Plan. Participant rollover contributions made to the Plan amounted to \$88,913 during the year ended December 31, 2024.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$42 and \$2, respectively. These accounts are used to reduce future employer contributions. Also, for the year ended December 31, 2024, employer contributions were reduced by \$53,234 from forfeited nonvested accounts.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There were no deemed distributions for the year ended December 31, 2024.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan, if not paid by the Plan, are paid directly by the Company and excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN AS COMPLETE AND ACCURATE**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution and Principal Life Insurance Company (U.S.A.), a qualified institution.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The Plan had no investments measured at Level 2 or 3 as of December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled Separate Accounts**

Pooled separate accounts (PSAs) are valued at the NAV of units held by the pooled separate accounts. Participant transactions (purchase and sales) may occur daily. There are no unfunded commitments. All the pooled separate accounts are direct filing entities.

**Collective Investment Trusts**

Collective Investment Trusts (CITs) are valued at the NAV of the CIT, which is not publicly quoted, but is available to current investors when Plan participants access their account values. Participant transactions (purchase and sales) may occur daily. There are no unfunded commitments. All the CITs are direct filing entities.

**Stable Value Fund**

A stable value fund is valued at the NAV of units of the bank collective trust. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used. Participant transactions (purchase and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly manner. There are no unfunded commitments. The stable value fund is a direct filing entity.

**Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers.

**NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan holds investments which are issued and managed by Principal Life Insurance Company (U.S.A.) or an affiliate thereof. Principal Trust Company, an affiliate, is the custodian as defined by the Plan. Fees paid by the Plan to Principal Trust Company for administrative expenses were \$115,899 for the year ended December 31, 2024. This transaction qualifies as a party-in-interest transaction and is exempt under the prohibited transaction rules.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 7 – TAX STATUS**

The Plan is a prototype non-standardized volume submitter profit sharing plan approved June 30, 2020, which the Internal Revenue Service (“IRS”) ruled in an opinion letter, as then designed, qualifies under Section 401 of the IRC. The Plan administrator (and the Plan’s tax counsel) believe that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC, except for certain operational errors as discussed in Note 12. The Plan sponsor believes the Plan has maintained its tax-exempt status. In addition, effective February 17, 2022, the Plan was restated in accordance with the requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS, or applicable state authority.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

In accordance with the DOL’s Regulation 2510.3-102, an employer is required to segregate participants’ contributions from its general assets as soon as practical, but in no event more than the 15<sup>th</sup> business day following the end of the month in which amounts are contributed by participants or withheld from their wages for a benefit plan such as the Plan. While the Company remitted all employee contributions to the Plan, contributions of \$860,958 were not remitted within the required time period for the year ended December 31, 2023. The Company has fully corrected these delinquent contributions during 2024, including any lost earnings as a result. During the year ended December 31, 2024, there were no instances of late remittances.

**NOTE 9 – CONCENTRATIONS**

The Plan has one investment that makes up 16.7% of total net assets available for benefits at December 31, 2024.

**NOTE 10 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 12 – OPERATIONAL FAILURES**

During 2022, the Company discovered an operational failure related to the application of eligible compensation. Since the inception of the Plan, the Company's operational intent was not to include bonus pay as eligible compensation for the purpose of calculating employee deferrals. However, according to the Plan document, such compensation is eligible compensation for employee deferrals, which creates a potential Plan operational failure. A Voluntary Correction Program (VCP) application was submitted to the IRS under the Employee Plans Compliance Resolution System ("EPCRS") in February 2023, outlining the foregoing operational issue and the Plan's proposed resolution and corrective action. As of the date the financial statements were issued, the VCP submission is still pending with the IRS; therefore, the Plan cannot currently determine the outcome or the impact on the Plan's financial statements. Effective October 2022, the Plan was amended to exclude bonus compensation from eligible compensation.

In July 2025, an additional VCP application was submitted to the IRS under EPCRS proposing a resolution to the foregoing operational issue through a qualified non-elective contribution ("QNEC"). The VCP application outlined the Plan's calculation of an estimate for total corrective QNECs of \$400,000. In September 2025, this VCP submission was accepted by the IRS, thus the QNEC estimate of \$400,000 is included in the financial statements as Corrective employer contributions receivable and Corrective employer contributions.

No provision for income taxes has been included in the Plan's financial statements related to the foregoing matters because the Plan sponsor believes that the Plan continues to be qualified, and the tax status of the related trust continues to be tax exempt.
