Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of S. Martinelli & Company Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. DESCRIPTION OF THE PLAN

The following description of the S. Martinelli & Company Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility — The Plan is a defined contribution retirement plan sponsored by S. Martinelli & Company (the Company or Plan Sponsor), who have attained 18 years of age and have 30 days of service, excluding nonresident aliens or employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). The entry date of participation for employee contributions is the first day of the month upon satisfaction of eligibility conditions. To be eligible for the employer match or profit sharing contribution, participants must have 1,000 hours of credited service during the plan year.

Change in Trustees, record keeper, and custodian — Effective December 9, 2024, the Plan changed its recordkeeper from Milliman Inc. (Milliman) to J.P. Morgan Retirement Plan Services (JP Morgan) and custodian from Charles Schwab Trust Bank (Charles Schwab) to Empower Trust Company, LLC (Empower). The named trustee effective December 9, 2024 is Empower.

Contributions and investment options — Each year, participants may contribute up to 100% of their eligible compensation, subject to maximum limits defined by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan, which also includes personal choice retirement accounts (PCRA) offered by the Plan's trustee.

The Plan allows for discretionary employer matching or profit sharing contributions. There were no employer matching contributions for the year ended December 31, 2024. For the year ended December 31, 2024, the Company made profit sharing contributions to the Plan totaling \$773,452. Contributions are subject to certain limitations.

The Plan has an automatic enrollment feature for those not previously participating in the Plan. Once eligible, employees are automatically enrolled in the Plan at a deferral rate of 2% unless otherwise elected, and their contributions are invested in a designated balanced fund until changed by the participant. Initially enrolled participants are also subject to the annual automatic deferral increase feature, which automatically increases a participant's deferral each year by 1% until the deferral reaches 10%, occurring January 1 of each year. Participants have 90 days following the date first eligible to elect nonparticipation in the Plan and receive a refund of previous withholdings.

Participant accounts — Each participant's account is credited with the participant's contributions and allocations of: (a) Plan's earnings or losses on investments, and (b) administrative expenses. Allocations are based on a participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting — Participants are immediately 100% vested in their own contributions plus actual earnings thereon. Employer discretionary contributions vest annually for each year of credited service, which is defined as 1,000 hours. Prior to December 9, 2024, participants vested in the employer contributions on a graded basis and were fully vested after six years of credited service. Effective December 9, 2024, participants vest in employer contributions on a graded basis and are fully vested after five years of credited service.

Notes receivable from participants — Participants may borrow from their accounts a minimum of \$1,000, up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1%. Principal and interest are repaid ratably through payroll deductions within five years, or up to 15 years if used to acquire a principal residence of the participant. In the event the scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due, the loan is considered to be in default and considered a deemed distribution. Notes receivable outstanding at December 31, 2024, mature at various dates through 2029, with interest rates ranging from 4.25% to 9.50%.

Payment of benefits — Upon termination of service due to death, disability, retirement or termination of employment, a participant or beneficiary, as applicable, shall receive a lump-sum distribution in an amount equal to the value of the participant's interest in his or her account. If a participant's vested account balance is equal to or less than \$5,000 and no election is made, the vested account balance will be distributed directly to the participant. Effective December 9, 2024, this limit was increased to \$7,000. If the distribution amount exceeds \$1,000, the distribution will be directly rolled over to an Individual Retirement Account (IRA), amounts less than \$1,000 will be a cash distribution. The Plan also allows in-service withdrawals and hardship withdrawals under certain circumstances.

Forfeited accounts — The Plan provides for forfeitures of terminating participants' nonvested accounts to pay for administrative expenses or reduce future employer contributions under the Plan's provisions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$86,062 and \$2,481, respectively. During 2024, forfeitures of \$2,481 were used to reduce employer profit sharing contributions.

Note 2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting — The financial statements of the Plan are prepared on the accrual basis of accounting under accounting principles generally accepted in the United States of America (U.S. GAAP).

Contributions — Contributions to Plan participants and the employer matching contribution (if any) are recorded in the year in which the employee contributions are withheld from compensation. Contributions related to the employer profit sharing contribution are recorded in the year in which the participant compensation is earned.

Use of estimates — The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits — Benefits are recorded when paid.

Administrative expenses — The Plan incurs record-keeping and administrative expenses. Specific participant transaction expenses are deducted from participant accounts directly. Plan expenses that cannot be directly charged to a specific participant transaction may be paid, in whole or in part, from forfeitures or paid by the Company. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events — The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

Note 3. INFORMATION CERTIFIED AND PROVIDED BY CHARLES SCHWAB AND EMPOWER, THE CUSTODIANS

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution. The Plan Administrator has obtained certification from Charles Schwab, the former custodian, as of December 31, 2023 and for the period from January 1, 2024 to December 8, 2024. The Plan Administrator has obtained certification from Empower, the current custodian, as of December 31, 2024 and for the period from December 9, 2024 to December 31, 2024. The information provided to the Plan Administrator by the custodians related to the following assets:

Note 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets

Quoted prices for identical or similar assets or liabilities in inactive markets

Inputs other than quoted prices that are observable for the asset or liability

Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered investment companies (mutual funds) — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Money market fund — Valued at the daily closing price as reported by the fund. Money market funds hold primarily cash and these funds are required to publish their NAV and to transact at that price. The money market fund held by the Plan is deemed to be actively traded (Level 1).

Personal choice retirement account — Participants are able to open a personal choice retirement account (PCRA) within the trustee's investment platform, which allows for additional investment options. The PCRA accounts contain registered investment companies and money market funds, as described above, and common stocks, which are valued at the daily closing price as reported by the exchange. The PCRA investments held by the Plan are all deemed to be actively traded (Level 1).

Collective common trust — A stable value fund that is comprised primarily of fixed income instruments and stable value products that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The investment in the J.P. Morgan Chase Bank Stable Asset Income Fund, a collective common trust, seeks to provide capital preservation, liquidity, and current income at levels that are typically higher than those provided by money market funds. The Fund invests primarily in fixed income instruments with companion book value contracts issued by insurance companies, banks, and other financial institutions, as well as other types of stable value products which may be available such as other stable value collective trusts, guaranteed investment contracts, bank investment contracts, group annuity contracts, separate account insurance contracts. A book value contract is an agreement from a major financial institution to provide liquidity for participant transactions on a stable book value basis. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan assets are maintained by Empower and were maintained by Charles Schwab, respectively, with recordkeeping services provided by Milliman and JP Morgan, respectively, for the periods discussed in Note 1. These transactions qualify as party-in-interest transactions. Certain administrative functions are performed by employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses for participants are paid directly by the Plan Sponsor.

Note 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in any portion of their accounts not already 100% vested.

Note 7. TAX STATUS

Effective December 9, 2024, the Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022. Prior to December 9, 2024, the Plan had adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020. Both opinion letters state that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
