Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Securecloud Technologies, Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Securecloud Technologies, Inc. 401(k) Plan (formerly the 8K Miles Software Services 401(k) Plan) (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan is a defined contribution and profit-sharing plan originally adopted on August 1, 2018, and most recently amended effective May 15, 2021, to conform to recent tax laws. The Plan covers substantially all employees of Securecloud Technologies, Inc. (formerly 8K Miles Software Services, Inc.) (the “Company”) who have completed at least six months of eligibility service and are age 21 or older. Employees begin participation in the Plan as of the first day of each calendar quarter coinciding with or following the date that they meet eligibility requirements.

The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – Under the terms of the Plan, Ascensus Trust Company acts as custodian and Plan trustee. The Company is the Plan Sponsor and acts as the Plan Administrator. The Company has contracted with Ascensus, Inc. to act as the Plan’s third-party administrator. The Company pays most of the expenses incurred to administer the Plan, except for certain contract administration and investment advisory and management fees, which are paid by the Plan.

Basis of accounting – The accounting records of the Plan are maintained on the accrual basis in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reported period. Actual results could differ from these estimates.

Employee contributions – Participants may elect to have the Company contribute a percentage of their pre-tax compensation to the Plan, up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants may also elect to have the Company contribute a portion of their compensation after-tax in the form of a Roth deferral.

Employer contributions – The Plan permits discretionary employer matching and profit-sharing contributions. For the year ended December 31, 2024, the Company did not make any discretionary employer matching or profit sharing contributions. For the year ended December 31, 2023, the Company made corrective qualified nonelective contributions totaling \$1,682, which are reported as employer contributions on the accompanying statement of changes in net assets available for benefits.

Participant accounts – A separate account is maintained for each participant and is credited with the participant’s employee contributions, employer contributions and an allocation of Plan earnings, less withdrawals, distributions, and administrative expenses, if any. Participants direct the investment of their contributions into the various investment options offered by the Plan. The benefit to which a participant is entitled is limited to the benefit that may be provided from the participant’s vested account balance.

Vesting – Participant account balances generated from any employer matching and profit-sharing contributions will be 100% vested at all times.

Forfeitures – Non-vested portions of participant accounts, if any, are forfeited upon termination of employment and may be used to pay expenses of the Plan or to reduce employer contributions at the discretion of the Company. Unallocated forfeitures at December 31, 2024 and 2023 totaled \$521 and \$498, respectively. Forfeitures totaling \$4 were used to reduce employer contributions for the year ended December 31, 2024.

Investments – Investments of the Plan are held by the Plan’s trustee and are invested based solely upon instructions from participants. Mutual fund investments, including money market mutual funds, are valued at fair market value based on market prices as quoted by the Plan’s trustee.

The Plan follows the guidance of GAAP for measuring fair value of investments. Those principles establish a framework for the measurement of fair value and provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment income – Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost if acquired during the Plan year. In accordance with the Plan's policy of stating investments at fair value, net unrealized appreciation or depreciation is included in the statement of changes in net assets in the period in which the market change occurs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Notes receivable from participants – The Plan provides a provision that allows a participant to borrow up to the lesser of \$50,000 or 50% of their vested account balance, with a minimum borrowing of \$1,000. Such loans shall bear interest at prime rate plus 1% per annum. The term of the loans generally cannot exceed five years, except for the purchase of a principal residence, which may be repaid over a period of up to 15 years, and a participant may not have more than one loan outstanding at any time. The loans are secured by the participant's vested balance. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest.

Payment of benefits – Benefits, including rollover transfers to other plans, are recorded when paid. Upon termination of service, a participant is entitled to receive an amount equal to the value of the vested interest in their account. Participant account balances may also be distributed prior to termination or retirement age under certain circumstances, including death or disability. Upon termination of service for account balances less than \$5,000, a lump-sum distribution may be made at the Company's discretion. For account balances greater than \$5,000, written consent by the participant is required before a distribution may be made. The normal retirement age under the Plan is 65. Participants who have reached age 59 ½ may take an in-service distribution subject to Plan provisions. Hardship withdrawals are not allowed.

Plan termination - The Company intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to terminate the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Subsequent events - The Plan's management evaluates events or transactions occurring after the statement of net assets available for plan benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. Events or transactions occurring subsequent to year end through the date the financial statements were available to be issued, October 3, 2025, have been evaluated in the preparation of the accompanying financial statements.

2. INCOME TAX STATUS

The Company adopted a Prototype Non-standardized Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on January 1, 2018, which stated that the Plan and related trust are designed in accordance with Section 401(a) of the Internal Revenue Code and, therefore, the underlying trust is not subject to tax under IRC 501 (a). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

3. CERTIFIED INFORMATION

4. PARTY-IN-INTEREST TRANSACTIONS

As required by ERISA Section 2510.3-102, during 2024, the Plan Sponsor did not remit participant salary deferral contributions totaling \$27,711 to the Plan in a timely manner. Management corrected this situation in 2025 by contributing lost earnings to the accounts of the affected participants.

For the year ended December 31, 2024, fees paid by the Plan to the trustee, its affiliates and the Plan's investment manager, for investment management and recordkeeping services were included in Administrative Fees and totaled \$28,117. These transactions qualified as party-in-interest transactions.

5. RISK AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist principally of mutual funds and a money market fund. As the portfolio is well diversified and issuers of the funds' underlying securities are dispersed throughout many industries and geographies, the concentrations of credit risk are limited.
