Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Quaker Equities, Ltd. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

NOTE 1 - Description of the Plan

The following description of the Quaker Equities, Ltd. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-union full-time employees of Quaker Equities, Ltd. (the "Company"), who have completed 60 days of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover"). The Plan currently offers various mutual funds, a pooled separate account, common collective trust fund accounts and a guaranteed insurance contract with an insurance company as investment options for participants. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 3% of the participant's compensation to the Plan. In addition, the Company can make an annual discretionary contribution to employees meeting eligibility requirements. For the year ending December 31, 2024, the Company provided an additional 2% elective contribution, for a total of 5% of the participant's compensation, payable to all eligible employees. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, participant earnings (losses) or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant is 100% vested after one year of credited service for the Company's non-elective contribution of 3%. A participant vests in the Company's elective contribution of 2% as follows: 0% vested at one year; 20% vested at two years; 40% vested at three years; 60% vested at four years; 80% vested at five years; and 100% vested at six years.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through weekly payroll deductions.

Benefits Paid to Participants

On termination of service due to death, disability, retirement, or any other causes, a participant may elect to receive a lump-sum amount, installment payments subject to required minimum distributions or ad-hoc distributions, equal to the value of the participant's vested interest in his or her account. In addition, a participant may receive a payment of benefits, if they are still employed and eligible through an in-service withdrawal.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$21,900 and \$-, respectively. These accounts will be used to reduce future employer contributions. In 2024, approximately \$17,000 was used to reduce employer contributions from forfeited nonvested accounts.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") under the accrual basis of accounting and is in compliance with the Accounting Standards Codification ("ASC") of the Financial Accounting Standards Board ("FASB").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Fair Value of Investments

Net change in unrealized appreciation (depreciation) and net realized gains (losses) on investments are recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

In May 2025, the Plan notified Principal of its intention to transfer all Plan assets to Bank of America, N.A., which will serve as the sole trustee of the Plan, with an anticipated effective date in December 2025.

NOTE 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820, *Fair Value Measurement*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (the "SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: According to the Plan trustee, this account is maintained by an insurance company that are used for the collective investment of Plan funds from multiple employee benefit plans. The value of an interest in a pooled separate account is the market value of the underlying assets of the separate account plus income accrued but not yet received less operating expenses accrued but not deducted, if any. The assets allocated to the separate account can include, but is not limited to, stocks, bonds, mortgages, real estate, mutual funds, other separate accounts, and cash or cash equivalents.

Common collective trust funds: Valued at the NAV per unit as determined by the collective trust as of the valuation date. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily and have no restrictions.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – Guaranteed Investment Contract with Principal Life Insurance Company

The Plan invests in fully benefit-responsive guaranteed investment contract (“GIC”) with Principal Life Insurance Company, a guaranteed general account backed group annuity contract that has been issued to Principal Trust Company as custodian. The Principal Fixed Income Guaranteed Option (“PFIGO”) guaranteed general account is presented in the financial statements within net assets available for benefits at its contract value. Contract value represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan, which approximates fair value.

The issuer of the GIC maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC does not have specific underlying assets assigned. No redemption fees, early withdrawal charges or market value adjustments are charged on participant transfers into or out of the contract. There are no events in which the issuer can terminate the GIC with the Plan and settle at an amount different from contract value. Termination of the Plan’s interest in the PFIGO is subject to either a 12-month advance notice or a 5% surrender charge calculated using the 12-month average value of the Plan’s interest in the contract. There are no restrictions on investment transfers initiated by a participant to non-competing investment options.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include changes to the Plan's policy on transfers to competing investment options or the related equity wash provision and termination of the Plan's interest in the GIC by the Plan Administrator. The Plan Administrator does not believe that the occurrence of either such event is probable.

The net crediting rate is reset semiannually on the first day of June and December. At December 31, 2024, the net crediting rate was 4.65%.

NOTE 6 - Information Certified by the Plan's Trustee (Unaudited)

In accordance with the provisions of 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the trustee has provided and certified that the following information included in the financial statements and supplemental schedule is complete and accurate at December 31, 2024 and 2023 and for the year ended December 31, 2024:

- Statement of Net Assets Available for Benefits - all investments and notes receivable from participants.
- Statement of Changes in Net Assets Available for Benefits - net appreciation in fair value of investments, interest, dividends and other investment income.
- Supplemental Schedule - all investments and notes receivable from participants.

NOTE 7 - Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments in a pooled separate account and the guaranteed investment contract are managed by Principal. Principal is the trustee and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 8 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contributions allocated to their account.

NOTE 9 - Tax Status

The Plan obtained its opinion letter on a prototype plan approved by the Internal Revenue Service (the "IRS"), effective June 30, 2020. The IRS stated that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the IRS opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan,

and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
