### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Shannon Medical Center 401(k) Savings and Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

***General***

The following description of Shannon Medical Center 401(k) Savings and Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a profit-sharing and savings plan sponsored by Shannon Medical Center (Company or Employer) to encourage and assist eligible employees of the Company in adopting a regular program of savings to provide additional security for their retirement. The Plan originated as the Shannon Clinic Pretax Savings and Employee Profit Sharing Plan. The Plan was amended, as of January 1, 1998, to adopt Shannon Health System as the primary sponsor, to make the Plan available for the Company's eligible employees, and to rename the Plan. The Plan was amended, again, as of November 1, 2012, to adopt Shannon Medical Center as the primary sponsor and to rename the Plan. The effective date of the Plan was September 1, 1975. The Plan was amended and restated effective January 1, 2016 and amended effective April 1, 2021 to allow participants to make after-tax voluntary 401(k) contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

***Administration***

The Retirement/Investment Committee (Committee), which is appointed by the Company, is responsible for the operation and administration of the Plan. At any time, the Committee consists of one or more members. The Company has the discretion to appoint or remove any member of the Committee at any time. The Committee has the full power to administer the Plan and apply all of its provisions on behalf of the Company. The Committee may also prescribe such reasonable rules and procedures as necessary to administer the Plan. Charles Schwab Trust Company (Schwab) is the custodian of the Plan, and Milliman Inc. (Milliman) performs recordkeeping services.

***Contributions***

Effective March 1, 2000, employees of the Company became eligible to join the Plan on the first day of the month after completing three months of service.

The Plan allows participants to contribute up to 50% of their defined annual compensation, up to a maximum of \$23,000 and \$22,500 in 2024 and 2023, respectively. Catch-up contributions of \$7,500 in 2024 and 2023 are allowed for participants aged 50 or older. Those contributions are made on a before-tax basis under the Section 401(k) provisions of the Internal Revenue Code.

The Company makes matching contributions to the Plan from the first day of the month following completion of 15 months of service. The Company matches every dollar contributed up to 3% of participants defined compensation and for every dollar the participant contributes thereafter up to an additional 2% of participants defined compensation, the Company contributes \$0.50. The maximum match is 4% of participants defined compensation.

The net investment gain or loss, after adjustment for applicable expenses, if any, of each investment fund is allocated to each participant's account based on the ratio of the participant's account balance to the total of all participants' account balances.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The plan document also includes an automatic deferral feature that once a participant meets the eligibility requirements, three percent (3%) of the participants pay will be automatically deducted and contributed to the Plan as a before-tax contribution, unless the participant elects a different percentage or elects not to contribute.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

The participants' employee contribution accounts, company matching accounts, and the earnings thereon are fully vested and nonforfeitable at all times.

The Company's discretionary contributions prior to January 1, 2014 become 20% vested after two years of service. The percentage vested increases in 20% increments for each year of service until reaching 100% after six years of service. A participant also becomes fully vested in their Company retirement contribution account upon: (a) retirement at or after age 65, (b) total and permanent disability, (c) death, or (d) termination of the Plan.

Terminated participants who incurred five consecutive one-year breaks in service forfeit any non-vested portions of the company contributions. These forfeited amounts can be used to reduce future company contributions.

***Notes Receivable From Participants***

The Plan allows loans to participants. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of 50% of the participants vested account balance (including Roth 401(k), if any) and \$50,000. The interest rate on loans is required to be a reasonable rate as determined by the plan administrator. The interest rates for outstanding loans at December 31, 2024 ranged from 6.0% to 10.5%. Loans are repaid through mandatory payroll deductions while a participant is an employee.

Terminated employees of Shannon Medical Center and Affiliates may repay outstanding loans by the end of the calendar quarter following the calendar quarter for which repayment is due with a single lump-sum payment via a cashier's check or money order. Loans not repaid within this period are considered to be a taxable distribution to the terminated employee.

***Payment of Benefits***

On termination of service due to death, total and permanent disability, or retirement, a participant may elect to receive either a lump-sum amount, a commercial annuity in the form of a single life annuity, or periodic installments over a certain period not to exceed the beneficiary's life expectancy, equal to the value of the participant's vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,364 and \$11,780, respectively. Also, in 2024 and 2023, employer contributions were reduced by \$54,676 and \$51,913, respectively, from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Preferred stocks are valued at the closing price reported on the active market on which the individual securities are traded. Unit investment trusts are valued at the net asset value (NAV) of the of the underlying investments held at year end. Mutual funds are valued at the NAV of shares held by the Plan at year-end.

***Notes Receivable From Participants***

Notes receivable from participants are reported at unpaid principal balance plus accrued but unpaid interest. The accrual of interest on loans is discontinued at the time the loan is 90 days past due unless the credit is well-secured and in process of collection. Past-due status is based on contractual terms of the loan. In all cases, loans are placed on nonaccrual or charged off at an earlier date if collection of principal or interest is considered doubtful.

All interest accrued but not collected for loans placed on nonaccrual or charged off is reversed against interest income. The interest on these loans is accounted for on the cash-basis or cost-recovery method until qualifying for return to accrual. Loans are returned to accrual status when all the principal and interest amounts contractually due are brought current and future payments are reasonably assured.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

At the discretion of the Company, the Plan's administrative expenses are paid by the Company or from plan assets. During fiscal years 2024 and 2023, no administrative expenses were paid by the Company. The Plan will not be required to reimburse the Company for the administrative expenses paid on its behalf.

***Revisions***

Certain immaterial revisions have been made to the 2023 financial statements for classification of cash and cash equivalents into investments and the associated presentation of the fair value hierarchy table in Note 5 of approximately \$24,600,000. In addition, there were some revisions to the 2023 fair value hierarchy table in Note 5 associated with the presentation of self-directed accounts.

**Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab,

a qualified institution and the trustee of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Schwab. Schwab is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue-sharing rather than a direct payment. The Company directly pays any other fees related to the Plan's operations.

During fiscal year 2024 and 2023, the Plan paid \$619,802 and \$572,055, respectively, in administrative expenses, which are included in the accompanying statements of changes in net assets available for plan benefits as administrative expenses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. The Company provides certain administrative services at no cost to the Plan.

#### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no investments classified as Level 3.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 7. Tax Status**

Effective January 1, 2016, the Plan was amended and restated and was submitted to the IRS for an updated ruling. The Plan obtained its latest determination letter on January 25, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code through its amendment dated December 1, 2015.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2017.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.
