Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Stokes Lawrence, P.S. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of the Stokes Lawrence, P.S. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective January 1, 1990, and most recently restated effective January 1, 2022. Stokes Lawrence, P.S. (the Company) is the sponsor of the Plan. The Plan covers all employees of the Company, except for union employees, nonresident aliens, Puerto Rican employees, and part-time, temporary, and seasonal employees whose regularly scheduled hours are less than 1,000 hours per Plan year. The Plan is subject to the applicable provisions of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian and Administrator of the Plan

The custodian of the Plan is Charles Schwab Trust Bank (the custodian). The recordkeeper of the Plan is NWPS (the recordkeeper). The administrator of the Plan is the Company. The Custodian holds all assets of the Plan in accordance with the service provider contract with the Company.

Eligibility

Employees of the Company are eligible to make employee contributions to the Plan upon reaching age 21. Participants who meet the above criteria and complete one year of service are eligible for the employer matching contribution. Additionally, upon reaching age 21 and after completing one year of service, an employee must work 1,000 hours during the Plan year and be employed on the last day of the Plan year in order to receive the employer nonelective contribution, unless termination due to retirement, death, or disability.

Contributions

Participant Contributions – Eligible participants may elect to contribute up to 90% of their annual compensation, as defined in the Plan document. Contributions can be made on both a pre-tax and/or Roth basis through payroll deductions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. When eligible to participate in the Plan, if an employee does not make an election otherwise, he or she will be automatically enrolled in the Plan at an initial pre-tax salary deferral amount of 3%.

Employer Contributions – The Company may make discretionary matching and nonelective contributions to the Plan each year. During 2024 and 2023, the Company matched up to 50% of the first 6% of eligible compensation, as defined, that the participants contributed to the Plan. The Company nonelective contribution for the year ended December 31, 2024 and 2023 totaled \$1,300,161 and \$1,182,445, respectively, and was allocated to eligible participants based on their job classification. The Plan Sponsor may also make an additional contribution to meet IRS non-discrimination requirements.

For the years ended December 31, 2024, and 2023, the Plan Sponsor made a top heavy contribution of \$7,163 and \$23,841, respectively.

Contributions are subject to certain other limitations in accordance with the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, as applicable. Allocations are based on participant earnings, participant contributions, or account balances, as defined. The benefit to which a participant is entitled is the vested portion of their accounts.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan up to maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the participants' accounts and bear interest at a rate of prime plus 1% (3.25% – 9.50% for notes outstanding at December 31, 2024. Loans must be repaid in five years (a longer term is allowed if used to acquire a principal residence), and payments are required to be made through payroll deductions. Due dates range from February 2025 to November 2029. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Vesting

Participants are immediately 100% vested in their contributions to the Plan and related earnings at all times. Contributions from the Company and related earnings become vested to the participant based on the following number of years of service: 0 to 3 years – 0%; after 3 years – 100%.

Additionally, Participants become fully vested in the event of retirement, death, total disability, and Plan termination.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeitures

The portion of a terminated participant account that is not vested (forfeitures) can be used to pay expenses of the Plan or to reduce employer contributions. Forfeitures of \$24,003 were used to reduce employer contributions in 2024.

At December 31, 2024 and 2023, there were \$34,287 and \$24,003 respectively, of forfeitures included with net assets available for benefits to be used to pay expenses of the Plan and reduce future employer contributions.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits paid to participants are recorded when requested and approved. Benefit payments requested, approved and not yet processed at year-end are recorded as benefit payments payable in the statements of net assets available for benefits.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company, except for certain expenses that are charged to participant accounts. Certain investment expenses which are charged within investments are presented net of the appreciation in fair value of investments. All other expenses of the Plan for the year ended December 31, 2024 were paid by the Company and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through the date these financial statements were available to be issued, which was October 2, 2025.

Note 3 – Information Prepared and Certified by Third-Party Service Providers

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4 – Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted market prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust (CIT): Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CIT, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-Directed Brokerage Accounts: These accounts are comprised primarily of common stocks, mutual funds, and cash and cash equivalents. Common stock is valued at the published market price on an active market. The mutual funds are valued at the NAV that is quoted on an active market and is determined based on the fair value of the underlying assets at the end of each day.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Party-in-Interest Transactions

Participant loan and distribution processing fees are paid to the recordkeeper by participants. The Plan paid for third party administrator fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA and its related regulations. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 7 – Income Tax Status

The Plan uses a volume submitter plan from its recordkeeper which received an opinion letter from the IRS on June 30, 2020 which states that the volume submitter plan, as then designed, satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the opinion letter, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
