Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Northwest Crane Service 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 and the schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not part of information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with general accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A--DESCRIPTION OF THE PLAN

The following description of Northwest Crane Service 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan with a cash or deferred arrangement covering all employees of Northwest Crane Service, LLC, Northwest Concrete Products, Inc, and Hodges Land & Cattle, LLC (collectively the "Company") who have completed three months of service as defined in the Plan agreement. The Plan was enacted as of September 1, 2017 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees will automatically be enrolled in the plan on the first day of the following month coinciding with the date on which the employee satisfies the applicable eligibility requirements.

Contributions: Participants may elect to contribute a percentage of their eligible compensation up to the lesser of the participant's eligible compensation or the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$23,000 for 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 during 2024. The Plan also permits participants to make rollover contributions from other qualified plans. The participants eligible to make the catch-up contributions may do so only after making the total elective deferral contributions allowed by the IRS.

The Company matches contributions on pre-tax elective deferrals equal to 100% of a participant's salary reduction up to 3% of the participant's compensation plus 50% of salary deferrals on the next 3%. The maximum matching contribution is 4.5%. The Company may also make discretionary matching contributions up to 6% of the participant's compensation. There were no discretionary matching contributions in 2024.

Participant Accounts and Investment Options: Each participant's account is credited with the participant's contribution, the Company's contribution, and the income and appreciation or depreciation of the investments attributable to each type of investment. Allocations are based on a participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and the Company's discretionary matching contributions. Profit sharing contributions are fully vested upon reaching two years of service.

NOTE A--DESCRIPTION OF THE PLAN--Continued

Forfeitures: Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees and are used to offset administrative costs and future contributions of the Company.

Payment of Benefits: Upon termination of employment for reasons other than death, disability, or retirement, the participant is entitled to receive a lump sum payment equal to his or her vested interest.

Upon retirement at age 65, retirement due to disability or the death of the participant, the participant or participant's designated beneficiary is entitled to receive the participant's entire account balance.

If the participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it can be made. Participants that have a vested benefit that does not exceed \$5,000 will receive a lump sum payment as soon as practicable following the event entitling the participant to a distribution. Certain early distributions made upon termination of employment may be subject to a penalty. At December 31, 2024, net assets available for benefits included approximately \$1,060,000 relating to former participants who have elected, for the present time, to leave their balances intact with the Plan.

Hardship withdrawals are permitted up to the amount of the participant's account balance attributable to their contributions made to the Plan. Hardship withdrawals are only permitted for certain specific uses as defined in the Plan agreement.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Essentially all of the administrative expenses of the Plan are paid by the Plan Sponsor.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

Income Tax Status: The Internal Revenue Service has determined and informed the Company in a letter dated April 2, 2012, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events: Subsequent events have been evaluated through August 26, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure.

NOTE C--INVESTMENT CONCENTRATIONS, RISKS AND UNCERTAINTIES

As of December 31, 2024, approximately 18% of Plan assets consists of one mutual fund investment.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE D--FAIR VALUE MEASUREMENTS

FASB ASC 820-10-35-39 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value collective trust fund: A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of a collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E--INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, INTRUST Bank, N.A. ("Intrust"), the Plan's custodian, has certified that the following data included in the accompanying financial statements and supplementary schedule of assets (held at end of year) is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i--schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform audit procedures with respect to this information, except for comparing such information per Intrust's certified statements to the related information included in the financial statements and supplementary schedule.

NOTE F--STABLE VALUE FUND

The Plan invests in one common collective trust fund (the T. Rowe Price Trust Company Stable Value Fund B) whose underlying assets are fully benefit-responsive investment contracts. The stable value fund seeks to provide preservation of principal and provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The stable value fund offer five classes of units (Tier 1 through Tier 5) with identical investment objectives for each class of unit. Each class of unit declares income dividends daily and thereby maintains a net asset value of \$1 per unit. The underlying investments of the stable value fund consist of conventional guarantee investment contracts ("GICs"), synthetic guarantee investment contracts ("wrap contracts") and cash equivalents. The GICs are typically issued with a fixed crediting rate and a fixed maturity date that does not change over the life of the contract. Whereas, wrap contracts typically reset on a monthly or quarterly basis as negotiated with the issuer and do not have a final stated maturity date. Gains and losses on the underlying portfolio are amortized over the duration of the investment, through adjustments to the future interest crediting rate.

A number of factors can influence future crediting rates of wrap contracts, which may include but are not limited to: portfolio cash flows, underlying portfolio performance, current market interest rates for reinvestment, duration posture, change in crediting ratings, default or bankruptcy by an asset or wrap issuer, the unexpected receipt of principal and interest payments, extraordinary withdrawals and certain wrap contract terms, including wrap fees.

NOTE G--VOLUNTARY CORRECTION PROGRAM

The Plan had untimely participant contributions during 2024 of \$29,480. Lost earnings were calculated and remitted in 2025. These remittances constitute prohibited transactions as defined by ERISA. Management does not believe the amount of any lost earnings, interest, or penalties required to be paid is significant.
