Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Emphasis of Matter – Plan Termination

As discussed in Note 1 to the financial statements, effective March 21, 2025, the Plan Sponsor approved a plan of termination, contributions into the Plan were suspended, and all assets are anticipated to be distributed in 2025. Our opinion is not modified with respect to that matter.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Digital Remedy 401(k) Plan (the "Plan") (formerly known as CPX 401(k) Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act, (the "CARES Act"), was passed by Congress. The CARES Act contains several provisions that temporarily impact 401(k) plans. The plan administrator has elected to allow coronavirus-related distributions, coronavirus loans, and the waiver of required minimum distributions. The Company complies with the necessary provisions of the Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0.

GENERAL

The Plan is a defined contribution plan and was established on January 1, 2015, to provide benefits to eligible employees of CPX Interactive LLC (the "Company"). Employees who have reached the age of 21 and have completed 3 months of employment are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Trustees are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. Effective January 25, 2017, the Plan Sponsor and Trustees amended the Plan name from CPX 401(k) Plan to Digital Remedy 401(k) Plan.

PLAN TERMINATION

Effective March 21, 2025, the Plan Sponsor approved a plan termination, contributions into the Plan were suspended, and all assets are anticipated to be distributed during 2025. Upon termination, all impacted participants became fully vested in their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such as manner as the Company may determine.

CONTRIBUTIONS

Each year, participants may contribute up to 100 percent of annual compensation on a pre-tax basis and/or an after-tax (ROTH) basis, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company, at its discretion, may make matching, or profit-sharing contributions to eligible employees under the terms of the Plan. The amount may vary from year to year, and in years a safe harbor contribution is elected a matching or profit-sharing contribution will not be made.

In 2023, the Company amended the Plan's formula by which the Safe Harbor Matching Contributions are made. Effective January 1, 2023, the employer will make matching contributions of 100 percent of the elective deferral that does not exceed 4 percent of compensation. The safe harbor contribution for the year ended December 31, 2024 was \$513,614.

Effective January 1, 2021, the Plan's definition of eligible compensation was amended to exclude taxable employee benefits for elective deferral purposes.

Participants direct the investments of their contributions and the Company's contributions into various investment options offered by the Plan.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing and safe harbor contribution and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participant's contributions, safe harbor contributions, and earnings thereon are immediately fully vested. Company matching, and profit-sharing contributions are subject to a vesting schedule. The following table illustrates the percentage of any Company matching or profit-sharing contributions that an employee is entitled to, based on the number of years of continuous service with the Company:

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The participant may have two loans outstanding at any time. The loan interest rate is set at 1 percent above the prime rate, as defined in the loan plan provisions. Principal and interest are paid ratably through semi-monthly payroll deductions.

PAYMENT OF BENEFITS

On termination of service due to death, disability, retirement or any other reason, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan also provides for hardship distributions subject to conditions and limitations provided for in the plan document.

FORFEITURES

At December 31, 2024 and 2023, forfeited accounts totaled \$1,965 and \$1,796 respectively. Forfeitures, if any, may be allocated to reduce future Company contributions or plan expenses. Forfeitures did not reduce Company contributions or plan expenses during the year ended December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are classified as distributions based upon the terms of the Plan agreement.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, Fair Value Measurements and Disclosures, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. Mutual funds are valued at quoted market prices in an active market at the end of the period.

Self-Directed Accounts: Consist of common stock and cash (or cash equivalents). The common stocks are valued at the closing price reported on the active market on which the individual securities trade. The cash is valued at cost, which approximates fair value.

For years ended December 31, 2024 and 2023, there were no significant transfer between Level 1 and Level 2 and no transfers in or out of Level 3.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE 4 - GROUP ANNUITY CONTRACT

The Plan has entered into a group annuity contract, the Stable Value Option Fund, with Transamerica Financial Life Insurance Company (“Transamerica”). Transamerica offers a Stable Value Option Fund that the participant may elect to transfer all or part of its funds. The Stable Value Option Fund is considered to be a fully benefit-responsive investment contract. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported by Transamerica, is the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses, a measurement, which approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of Transamerica or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$579,714 and \$392,924, respectively. This investment seeks to protect against any loss of principal while providing returns in excess of money market funds and one-year U.S. Treasury bills. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and with no set maturity. The effective credited interest rate is set semi-annually, on January 1 and July 1, and cannot change during the six-month period for which it is effective. There is no stated minimum or maximum interest rate. Contract charges may reduce this return. The Stable Value Option Fund is not a separate account investment choice – it is an investment in Transamerica’s general account. The average yield of the Stable Value Option Fund based on actual earnings and interest credited to participants yielded 1.58% for the year ended December 31, 2024.

The redemption notice and redemption frequency for the Stable Value Option Fund is daily. There are no unfunded commitments.

Certain events limit the ability of the Plan to transact at contract value with Transamerica. Such events include the following: (1) the Plan is changed so as to significantly affect Transamerica obligations to the contract, (2) the contract can no longer be treated as a pension plan contract, (3) the Plan is terminated, (4) failure to comply with the contract requirements, (5) failure to provide information, or (6) the failure of the trust to qualify for exemption taxes or any required prohibited transaction exemption under ERISA. The plan administrator is not aware of any events, which would limit the Plan's ability to transact at contract value with participants that are probable of occurring.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Transamerica Financial Life Insurance Company Inc. ("Transamerica"), the custodian of the Plan. Transamerica Retirement Solutions ("Transamerica Retirement") is the record-keeper of the Plan. These transactions qualify as party-in-interest transactions. Effective August 2019, Transamerica provides certain administrative services to the Plan pursuant to a service agreement between the Company and Transamerica. Transamerica receives revenue from mutual fund service providers for services Transamerica provides to the funds. This revenue will be used to offset certain amounts owed to Transamerica, or other service providers, for their administrative services to the Plan.

If revenue received from Transamerica from such mutual fund services providers exceeds the amount owed under the agreement, Transamerica remits the excess to the Plan's trust on a monthly basis. Such amounts may be applied to pay Plan administrative expenses. At December 31, 2024, there were excess unallocated revenue credits of \$19,437 that will be used to offset future Plan administrative expenses. These unallocated funds are invested in the Transamerica Stable Value Option Fund and are included in investments, at contract value, on the statements of net assets available for benefits. During the year ended December 31, 2024, the Plan received revenue credits in the amount of \$12,217 which is reported as other income on the statement of changes in net assets available for benefits.

Fees incurred and paid directly by the Plan to the custodian and record-keeper were \$33,653 for the year ended December 31, 2024.

NOTE 6 - INCOME TAX STATUS

The Plan has adopted a volume submitter plan and is relying on an opinion letter received from FJC & Associates, Inc. dated June 30, 2020, stating that the Internal Revenue Service has determined that the volume submitter plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - INFORMATION CERTIFIED BY THE TRUSTEE OR CUSTODIAN

The mutual funds and self-directed accounts are certified as complete and accurate by Transamerica Trust Company (the "Trustee"). The Stable Value Option Fund is certified as complete and accurate by Transamerica (the "Custodian").

The following information included in the accompanying financial statements and supplemental schedule was obtained from data certified as complete and accurate by the Custodian and Trustee of the Plan.
