Notes to Financial Statements

Note 1. Plan Description

The following description of the Western Oilfields Supply Company 401(k) Profit Sharing Plan (the Plan) provides only general information with regard to the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution 401(k) plan covering all full-time employees of Western Oilfields Supply Company (the Company) who have attained the age of 18 except for employees subject to collective bargaining agreements, nonresident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may contribute up to the maximum percentage allowable of pre-tax annual compensation, not to exceed the limits of Code sections 401(k), 404, and 415, as defined in the Plan. Participants are automatically enrolled after 30 days of employment if they do not make an election of their own or opt-out of participation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may also make after-tax contributions up to 10% of eligible compensation. The Company may make discretionary matching contributions up to a discretionary percentage of a participant's compensation. For the year ended December 31, 2024, the Company matched 40% of pre-tax deferrals up to 12% of an employee's eligible wages. For the year ended December 31, 2024, the employer contribution was \$4,175,067 offset by application of forfeitures. Contributions are funded coinciding with participant deferrals.

Forfeitures of terminated employees' nonvested account balances can be used to offset employer contributions and expenses. Forfeiture amounts of \$636,025 were used to offset employer contributions for the year ended December 31, 2024. The forfeiture reserve balance as of December 31, 2024 and 2023 was \$230,805 and \$212,392, respectively.

Participant accounts:

Separate accounts are kept for each participant. Each participant's account is credited with the Company's contributions, the employee's contributions, Plan forfeitures and allocation of Plan earnings or losses and expenses. All amounts in participant accounts are participant-directed; participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions plus earnings thereon is based on continuous years of service. A participant is 100% vested after 5 years of credited service.

Notes receivable, participants:

Participants may borrow up to one loan from their account a minimum of \$1,000, up to a maximum of 50% of their vested account balance. The maximum aggregated dollar amount of a loan outstanding to a participant may not exceed \$50,000. The loans bear interest at a rate commensurate with prime rate plus 1%. Loans are secured by the participant's vested interest in the Plan. No allowance for credit losses has been recorded as of 2024 or 2023.

Benefit payments and withdrawals:

Upon retirement, death, disability or termination, a participant may elect to receive a distribution equal to the vested portion of their account balance. Participants may elect to receive either an installment distribution, a lump sum distribution or a partial lump sum and partial installment distribution. Participants automatically become 100% vested upon reaching normal retirement age, death or termination due to disability. If a terminated participant's vested account balance is less than \$1,000, they will automatically receive payment in the form of a lump sum distribution. Amounts greater than \$1,000 but less than \$7,000 are transferred to an individual retirement account for the participant.

The participant may request for in-service withdrawals if the participant has reached age 59 ½, and may elect to withdraw all or a portion of the entire vested account while the participant is still employed by the Company. The participant may also request for hardship withdrawals in which the participant may withdraw employee pre-tax and after elective contributions to satisfy specific and heavy financial needs in accordance with Internal Revenue Service regulations.

Amounts allocated to accounts of persons who, at December 31, 2024, have elected to withdraw from the Plan but have not been paid are \$-0-.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes to Financial Statements

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes receivable, participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefits:

Benefit payments are recorded when paid.

Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Tax status:

The Plan and related trust are designed and operating in accordance with Section 401(a) of the Internal Revenue Code. The prototype Standardized Profit Sharing Plan Adoption Agreement has received a favorable opinion letter from the Internal Revenue Service dated June 2020. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements

Note 3. Plan Termination

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 4. Fair Value Disclosures

The Financial Accounting Standards Board (FASB) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB are described as follows: Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means; Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered investment companies (mutual funds): The fair values of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
