INDEPENDENT AUDITOR'S REPORT

To the Investment Committee, Plan Administrator and Participants of
Offit Kurman, P.A. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Offit Kurman, P.A. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan of Offit Kurman, P.A. (Company) and was established on October 1, 1994. The Plan is subject to the provisions of ERISA.

Effective December 1, 2023, the Company engaged Fidelity Workplace Services, LLC (FWS) to provide recordkeeping and administration services and Fidelity Management Trust Company (FMTC) for trustee services for the Plan. The Plan's assets were transferred from Reliance Trust Company to FMTC on November 30, 2023. Effective December 1, 2023, the Plan adopted the FMR LLC Defined Contribution Pre-Approved Plan. No significant changes were made at that time.

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0 Act) was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed in these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: The Plan covers substantially all full-time employees. Employees must complete two months of service to become eligible. Leased, temporary and seasonal employees are excluded. However, if a temporary or seasonal employee completes a year of service, as defined, they become eligible to participate at the next plan entry date. New employees are eligible for auto enrollment. Additional eligibility requirements for the Company discretionary contribution are described below.

Recognition of Service with Other Employers: The Plan recognizes predecessor service for employees of certain affiliated employers for eligibility, vesting and contribution allocation purposes. These employers are specifically identified in the plan document.

Contributions: Each year, participants may elect to contribute up to 90% of their eligible compensation (as defined), up to the maximum allowable contribution amount under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Under the Plan's Qualified Automatic Enrollment Arrangement, a pre-tax deferral contribution of 6% of eligible compensation (as defined) will automatically be elected, unless otherwise directed by the employee. Participants who have attained age 50 before the end of the plan year are eligible to make age 50 catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company provides for the following contributions on behalf of participants:

A safe harbor matching contribution equal to 100% of a participant's elective deferrals up to 1% of a participant's eligible compensation plus 50% of a participant's elective deferrals that exceed 1% but do not exceed 6% of a participant's eligible compensation. All participants are eligible for this contribution except for principals of the Company considered highly compensated employees, as defined. The Company's safe harbor matching contribution for 2024 totaled \$1,169,482, net of forfeitures.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Contributions - continued:

The Company may contribute a discretionary contribution as it determines. In order to share in the allocation of the discretionary contribution, a participant must complete two months of service. Participants not actively employed at the end of the plan year will not share in the discretionary contribution, regardless of service, unless the participant dies or terminates employment due to becoming disabled or reaching normal retirement age. No discretionary contribution was made for 2024.

The Company may also make Qualified Nonelective Contributions (QNECs) to eligible participants, as defined in the Plan. No QNECs were made for 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and Company contributions into various registered investment companies (mutual funds) offered by the Plan. For those participants who do not make an investment selection, their contributions and the related Company contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions and QNECs plus earnings thereon. Vesting in the Company's safe harbor and discretionary contributions is based on years of continuous service. A participant is 100 percent vested in the safe harbor matching and discretionary contributions after completing two and three years of service, respectively. Regardless of the vesting schedule, participants will become fully vested upon reaching the normal retirement age, death or total and permanent disability.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at a rate of return commensurate with the prevailing interest rate charged on similar notes and can only exceed a repayment period of five years for the purchase of a principal residence. Only one note may be outstanding at a time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums, substantially equal installments and partial withdrawals and are payable upon termination of employment, death or retirement at age 65. The Plan may automatically distribute vested account balances less than \$7,000 (as updated by the SECURE 2.0 Act) in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59 ½ are also permitted, subject to provisions defined in the plan document, and a minimum withdrawal amount of \$500.

Forfeitures: Forfeitures of the Company's contribution portion of participants' accounts (due to participants' termination prior to full vesting) are to be used to pay administrative expenses and reduce the Company's contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,571 and \$9,569, respectively. During 2024, forfeitures of \$144,468 were used to reduce the Company's safe harbor contribution and \$5,594 used to pay investment advisory service fees.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management and the Investment Committee determine the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions: Contributions from plan participants and the Company safe harbor matching contribution are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. An annual recordkeeping fee, net of revenue credits, fees for investment advisory services and fees related to the administration of notes receivable from participants and participant distributions are charged directly to participants' accounts and are included in administrative expenses.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by FMTC, a qualified institution and trustee of the Plan.

NOTE 5 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed FMR LLC, by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Prior to December 1, 2023, the IRS had determined and informed ADP, Inc. by a letter dated October 6, 2020, that the prototype plan was designed in accordance with applicable sections of the IRC. Although the Plan had been amended since receiving the opinion letter, the plan administrator believed that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments consist of registered investment companies managed and/or issued by Fidelity Investments. Fidelity Investments is the parent company of FWS, the Plan's recordkeeper, and FMTC, the trustee of the Plan. Transactions with Fidelity Investments, FWS and FMTC qualify as party in interest transactions.

FWS provides certain administrative services to the Plan pursuant to the Fidelity Pre-Approved Plan Service Agreement (the Agreement) between the Company and FWS. The Agreement provides for a fixed basis recordkeeping fee. FWS receives recordkeeping revenue based on a fixed amount per participant which is billed and payable quarterly. Certain Fidelity Investment and non-Fidelity Investment products provide revenue credits which are provided in a Revenue Credit Account of the Plan and can be used to offset the recordkeeping revenue. Any remaining balance is billed to participants on a pro-rata basis. FWS is authorized to retain net float earnings earned on the investment of transaction account balances in overnight short-term investments. Under the Agreement, participants also pay transactional fees relative to notes receivable and distributions. Fees paid by the Plan to Fidelity amounted to \$28,916 for 2024, prior to offset of revenue credit income.

NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS - CONTINUED

At December 31, 2024 and 2023, the balance in the Revenue Credit Account totaled \$14,371 and \$0, respectively. The Plan or Company may make payments to FWS for administrative expenses not covered by the aforementioned fees.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 57% and 61%, respectively, of net assets available for benefits is invested in the Fidelity Freedom Funds Funds; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.
