To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Advanced Micro Devices, Inc. Disability Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 and schedule of reportable transactions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The following description of Advanced Micro Devices, Inc. Disability Benefit Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan provides short-term disability (STD) and long-term disability (LTD) benefits to eligible employees of Advanced Micro Devices, Inc. and Xilinx, Inc. (collectively, the Company). The Plan's STD benefits are funded through a trust, and the Plan's LTD benefits are funded through an insurance policy with Liberty Life Assurance Company. The terms and conditions in the underlying insurance policy shall control with respect to all LTD benefits. Effective January 1, 2024, the Plan began using Larkin Company to process new STD claims and MetLife for providing LTD benefits for new claims. The Plan Administrative Committee (the Committee) is responsible for the general administration of the Plan. Principal Bank (the Trustee) is the trustee of the Plan. The Plan's assets are held in a Voluntary Employees' Beneficiary Association (VEBA) trust. The Plan is subject to the provisions of the Internal Revenue Code (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA). Eligible employees are automatically enrolled in the Plan. Those who are not executive employees may opt out of coverage within the first 31 days or may cease coverage on the first day of the month after providing written notice. No pre-existing condition exclusion applies to STD benefits. Executives hired before January 1, 2012 and non-executives are subject to pre-existing exclusions under the insured LTD benefits.

Effective January 1, 2024, the Plan was restated. Plan provisions that were amended upon restatement include: executives being able to drop coverage in the first 30 days after becoming eligible for the Plan, participants being able to add coverage within 30 days of a change in status event, allowing participants to drop coverage at any time for the 2024 Plan year, and stating that participants may only drop coverage within 30 days of a change in status event beginning with the 2025 Plan year.

Effective May 4, 2024, the Plan was amended to update the definition of compensation for purposes of STD benefits and to clarify that California employees are not eligible for STD benefits under this Plan as they are covered by another plan.

Contributions (Continued)

The Plan document provides that participants fund the Plan in the form of after-tax payroll withholdings, which are subsequently used for payment of authorized disability benefits and insurance premiums. A portion of the employee contributions to the Plan is used to pay the premiums for the fully insured coverage. For the year ended December 31, 2024, participants contribute 0.31% of their eligible earnings, as defined, up to \$200,000. For the year ended December 31, 2023, participants contribute 0.30% of their eligible earnings, as defined, up to \$198,000, if non-executive, and \$270,000, if executive. For the year ended December 31, 2024, participants employed in the states of California, New Jersey or New York contribute 0.31% of their eligible earnings up to \$200,000, adjusted for amounts contributed to a state-mandated voluntary plan or the Company's voluntary plan. For the year ended December 31, 2023, participants employed in the states of California, New Jersey or New York contribute 0.30% of their eligible earnings up to \$198,000, if non-executive, and \$270,000, if an executive, adjusted for amounts contributed to a state-mandated voluntary plan or the Company's voluntary plan.

The Company shall have no obligation to make any contributions to the Plan. The Company may, from time-to-time, contribute to the Plan amounts as may be necessary for the proper maintenance and operation of the Plan. Such amounts shall be in complete discharge of the financial obligations of the Company under the Plan with respect to the period or periods for which made. No such Company contributions were made for the years ended December 31, 2024 and 2023.

Payment of Benefits

The administration of claims and the payment of benefits are processed by an independent third-party administrator. An independent actuary estimates the total disability benefits payable by the Plan using a tabular approach for long-term benefits payable and a development approach for short-term benefits payable using the past three years' experience. The tabular method uses the individual characteristics of each disabled participant to determine the reserve estimate for that individual. The estimates are subject to a discount rate of 4.53% and 4.02%, respectively, for the years ended December 31, 2024 and 2023. The development method uses recent claim payment patterns of claimants to determine the reserve. The reserves for the disability benefits incurred but not reported at year-end are implicitly estimated in the development method. For the year ended December 31, 2024, the monthly benefit payment amount is equal to the lesser of 66.67% of the participant's eligible compensation at the time of disability or \$15,000. For the year ended December 31, 2023, the monthly benefit payment amount is equal to the lesser of 66.67% of the participant's eligible compensation at the time of disability or \$11,000, if non-executive, and \$15,000, if executive.

Payment of Benefits (Continued)

Any claims initiated as of January 1, 2012 or later transition to the fully-insured LTD portion of the Plan after 180 days, and are not paid out of the Plan. The amount of benefit is reduced by the amount of benefits received from a state-mandated plan, the Company's voluntary plan, worker's compensation, part-time wages, and Social Security benefits.

Under LTD claims, the maximum benefit period is limited depending on the participant's age at the commencement of the disability as outlined below.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. Estimates that are particularly susceptible to significant change in the near-term are the liabilities for IBNR. Although it is not possible to measure the degree of variability inherent in these estimates, management believes that the liabilities reported are adequate. Any adjustment determined to be necessary is reflected in current operations.

Contributions and Contributions Receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date. The Plan records receivables for participants' contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Contributions from the Company, if any, are recorded in the year paid and coincide with the year in which the Company records the contributions to its general ledger.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Claims and Insurance Premiums

Claim payments and insurance premiums are recorded when paid by the claims administrator.

Accounts Payable and Other Liabilities

Accounts payable and other liabilities totaled \$5,202,371 and \$2,429,576 as of December 31, 2024 and 2023, respectively, and primarily consist of accrued insurance premiums, administrative services only (ASO) fees and taxes as well as amounts related to premiums paid by the Company on behalf of the trust.

Claims Incurred but Not Reported

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Administrative Expenses

The Plan, or the participants, pay for administrative expenses that consist primarily of administrative fees paid to third-party administrators, the trustee, the actuary, and accountants. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. Legal fees are paid by the Company.

Management fees and expenses charged to the Plan for investments in mutual fund accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor (DOL). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

3. BENEFIT OBLIGATIONS

The amount of the disability benefits payable and claims incurred but not reported was \$2,901,801 and \$3,193,466 as of December 31, 2024 and 2023, respectively. The following presents the components of the changes in the Plan's benefit obligations for the years ended December 31, 2024 and 2023:

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued on the basis of historical cost, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. CERTIFICATION OF FINANCIAL INFORMATION

The financial data included in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023 and supplemental schedules of assets (held at end of year) as of December 31, 2024 and reportable transactions for the year ended December 31, 2024, have been certified as complete and accurate by Principal Bank, a qualified institution. The following certified information was obtained by management and agreed to or derived from information certified as complete and accurate, and has not been audited by the independent auditors for the Plan: investments at fair value, accrued interest, interest and dividends, and net appreciation in fair value of investments.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan in accordance with its provisions and subject to the provisions of ERISA and the IRC at any time without any liability for such termination. In the event the Plan is terminated, all benefits due and payable to participants for disabilities originating prior to the Plan's termination date will continue to be paid. Any excess funds are subject to the provisions of ERISA.

7. TAX STATUS

The trust funding the Plan has received an exemption letter from the IRS dated December 14, 1988, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC as a VEBA. Subsequent to issuance of the exemption letter, the Plan was amended and restated. The Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes the Plan, as amended and restated, is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the related trust is tax-exempt. For the years ended December 31, 2024 and 2023, the trust had unrelated business income resulting in estimated federal income tax expense included in the accompanying statements of changes in net assets available for benefits and a related income tax payables as of December 31, 2024 and 2023, which are included in the accompanying statements of net assets available for benefits.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Allspring Global Investments, which is an affiliate of Principal Bank, the Plan's trustee; therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative expenses were paid by the Plan or the Company. Employees of the Company provide administrative services to the Plan for which no fees are charged.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the investment balances and the amounts reported in the statements of net assets available for benefits.
