NOTE A - DESCRIPTION OF PLAN

The following description of the READING INTERNATIONAL, INC. Employee Retirement Savings Plan provides only general information. For a more complete description of the Plan, participants should refer to the Plan Document maintained by READING INTERNATIONAL, INC. (the Company, Plan Administrator and Trustee of the Plan).

General

The Plan is a defined contribution plan established on January 1, 1998 to provide retirement benefits for eligible employees of the Company. The Plan covers all employees who have completed four months of service and are age twenty-one or older, excluding those employees covered by a collective bargaining agreement, leased employees and non-resident aliens. Employees who have met the eligibility requirement, may enter the plan January 1<sup>st</sup> and the same day of the month occurring in each successive 3-month period, coincident with or next following satisfaction of the eligibility requirements. The Plan is subject to and has met the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions and Investment Options

Each year, participants may contribute up to the dollar limit that is set by law of their pretax annual compensation. The limit set by the Internal Revenue Service was \$23,000 in 2024 and \$22,500 in 2023. The catch-up limit for participants aged 50 and over who participate in the plan is \$7,500 in 2024 and \$7,500 in 2023. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time. At the option of the Company’s board of directors, the Company may make profit sharing contributions that are invested in a portfolio of investments as directed by the Company. The profit-sharing allocation is based on the relationship of the participant’s compensation to the total compensation for all participants. The Company has elected to provide a (safe harbor) contribution to each participant who is eligible to make a salary deferral in an amount equal to 100% of the first 3% of salary deferral plus 50% of the next 2% of salary deferral. The Company has evaluated all contribution receivables and has deemed them all collectible and that no allowance is necessary.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All contributions/investments are participant directed.

Vesting

Participants are 100% vested immediately in any salary deferrals (including catch-up contributions), safe harbor contributions and rollover accounts, along with those earnings associated with these accounts. Vesting in the Company’s matching and profit-sharing contribution portion of each participant’s account plus actual earnings thereon is based on years of continuous service. A participant is fully vested after four years of credit service.

Participant Loans

Effective January 1, 2008, the Plan no longer permits participant loans.

Payment of Benefits

On termination of service due to death, disability or normal retirement, the participant becomes 100% vested in their employer profit-sharing account. The Plan provides for a lump-sum distribution. The plan will make the distribution as a direct rollover for any amounts greater than \$1,000.

Forfeitures

Forfeitures will be used by the Plan for payment of plan expenses or to reduce future employer contributions. At December 31, 2024, there was a balance of \$-0- available in the forfeitures account. In 2023, a balance of \$-0- of forfeited funds was used to cover plan expenses.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Administrative expenses recorded by the Plan during the years ended December 31, 2024 and 2023, totaled \$16,530 and \$16,494, respectively. These generally include maintenance fees, withdrawal fees, recordkeeping fees, and managed account fees charged directly to the participant's account.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements and supplemental information have been prepared on the accrual basis of accounting and present the net assets available for benefits and changes in those net assets in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and trustee. See Note F for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Date of Management's Review

Subsequent events were evaluated through October 2, 2025, which is the date the financials were available to be issued.

NOTE C - INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated February 28, 1995, that the form of the Plan and related trust, as then designed, were in accordance with applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for the years prior to 2012.

**NOTE D - INVESTMENT CONTRACT**

The investment contract is an allocated retirement account group contract with Ascensus Trust Company. Ascensus Trust Company maintains the contributions in units of investment in registered investment companies. The accounts are credited with actual earnings, investment gains and losses on the underlying investments and charged for participant withdrawals and administrative expenses not paid by the plan sponsor. The contract is included in the financial statements at fair value as reported to the Plan by Ascensus Trust Company.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer in which interest rates are determined on an individual basis based upon the time the investment is held, but can never be less than 2.5%.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with the Plan participants is not probable.

**NOTE E - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustees have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivables from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and supplemental schedule of assets (held at end of the year) as of December 31, 2024.

The Plan's independent accountants did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE F - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reported date.

Fair value measurements are based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology are other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following section describes the valuation methodologies used to measure various financial instruments at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023.

**Investment in Registered Investment Companies**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE I - PARTY-IN-INTEREST TRANSACTIONS**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned.

Ascensus Trust Company is the trustee of the Plan's investments and, therefore, any transactions with the trustee qualifies as a party-in-interest transaction. The employees of READING INTERNATIONAL, INC. are also parties-in-interest.

Certain Plan investments are units of investment in registered investment company managed by Ascensus Trust Company. Any purchases and sales of these investments are performed in the open market at fair value or contract value. Ascensus Trust Company is the recordkeeper/trustee of the Plan as agent for READING INTERNATIONAL, INC., administrator of the Plan. READING INTERNATIONAL, INC. administrator also makes decisions affecting the plan and makes payments for services provided to the plan. Also, Platform CPAs, LLP performs an independent audit of the Plan. These transactions qualify as party-in-interest transactions for which there is a statutory exemption.

**NOTE J - RECLASSIFICATIONS**

Reclassifications were made to certain prior period amounts in order to conform to the current year classifications. The reclassifications have no effect on reported net income.

## **SUPPLEMENTARY INFORMATION**
