### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Butterball, LLC Salary & Hourly 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

**NOTE 1 — DESCRIPTION OF THE PLAN**

The following description of the Butterball, LLC Salary & Hourly 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General Information**

The Plan is a defined contribution plan for the benefit of eligible employees of Butterball, LLC (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**Eligibility**

Each employee, who is not a leased employee, a nonresident alien or a member of a collective bargaining unit, except members of the United Food and Commercial Workers Local 1208, shall be eligible to participate in the Plan on the first day of the month coinciding with or following the completion of 90 days of service.

**Contributions**

Participants may make voluntary pretax contributions, subject to certain limitations under the terms of the Plan and the Internal Revenue Code (IRC). Effective April 1, 2024, the Plan adopted an amendment to allow for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes safe harbor matching contributions equal to 100% of a participant’s contributions up to 3% of a participant’s eligible compensation, plus 50% of a participant’s contribution up to the next 2% of a participant’s eligible compensation. An additional contribution, resulting from matching being based on annual compensation (true-up), is funded as soon as administratively possible after the end of the Plan year. The Employer may also make a discretionary matching contribution.

**Participant Accounts**

Each participant’s account is credited with participant contributions, Employer safe harbor matching contributions, an allocation of investment earnings (losses) and an allocation of administrative expenses. Allocations of investment earnings, and administrative expenses are based on a participant’s account balance relative to the total of all participant balances in each investment. The benefit to which a participant is entitled is the benefit that can be provided from a participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in employer contributions, other than safe harbor matching contributions, is based on years of service. A participant is 20% vested after two years of service, increasing 20% per year thereafter, with 100% vesting after 6 years of credited service. Participants automatically become fully vested upon attaining retirement age of 65, total disability or death while employed by the Employer, regardless of years of service.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in a participant's account and bear interest at the Wall Street Journal Prime Rate plus 1%. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service, a participant or their beneficiary may elect to receive benefits in a lump sum or installments. If a terminated participant's account balance is equal to or less than \$5,000, the account balance will be automatically distributed. Any distribution greater than \$1,000 that is automatically distributed to a participant before the participant's normal retirement age will be rolled over to an individual retirement plan designated by the Plan administrator. In-service withdrawals are available to participants who have obtained age 59½ or who have met certain hardship requirements, as outlined by the Internal Revenue Service (IRS).

**Forfeitures**

At December 31, 2024 and 2023, forfeitures totaled \$8,141 and \$29,556, respectively. These accounts may be used to reduce future employer contributions and pay administrative expenses. Forfeitures totaling \$25,000 were used to pay administrative expenses during 2024.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as disclosed in Note 5. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Expenses primarily consist of recordkeeping and investment advisory fees. Fees for the administration of notes receivable and benefits paid are included in administrative expenses and are charged directly to participant accounts. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

**NOTE 3 — INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has furnished certain financial information to the Plan Administrator and certified as to its completeness and accuracy. These certifications are as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and include investment information related to investments, notes receivable from participants, net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants that is included in the Plan's financial statements and supplemental schedule of assets (held at end of year).

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets, that the Plan has the ability to access, for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices of identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 were not available.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price.

Money market funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Common collective trusts: Valued at the NAV of units of the collective trust. Due to the various unique investments that may be allowed in a collective trust, and the various redemption restrictions that may be imposed, the CCT funds are valued at NAV, as provided by the trustee, as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. As of December 31, 2024, there were no redemption restrictions.

**NOTE 5 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with Standard Insurance Company (“SIC”). SIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. SIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by SIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

There are no reserves against the contract value for credit risk of SIC or otherwise. The contract guarantees a periodic minimum rate of interest not less frequently than annually. The interest rate is guaranteed to be not less than 1%. The crediting rate is determined quarterly and is based on a formula agreed upon with the issuer.

There are no events that limit the ability of the Plan to transact at contract value with the issuer. In addition, there are no events that would permit issuers to terminate the contract and settle at amounts that differ from contract value.

The following represents the contract value of the GIC held by the Plan at December 31:

**NOTE 6 — TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit-sharing plan sponsored by FMR LLC. The underlying non-standardized prototype plan has an opinion letter from the IRS dated June 30, 2020, which states that the prototype profit sharing plan, as then designed, was in compliance with the applicable sections of the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 6 — TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 7 — PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Fidelity Management Trust Company. The Plan has also entered into a Guaranteed Investment Contract with Standard Insurance Company. These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

Notes receivable from participants qualify as party-in-interest transactions and are also exempt from the prohibited transaction rules of ERISA.

**NOTE 8 — PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all of their accounts.

**NOTE 9 — RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
