Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 - Plan Description

The following description of the Accuride Consolidated Employee Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering salaried and non-bargaining hourly employees of Accuride Corporation (Company and Plan Sponsor) and its participating subsidiaries, affiliates, and locations who have completed 30 days of service, as defined by the Plan. The Plan is subject to the provisions of ERISA. The Plan administrator is responsible for the oversight of the Plan. The Benefits Administration Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On October 9, 2024, the Plan Sponsor filed for Chapter 11 (reorganization) bankruptcy, and later emerged from bankruptcy on March 7, 2025. During this time, the Plan experienced no significant operational changes and remained fully funded.

Contributions

Each year, participants may elect to contribute up to the maximum amount allowed by the Internal Revenue Code (IRC) of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Company shall increase the deferral rate for employees automatically enrolled by one percent annually up to ten percent, unless the employee elects against the increase. The Company makes a qualified automatic contribution agreement (QACA) Safe Harbor matching contribution equal to 100 percent of the first one percent, plus 50 percent of the next five percent of the participant's eligible compensation contributed to the Plan. The Company may make a discretionary, nonelective contribution each Plan year. There were no discretionary, nonelective matching contributions in 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company QACA Safe Harbor matching contributions, as well as allocations of the Company's discretionary, nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's QACA Safe Harbor matching contribution and discretionary, nonelective contribution portion of their accounts, is based on years of continuous service. A participant is 100 percent vested after two years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and interest rates ranging from 5.25 to 10.5 percent currently, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installment payments. Participants may request a hardship withdrawal of a portion of their account attributable to participant deferrals. Any hardship withdrawal is limited to the amount needed to meet the financial need. Active participants may also take distributions from the Plan upon attainment of age 59½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,417 and \$520, respectively. These accounts will be used to offset Plan expenses and reduce future QACA Safe Harbor matching contributions, discretionary, and nonelective contributions. During 2024, employer contributions were offset by \$9,950 from forfeited nonvested accounts.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits Administration Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. When applicable, fees related to hardship withdrawals as well as notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

Interest-bearing cash: Accounts primarily consist of money market accounts that are valued on the basis of readily determinable market prices.

Note 5 - Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by State Street Bank and Trust Company. State Street Bank and Trust Company is the Trustee for the Plan and; therefore, these transactions qualify as party-in-interest transactions. Transamerica Retirement Solutions, LLC provides certain administrative services to the Plan; therefore, these transactions also qualify as party-in-interest transactions. As described in Note 2, the Plan made a payment to Transamerica Retirement Solutions, LLC of \$98,490. Fees paid to other service providers, which are also considered party-in-interest transactions for the year ended December 31, 2024 were \$30,400.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company's matching and nonelective contributions.

Note 7 - Tax Status

The Plan adopted a nonstandardized pre-approved profit sharing plan with Cash or Deferred Arrangement sponsored by Transamerica Retirement Solutions, LLC. The Plan has received an opinion letter from the IRS as to the Plan's qualified status. The Plan Sponsor can rely on the qualified status to the extent the Plan Document does not deviate from the IRS pre-approved provisions. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Non-exempt Transactions

In the fourth quarter 2024, the Plan Sponsor inadvertently deposited \$400,498 of participant contributions, including participant loan repayments, ranging from one to four days later than the required timeframe as stated by the Department of Labor regulations. The Plan Sponsor did remit the full principal amount of \$400,498 to the Plan. During 2025, the Plan Sponsor will deposit lost earnings to correct for the delay. The Plan Sponsor also plans to file Form 5330 and pay applicable excise taxes to the IRS. The correction and excise taxes will be paid from the Plan Sponsor's assets and not from assets of the Plan.

Note 11 - Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

In January 2025, the Gunitite Plant in Rockford, Illinois closed. The closure of the Gunitite Plant affects certain Gunitite salary employees that participated in the Plan, which represented less than 20 percent of Plan participants. The termination of these participants is not expected to have any other material effects to the Plan for 2025.
