Note 1 – Plan Description

The following description of the Employees' Thrift Plan (the "Plan") of Davis H. Elliot Company, Incorporated (the "Company") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees, with the exception of certain classes of employees as defined in the Plan document, who have ninety days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year participants may contribute a percentage of their compensation not to exceed the dollar amount limit set by law. Participants are auto enrolled at 2% after meeting the service requirement. The Company matches 50% of the first 2% of compensation a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company's Board of Directors. Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching and additional contributions, and allocations of earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Individual accounts are fully vested at all times.

Payment of Benefits

On termination of service due to retirement, death, or disability, or after termination, a participant or beneficiary will receive a lump-sum distribution equal to the value of the participant's account. Distributions are paid as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Administrative Expenses

Administrative expenses incurred by the Plan are paid by both the Plan and the Company.

ESOP Transfer

The Company, as Plan Sponsor for both the Plan and the Davis H. Elliot Company, Incorporated Employee Stock Ownership Plan ("ESOP Plan"), entered into a transfer agreement to liquidate investments of certain former employee participants

of the ESOP Plan and transfer such participants' entire ESOP balances to this Plan. These transfers also included participant diversification distributions. The transfer agreement is effective until it is revoked or terminated by both parties.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 1, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with

those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurements

The fair values of mutual funds, pooled separate accounts, and the collective trust fund are based on quoted net asset values of the shares held by the Plan at year end.

Note 4 – Collective Trust Fund

The Plan has investments in the Principal Stable Value Fund at December 31, 2024 and 2023. Included in this fund are guaranteed investment contracts and certain wrapper contracts. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yield for the fund was approximately 2.73% and 2.66% for 2024 and 2023, respectively. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants at December 31, 2024 and 2023 was 2.54% and 2.68%, respectively. The percentage of contributions allocated to the fund are determined by the participants.

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants invest in funds held or managed by the Plan Trustee, as well as other investment management companies. Investments in funds issued or managed by the Trustee are considered related party transactions. Fees paid to the Trustee by the Plan for investment management and trust services amounted to \$343,898 for 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 7 – Income Tax Status

The Plan was adopted under a prototype plan arrangement with Principal Life Insurance Company who has received a letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that its master prototype plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The prototype as adopted includes amendments added since the date of the IRS letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
