We have performed audits of the financial statements of Air Methods Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Notes to Financial Statements

1. Plan Description

The following description of the Air Methods Corporation 401(k) Plan (the Plan), as amended, provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established by Air Methods Corporation and related employers who have adopted the Plan (the Company) effective January 1, 1989 and was most recently restated November 15, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The Benefit Committee of Air Methods Corporation administers the Plan. Fidelity Management Trust Company (Fidelity) serves as trustee, manages Plan assets, and maintains the Plan's records. The Plan offers Plan participants a variety of investment options through various mutual funds, a money market fund, a collective investment trust, and a self-directed brokerage account. Individual accounts are invested in the various investment options at the direction of the participants.

Eligibility

The Plan is available to employees aged 18 years or older who have completed 30 days of service. Per diem, temporary employees and interns are eligible at age 21 and after working 1,000 hours, as defined. The entry date for eligible participants is the first day of the month after meeting eligibility requirements. Leased employees are not eligible to participate in the Plan.

Contributions

Participants may make pre-tax or after-tax Roth contributions up to 60% of their annual eligible compensation, as limited by the Internal Revenue Code (IRC). This maximum percentage may be reduced by the Plan administrator in certain circumstances. Eligible employees who have reached age 50 during the Plan year may elect to make catch-up contributions, as limited by the IRC. Employee contributions to the Plan are made through regular payroll deductions. Participants can elect to discontinue or change contributions as allowed by the Plan.

The Plan allows for discretionary matching contributions and discretionary employer non-elective contributions. The discretionary matching contribution for the year ended December 31, 2024 was 70% of the first 8% of compensation deferred by the participant. For 2024, the Company did not make a discretionary employer non-elective contribution.

The Plan also permits rollover contributions from other qualified retirement plans, as defined in the Plan Document.

Participants' Accounts

Each participant's account is credited or debited with the participant's contributions, Company's discretionary contributions, withdrawals, an allocation of Plan earnings or losses, forfeitures, and Plan expenses. Plan earnings or losses are allocated to each participant's account in the proportion

that the balance of each participant's account bears to the total balance of all participants in each investment option selected. The benefit to which a participant is entitled is the vested portion of the participant's account.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note is secured by the participant's account and bears an interest rate based on the rates available for similar loans from commercial lending institutions and is fixed for the term of the note. The note may be for a term of up to five years, or up to ten years if the note is for the purchase of a principal residence, and is subject to certain other restrictions, as defined by the Plan Document, and applicable restrictions under the IRC. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount, leave the account in the Plan, or roll over the vested balance to another qualified retirement plan or Individual Retirement Account (IRA). Participants may also elect to receive their benefits in the form of an installment and partial withdrawals.

The Plan allows in-service distributions to participants aged 59½ or older who have not terminated employment with the Plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Effective November 12, 2024, management elected to adopt certain SECURE 2.0 provisions, which allows for in-service withdrawals as a result of domestic abuse, emergency expenses, qualified birth and adoption, and qualified declared disasters.

For terminated participants with vested balances greater than \$1,000, but less than \$5,000, if an election to distribute benefits is not made within 60 days following their termination date, their vested balance will be rolled into an IRA for the benefit of the participant. Furthermore, the Plan allows for terminated participant vested account balances less than \$1,000 to be automatically distributed. The Internal Revenue Service (IRS) has required minimum distributions once a participant reaches the requirement minimum age during the previous Plan year and is no longer employed by the Company.

Vesting and Forfeitures

Participants are 100% vested in their voluntary contributions, discretionary employer non-elective contributions, plus allocated earnings or losses thereon. A participant's vested interest in the discretionary matching contributions is based upon a participant's years of service, as defined, and will vest as follows:

Matching contributions from certain previous employers are subject to historical vesting schedules and certain prior service credit may apply. A participant's account becomes 100% vested upon death, attaining normal retirement age (the age of 59½) while an employee, retirement due to disability, or termination of the Plan.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$191,874 and \$707,311, respectively. Forfeited amounts may be used to pay administrative expenses or to reduce the employer contributions. During the year ended December 31, 2024, \$1,544,658 of forfeitures were utilized to fund employer contributions, and no fees were used to pay administrative expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested and non-forfeitable, to the extent not already vested.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Investment Committee determines the Plan's valuation policies utilizing information provided by the Benefit Committee and Fidelity.

Net appreciation or depreciation represents the difference between the aggregate fair value of investments at year-end and the values at the beginning of the year (or date purchased during the year) and includes any realized gains and losses in shares that were bought and sold during the year and reinvested capital gain distributions on those investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses (in the form of an expense ratio) charged to the Plan for investments in the mutual funds and collective investment trusts are deducted from income earned on a daily basis and reflected as a reduction of investment return for such investments.

Contributions

Participant deferral contributions and related discretionary matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary employer non-elective contributions, if any, are recognized in the period to which the participant's compensation relates.

Notes Receivable from Participants

Participant notes receivable are measured at their unpaid principal balance. Any accrued interest is de minimis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan balance to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses of the Plan

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. The Plan participants pay loan origination, loan maintenance, distribution, and investment advisor fees, which are charged directly to the participant's account. Under the service provider agreement with Fidelity, revenue sharing rebates of \$253,022 were received from mutual funds held by the Plan, which reduce recordkeeping fees and are shown in the accompanying financial statements as other income. Certain investment expenses may be netted with earnings of the mutual funds and are based on agreed upon expense ratios of each fund.

3. Fair Value Measurements and Disclosures

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs are the highest priority and consist of unadjusted quoted prices in active markets for identical assets and liabilities. Level 2 inputs are inputs for quoted prices for similar assets or liabilities in active markets; inputs for quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are the lowest priority and are unobservable and significant to the fair value measurement of an asset or liability.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and

Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust - The Morley Stable Value Fund is a collective investment trust that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of collective trust. The NAV is used as a practical expedient to estimate fair value of the trusts. This practical expedient would not be used if it is determined to be probable that the investment will sell the investment for an amount different from the reported NAV. This investment is a direct filing entity.

Commingled Fund - The Fidelity Contrafund Pooled Fund is a commingled fund that is primarily invested in the Fidelity Contrafund mutual fund. The NAV is used as a practical expedient to estimate fair value of the trusts. This practical expedient would not be used if it is determined to be probable that the investment will sell the investment for an amount different from the reported NAV. This investment is a direct filing entity.

Self-Directed Brokerage Account - The self-directed brokerage account primarily consists of common stock, mutual funds, exchange-traded funds, and other investment vehicles that are registered with the Securities and Exchange Commission and traded daily on an active exchange. These investments are valued daily based upon their last reported sales prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

5. Income Taxes

The Plan adopted a prototype plan document, which has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the IRC and is, therefore, exempt from federal income taxes under provisions of applicable sections of the IRC. The Plan has since been amended; however, the Plan administrator believes that the Plan continues to be operated and administered in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party and Party-in-Interest Transactions

The Plan invests in various mutual funds, collective investment trusts, and a commingled fund that are held and managed by Fidelity, the trustee and recordkeeper of the Plan. Fees of \$469,044 were paid to Fidelity, or affiliates of Fidelity, from the Plan and through revenue sharing during 2024. Fidelity may also receive certain indirect fees from the various mutual funds. Certain management fees (in the form of an expense ratio charged to each investment option) are deducted from earnings or losses on investments. In addition, the Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. The above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

7. Concentrations, Risks, and Uncertainties

The Plan invests in various investment securities. Investments, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
