Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stanford Federal Credit Union Deferred Compensation Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Stanford Federal Credit Union Deferred Compensation Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Stanford Federal Credit Union Deferred Compensation Plan (the Plan) provides only general information. Participants should refer to the Plan and Trust Agreement (Plan Document) for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) profit sharing plan established on January 1, 1984. The Plan has been amended and restated throughout the years to comply with tax legislation and most recently restated October 15, 2021. Substantially all employees of Stanford Federal Credit Union (Credit Union) are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Credit Union is the Plan's Sponsor and serves as the Plan administrator.

Eligibility

Employees of the Credit Union are eligible to participate in the deferral and match components of the Plan on their date of hire. Employees that were hired as of the first day of a quarter and were employed on the last day of the plan year will be eligible to receive employer profit sharing contributions.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, which is increased by 1% annually, until it reaches 10%.

The Credit Union may, at its discretion, make discretionary matching or profit-sharing contributions to the Plan. This matching percentage will be determined annually. For the years ended December 31, 2024 and 2023, the Credit Union's matching contribution was 100% of the first 5% of eligible compensation deferred that a participant contributed to the Plan. For the years ended December 31, 2024 and 2023, the Credit Union's profit-sharing contribution was approximately \$648,000 and \$569,000, respectively, which were allocated ratably to participants based on eligible compensation.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Individual accounts are maintained to record participant contributions, matching contributions, rollover contributions, profit-sharing contributions, and earnings thereon for each participant. Matching and profit-sharing contributions are referred to as employer contributions. The benefit to which a participant is entitled is the total benefit, which can be provided from the vested portion of these individual accounts.

Vesting

Upon entry into the Plan, participants are 100% vested in their participant contributions, rollover contributions, and earnings thereon. Vesting for the employer contributions and earnings thereon is based on years of service as follows:

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their accounts. The amounts borrowed are limited to the lesser of \$50,000 or one-half of the participant's vested account balance and must be greater than \$1,000. Loans must bear a reasonable rate of interest and must be repaid within five years. Current interest rates on these loans are prime plus 1%.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may request a distribution of their vested account balance from the Plan administrator. Furthermore, participants may be entitled to take hardship distributions subject to Plan provisions. Participants who have attained age 59½ may elect to withdraw a portion of their account while still employed. Participants that have terminated employment and have a vested balance less than \$1,000 will receive a distribution as soon as administratively feasible. Benefits are recorded when paid.

Forfeited Accounts

Forfeited accounts will be used to reduce employer contributions. Forfeitures as of December 31, 2024 and 2023 were \$121,005 and \$80,327, respectively. There were \$27,583 and \$25,157 of forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively. There were \$68,121 and \$111,482 of forfeitures used to reduce employer contributions for the years ended December 31, 2024 or 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Fees and Expenses

Certain expenses of maintaining the Plan are paid directly by the Credit Union and are excluded from these financial statements. Certain participant transaction fees, recordkeeping fees, and administrative fees are paid by the participants and are included in administrative expenses. Investment related expenses are included in net appreciation in the value of investments.

Subsequent Events

Management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Ascensus, Inc., as custodian and agent for Ascensus Trust Company (Ascensus), the custodian of the Plan, has supplied a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at the end of the year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing the information to the related information included in the financial statements and supplemental schedule.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobserved inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market: Valued at the daily closing price as reported by the fund. Money market accounts are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. SEC guidelines are such that the fund try to maintain a value of one dollar per share. The money market accounts held by the Plan are deemed to be actively traded.

NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY

The investment Variable Annuity Life Insurance Company (VALIC) GFUA-398 is a traditional investment contract that invests primarily in U.S. government securities, corporate bonds, mortgage-backed securities, asset-backed securities, private placement, mortgage loans, foreign bonds, private equity, hedge funds, and interest rate derivatives. Its investment objective is to optimize high yield adjusting for credit risk, liquidity, and liability characteristics. It holds a broadly diversified portfolio of U.S. dollar-denominated, fixed-income securities with a small allocation to alternative investments. The synthetic GICs are obligated to provide an interest rate not less than zero. The average interest rate earned on the investment during 2024 and 2023 was 0.96% and 1.00%, respectively.

The contract is issued directly to the employer and cannot be sold, assigned, discounted, or pledged as collateral for a loan or as security for the performance of an obligation. Furthermore, the contract and its rights cannot be transferred to anyone other than VALIC, except under a domestic relations order properly issued by a court of competent jurisdiction and that complies with ERISA. VALIC will pay annuity and other benefits as provided in the contract. The contract provides a guarantee of principal and previously credited interest, as well as a minimum guaranteed rate for the life of the contract. Moreover, the contract declares a rate each year which is guaranteed for that full year, and may declare rates from time to time during the year which are in excess of both the annual and lifetime guarantees. Participant transactions are conducted solely at contract value. The Plan may withdraw a portion of the accumulation value to provide participant benefits or transfers requested by participants to specific Plan maintained investment facilities, excluding competing options. If the Plan includes a competing option, participant requested transfers may be made only if the transfer amount remains in the receiving option for at least 90 days (equity wash provision). In the event of contract surrender, the contract value will be paid over a five-year installment plan or under a decreasing balance method, as defined.

The Credit Union understands that Plan restrictions on participant withdrawals which are generally consistent with applicable legal requirements for such plans, and common restrictions such as equity wash provisions, should not adversely affect a contract's status as a fully benefit-responsive contract. The Credit Union's plans or expectations, such as for mergers, layoffs, bankruptcy, or Plan termination, could affect a determination of whether the contract is fully benefit-responsive, depending on the terms of the contract.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 TAX STATUS

The Plan is placing reliance on opinion letters received from the IRS, stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (IRC), and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are held by Ascensus, the custodian and Plan record keeper. Ascensus is an affiliate of Vanguard. The Plan's investment advisor is Allworth Financial, LP. Therefore, any investment or administrative fees paid during the year to these entities qualify as party-in-interest transactions.
