NOTE 1 – DESCRIPTION OF PLAN

The following description of the TRM Innovative Hearth Products 401(k) Plan (the “Plan”) is provided for general information purposes only. The Plan was established April 24, 2012, is sponsored by TRM Innovative Hearth Products, LLC (“the Plan sponsor”), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has been amended from time to time to comply with current legislation and management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Eligibility

Employees become eligible to participate in the Plan on the first day coincident with attainment of age 18 – as long as the participant is not a leased employee or considered an independent contractor.

Contributions

Participants may make voluntary contributions to the Plan of up to 75% of their annual eligible compensation, but not in excess of the maximum amount permitted by the Internal Revenue Code. The Plan sponsor has a safe harbor match of 100% of employee contributions up to 3% of their annual compensation and a 50% match on the next 2% of their annual compensation (up to the annual IRS contribution limit).

In addition, the Plan sponsor may elect to make a discretionary contribution to eligible participants, determined each year by management.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Participant accounts

Upon enrollment in the Plan, or at any time subsequent, a participant may direct contributions into any of the available investment options. Each participant's account is credited with contributions in an amount equal to the salary reduction elected by that employee and any related matching or discretionary contribution. Earnings and administrative expenses are allocated based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately 100% vested in their accounts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Repayment of loan principal and interest are made through regular payroll deductions for a period of up to 5 years. Loan terms may exceed 5 years only in the event that loan proceeds are used to purchase or construct the participant's principal residence.

If a participant's employment terminates for any reason and the loan balances are not paid in full within 60 days of termination, the loan balances will be deemed distributed and become taxable income to the participant.

Benefit Payments

Generally, benefits are paid to participants at termination. When the service period ends as a result of death or retirement, the participant or beneficiary will receive a lump sum distribution equal to the value of their account. Participants may elect to defer receipt of benefits. The Plan had obligations to terminated employees totaling \$3,323,396 and \$3,356,394 at December 31, 2024 and 2023, respectively.

Investment Options

All investments are participant directed among various *Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company*, investment options.

Administrative Expenses

Certain plan administrative fees are absorbed by the Plan sponsor and certain administrative fees are paid by the Plan. Administrative fees paid by the Plan amounted to \$20,245 and \$30,262 during 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

All Plan investments are held by the Plan custodians, *Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company*, and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for further discussion and disclosure related to fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses on the Plan's investments are included in net appreciation in the fair value of investments in the statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Plan custodian shall hold the funds for distribution and distribute to the participants their full account balance on the date of such termination, less the administrative cost to the custodian for such distribution, in accordance with the Plan provisions.

NOTE 4 – TAX STATUS

The Plan sponsor's Board of Directors adopted the Volume Submitter Profit Sharing 401(k) Plan document. The Plan document has received an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan is required to operate in conformity with the Code to maintain qualification.

Although the Plan has been amended since receiving the determination letter, management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

The Plan has adopted the provisions of ASC Topic 740, *Income Taxes*, relating to uncertain tax positions. ASC Topic 740 provides a consistent framework to determine the appropriate level of tax reserves to maintain for uncertain tax positions. Specifically, the Plan must recognize a tax liability (or asset) if the Plan has taken an uncertain position that *more likely than not* would not be sustained upon examination by applicable taxing authorities.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

The Plan sponsor provides certain accounting, recordkeeping, and administrative services for the Plan for which no compensation is received. Administrative expenses for legal, accounting and other services are rendered by parties-in-interest and are paid by Plan sponsor.

Certain plan assets are in investment funds managed by *Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company*. *Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company* are the Plan custodians; therefore, transactions with *Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company* and *Principal Life Insurance Company* qualify as party-in-interest transactions.

NOTE 6 – INVESTMENTS - UNAUDITED

Management, having determined it is permissible in the circumstances, has elected to have the audit of the TRM Innovative Hearth Products 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company and *Principal Life Insurance Company*, the Plan custodians, have certified the completeness and accuracy of all investment information reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the 2024 schedule of assets held at end of year, and the related investment activity reflected in the statements of changes in net assets available for benefits for 2024 and 2023.

NOTE 7 – FAIR VALUE OF FINANCIAL INSTRUMENTS

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). ASC Topic 820 requires fair value measurements to be separately disclosed by level within the fair value hierarchy.

The three levels of fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for *identical* assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: quoted market prices for *similar* assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Valuation is generated from model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect the estimates of assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 7 – FAIR VALUE OF FINANCIAL INSTRUMENTS (CONTINUED)

The following valuation methodologies were used to measure the fair value of the Plan's investments:

Common collective trusts (CCT's) are tax-exempt, pooled investment vehicles, similar to a mutual fund but exclusively for qualified retirement plans. CCT's are reported at their net asset value (NAV) derived from the fair value of its underlying assets, which are comprised of various securities like stocks and bonds. CCT holdings are included as Level 1 assets in the fair value hierarchy.

Pooled separate accounts consist of units of participation in separate accounts, which are valued daily at their accumulated unit value. Accumulated unit value is determined based on the net asset values of the underlying mutual funds, which are generally quoted in active markets that the Plan has access to. There are no transfer or redemption restrictions, and no unfunded commitments on these investments. Pooled separate accounts are included as Level 1 assets in the fair value hierarchy.

Registered investment companies include a portfolio of financial instruments that include U.S. equities, international equities, and short and intermediate term investment funds. These are valued based on a quoted market price for identical assets in active markets that the Plan has the ability to access. Registered investment companies are included as Level 1 assets in the fair value hierarchy.

Fully benefit-responsive investment contracts ("FBRIC's") consist of a diversified portfolio of Guaranteed Investment Contracts issued by life insurance companies, banks and other financial institutions - the performance of which may be predicated on underlying fixed income investments. The principal value of these assets is designed to remain stable regardless of stock and bond market fluctuations. FBRIC's are valued at fair value using NAV per share (or its equivalent) as a practical expedient at year-end. In accordance with accounting pronouncements, the FBRIC's which are carried at fair value using the net asset value practical expedient, are no longer carried at contract value in the statement of net assets available for benefits and are not categorized within the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8 – EXCESS CONTRIBUTIONS TO PARTICIPANTS

During 2023, the Plan sponsor discovered an operational error related to the Plan. Specifically, it was determined that certain participants in the Plan received additional contributions - consisting of employee deferrals; related employer matching contributions; and, if applicable, loan payments.

To rectify this error, the Plan sponsor voluntarily entered the Internal Revenue Service's (IRS) Voluntary Correction Program (VCP).

As of the date of this report, the Plan sponsor had not received a compliance statement from the IRS approving the Plan sponsor's proposed correction method. However, management believes that the Plan's qualified status will be maintained as a result of the VCP submission and ultimate correction.

The Plan sponsor has taken steps to enhance its internal procedures to prevent similar errors in the future. Management does not believe the Plan's tax-qualified status would be adversely affected by this operational failure.

NOTE 9 – SUBSEQUENT EVENTS

In accordance with ASC Topic 855, *Subsequent Events*, Plan management has evaluated subsequent events through September 19, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
