## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### (1) DESCRIPTION OF PLAN

The following description of the Bailey Nurseries, Inc. 401(K) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all full-time employees age 21 or older, including H2A employees, of Bailey Nurseries, Inc. and its subsidiaries, Bailey Nurseries Services, Inc., Bailey Nurseries Growers, Inc. and Plant Introductions, Inc. (collectively the "Company"). All employees of the Company age 21 or older are eligible to participate in the Plan and may enter the Plan at the next Plan entry date after the completion of twelve months of eligible service and a minimum of 1,000 hours of service. Plan entry dates are at the beginning of each calendar quarter. Effective October 1, 2024, all full-time employees age 21 or older are eligible to participate in the Plan upon completion of one month of service. All employees who were eligible to participate in the Plan on the Plan amendment date of October 1, 2024, were eligible to enter the Plan at the next Plan entry date. The plan amendment extended eligibility to part-time, seasonal, and long-term part-time employees of the Company. Part-time and seasonal employees age 21 or older upon completion of 1,000 hours of service within the Plan year, and long-term part-time employees age 21 or older, who have completed at least 500 hours of service within two consecutive years within a 12 month period, become eligible for Plan entry on the first day of the next month after obtaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("IRC").

The Plan is administered by the Company's Retirement Committee ("Committee"), which is a committee of certain board of directors and management of the Company and includes the Trustees of the Plan. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions** - Participants may elect to contribute up to 100% of their eligible compensation to the Plan, not to exceed the maximum amount allowed, as an elective pre-tax or Roth deferral savings contribution under Section 401(k) of the IRC. Participants may also rollover into the Plan contributions received from other qualified plans ("rollover contributions"). Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions. The Plan provides for a discretionary Company matching contribution on eligible participant contributions as determined annually by the board of directors. For the Plan year ended December 31, 2024, the Company made matching contributions equal to 20% of the first 10% of eligible participant compensation.

The Plan also provides for profit sharing contribution by the Company, which is discretionary and determined annually by the Company's board of directors. The Company did not make any discretionary profit-sharing contributions for the year ended December 31, 2024.

Participant and Company contributions to the Plan are limited to the maximum amount deductible for federal income tax purposes. Contributions in excess of IRC limitations are returned to the participants and Company when determined.

**Participant investment account options** – Participants direct the investment of all contributions and their account balances into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts and a guaranteed return account.

### ( 1 ) DESCRIPTION OF PLAN (CONTINUED)

**Participant accounts** - Each participant's account is credited with their voluntary 401(k) contributions, the related employer's 401(k) matching contributions, participant rollover contributions from other qualified plans and an allocation of the Company's discretionary profit sharing plan contributions, plan earnings or losses and plan administrative expenses. Allocations of the profit sharing contributions are based on participant eligible compensation. Plan earnings or losses are allocated based on participant account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary 401(k) contributions, the employer's 401(k) matching contributions, Company discretionary profit sharing contributions, participant rollover contributions and earnings or losses thereon.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest on loans issued are paid ratably through direct debit from participant accounts at external financial institutions.

**Payment of benefits** - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

### ( 2 ) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates** - The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussions of fair value measurements.

### ( 2 ) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Investment valuation and income recognition (continued)** - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and at year end.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### ( 3 ) INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The trustee (or custodian) of the Plan, The Standard Insurance Company, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest income
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountant did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### ( 4 ) FAIR VALUE MEASUREMENTS

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the Net Asset Value ("NAV") of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily and do not have any redemption restrictions. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. Additionally, there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### ( 4 ) FAIR VALUE MEASUREMENTS (CONTINUED)

In accordance with Subtopic 820-10, the pooled separate accounts that were measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. No plan investments are classified in the fair value hierarchy.

### ( 5 ) GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANIES

The Plan has a fully benefit-responsive guaranteed investment contract with Standard Insurance Company (the "Custodian"). The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.50%. The guaranteed investment contract does not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

### ( 6 ) RELATED PARTY AND PARTIES IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Standard Insurance Company. Standard Insurance Company is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator of \$86,391 for the year ended December 31, 2024, which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### ( 7 ) PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

### ( 8 ) TAX STATUS

The Internal Revenue Service ("IRS") has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed the custodian of such in a letter dated June 30, 2020. The plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that is more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ( 9 ) RISKS, UNCERTAINTIES AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market risks and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **( 9 ) RISKS, UNCERTAINTIES AND CONCENTRATIONS (CONTINUED)**

At both December 31, 2024 and 2023, approximately 15% of the Plan's investments were invested in the Vanguard Equity-Income Admiral Fund and 20% in the JPMorgan Large Cap Growth Fund.

### **( 10 ) EXCESS CONTRIBUTIONS REFUNDABLE**

Contributions received from participants for 2024 are net of payments of \$78,046 made in March 2025 to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. At December 31, 2024 and 2023, \$78,046 and \$61,012, respectively, have been included in the Plan's statements of net assets available for benefits as excess contributions refundable.

### **( 11 ) SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued.
