The Plan is supposed to use the forfeitures every year to pay for the Plan's administrative expenses or to reduce employer contributions. However, we noted that the forfeitures increased in 2024 and were not fully used for either of these purposes.

Note 1. Description of the Plan

The following description of Boston Dynamics, Inc. 401k Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide eligible employees of Boston Dynamics, Inc. (the Company) with retirement benefits in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended.

Eligibility

All employees of the Company, other than leased employees or part time or seasonal employees (as defined), who are over the age of 21 are eligible to participate in the Plan. Employees may enter the plan on the first day of the month following the date on which eligibility requirements are met.

The Plan also includes an automatic enrollment provision. Therefore, when an employee becomes eligible to be a participant in the Plan, the Company will automatically, on behalf of those participants, defer 3% of the participants' eligible compensation (as defined). Participants who were automatically enrolled are also subject to an auto escalation of 1% of compensation up to a maximum of 6%. These increases will take place as soon as administratively feasible on or after each successive anniversary date of the participant's enrollment. These deferrals will be allocated to a default fund as defined in the plan document. Participants may cancel, modify or otherwise change any of the automatic elections.

Participant Contributions

Eligible participants may elect to contribute up to 80% of their eligible pre-tax annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC. In addition, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional "catch up" contribution. The Plan also allows for participants to defer funds into a Roth 401(k). These deferrals are subject to federal income taxes, and the maximum allowable participant contribution is the IRC limit combined between both the Roth and the pre-tax deferral. The Plan currently offers various mutual funds as investment options for participants.

The Plan also allows rollover contributions from other qualified plans as defined in the Plan document.

Employer Contributions

The Plan document provides for discretionary matching contributions. For the year ended December 31, 2024, all eligible employees were matched at 100% of the first 4% of their eligible compensation. Discretionary match contributions totaled \$4,931,758 for the year ended December 31, 2024. The plan document also allows for an annual "true up" calculation to participant accounts. The Company's 2023 true up contribution totaling \$808,108 was funded to the Plan on March 7, 2024. For the year ended December 31, 2024, the true up calculation resulted in a contribution of \$987,963, which was funded on April 15, 2025 and is reflected as employer contributions receivable in the statement of net assets available for benefits as of December 31, 2024.

Participant Accounts

Each participant's account is credited with its respective contributions and its allocation of (a) employer contributions and (b) Plan earnings or losses. Allocations are based on participant earnings or losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' voluntary contributions, rollover contributions, and any earnings thereon vest immediately. Vesting in employer discretionary matching contributions and any earnings or losses thereon is based on the number of years of continuous service (as defined). Participants are 50% vested after one year of service and 100% vested after two years of continuous employment. In the event of death, disability, or attainment of age of 65, participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum or in installment payments. Further, withdrawals from the Plan before leaving the Company are available after attaining the age of 59 ½ or for special "hardship" reasons (as defined). Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended to thirty years. Further, loans will bear interest at the Wall Street Journal Prime Rate plus 1.00% and are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. Interest rates range from 4.25% to 9.50% as of December 31, 2024.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will be used to pay the Plan's administrative expenses as they occur. Any remaining forfeitures will serve to reduce future company contributions. At December 31, 2024 and 2023, the net forfeiture balance was \$118,377 and \$33,201, respectively. Total forfeiture earnings during the year ended December 31, 2024 were \$3,118. There were no forfeitures used to offset employer contributions during the year ended December 31, 2024. Forfeitures totaling \$7,330 were used to pay plan expenses during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Company or Plan participants, as provided for in the Plan document.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 8 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the Plan year or at the time of purchase during the Plan year. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Fair Value

Accounting standards provide a common definition of fair value and establish a framework to make the measurement of fair value in generally accepted accounting principles more consistent and comparable. Accounting standards also require expanded disclosures to provide information about the extent to which fair value is used to measure certain financial assets and liabilities, the methods and assumptions used to measure fair value, and the effect of fair value measures on earnings. The Plan's financial assets reflected in the financial statements at fair value include its investments (see Note 8).

Subsequent Events

The Plan has evaluated subsequent events through September 2, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified by The Plan's Trustee

The Company, acting in its capacity as the Plan Administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (the DOL) Rules and Regulations for Reporting and Disclosure under ERISA. The investment assets, notes receivable from participants, investment transactions and investment income presented in the Plan's financial statements and supplemental schedule was prepared by or derived from information prepared by Fidelity Management Trust Company (Fidelity), the trustee, and furnished to the Company. The Company has obtained certifications from the trustee as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a prototype plan, which has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, indicating that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes and represents that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Financial Accounting Standard Board has issued a standard regarding the accounting and recognition of income tax positions taken or expected to be taken by the Plan. The plan administrator assesses the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are mutual funds that are managed by Fidelity, which is the trustee for the Plan.

The Plan paid, \$112,532 of recordkeeping fees to Fidelity during the year ended December 31, 2024. Individually nonmaterial expenses paid to parties in interest aggregated \$7,280 during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all accounts will be valued on the termination date and account balances will be distributed in full to participants.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts that invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Fair Value Measurements

Accounting standards require that financial assets and liabilities, recognized or disclosed in financial statements on a recurring basis (at least annually), be measured at fair value. These standards define fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

These standards also establish a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

These standards describe three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities that are accessible at the measurement date.
- Level 2** Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in markets that are not active; or model-derived valuations or other inputs that are observable or can be corroborated by observable market data for the assets or liabilities.
- Level 3** Unobservable inputs for the asset or liability that are significant to the fair value measurement. These inputs reflect the Plan's assumptions about the assumptions a market participant would use in pricing the asset or liability.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when higher level inputs are not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in equity investments of publicly traded small cap companies based in the United States of America. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
