Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Bond, Schoeneck & King, PLLC Members' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the **Auditor's Responsibilities for the Audits of the Financial Statements** section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the **Auditor's Responsibilities for the Audits of the Financial Statements** section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit** section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the Bond, Schoeneck & King, PLLC (the "Firm") Members' Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a qualified defined contribution sharing plan under Section 401(a) of the Internal Revenue Code. Equity and non-equity members of the Firm are eligible to participate in the Plan upon reaching the age of twenty-one and completing one year of service. The Plan is subject to the provisions of ERISA.

Contributions - Members are automatically enrolled on the January 1 or July 1 that coincides with or next follows the date that eligibility requirements were met. The Firm's contributions are discretionary and subject to annual approval by a majority vote of the members. If the members vote in favor of contributions, non-equity members will also receive contributions for that respective year. If approved, employer contributions to the Plan for equity members are based on a formula that factors years of practice, age and membership units. Employer contributions for non-equity members are based on a percentage of compensation as defined in the plan document. Discretionary employer contributions totaled \$4,587,300 and \$4,386,448 for the years ended December 31, 2024 and 2023, respectively. The Firm had to make additional employer contributions in order to satisfy certain nondiscrimination tests for the year ended December 31, 2023, (see Note 6). There has never been and shall not be any deductible voluntary employee contributions to the Plan. Further, there shall be no rollover contributions, transfer contributions or employee voluntary after-tax contributions to the Plan.

Participant accounts - Individual accounts are maintained for each of the Plan's participants to reflect the employer's contribution, as discussed above, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations are based on account balances as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants can access their account information via Vanguard Fiduciary Trust Company's (Vanguard) website where they have the ability to change their investment options, as well as request distributions.

Vesting - Participants are considered fully vested in their employer contributions plus actual earnings thereon after three years of service.

Forfeitures - Any forfeitures for a plan year shall first be applied to reinstate any previously forfeited account balances for rehired members that did not exceed the five-year break in service provisions of the Plan. Any remaining forfeitures will be allocated to participant accounts proportionately to the employer contributions made for the plan year. There were no forfeited non-vested accounts available as of December 31, 2024. Forfeited non-vested accounts were insignificant as of December 31, 2023. Furthermore, there were no forfeitures allocated during the years ended December 31, 2024 or 2023.

Investment options - Upon enrollment in the Plan, participants may direct contributions in any of the investment portfolio options offered by the Plan. The Plan provides for investment options in certain investment securities containing a combination of registered investment companies and common collective trusts. Participants may change their investment options daily through online access, as discussed above.

Payment of benefits - Upon termination of service due to retirement, death, disability or other reasons, a participant (or participant's beneficiary in the event of death) shall receive a lump-sum distribution equal to the participant's account balance or annual installments over a period selected by the participant, which may not exceed the participant and designated beneficiary's life expectancy. A required minimum distribution is made to certain participants that meet the necessary age requirement as defined by current rules and regulations, unless the participant elects to defer.

Plan termination - Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, participants will become 100% vested in their accounts. Upon plan termination, all assets would be used to pay administrative expenses, liquidation expenses and participant claims until all fund assets have been expended. The Firm would not be entitled to receive any assets or other distributions upon termination of the Plan.

Note 2 - Summary of accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market risk. Market risks include domestic and global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Investment valuation and income recognition - Investments are stated at fair value (see Note 5) with the exception of common collective trusts, which are valued at net asset value as a practical expedient as reported by the sponsor of the trust; see below. All investment values have been determined and certified by Vanguard Fiduciary Trust Company, the Trustee of the Plan (see Note 3). Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The common collective trust, Vanguard Retirement Savings Trust III, is made up of various investment and security-backed contracts, which are mainly publicly traded securities. Common collective trusts (CCT) are valued at net asset value (NAV), which serves as a practical expedient to estimate its fair value. The NAV of each common collective trust is not publicly quoted in the active markets and is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the CCT will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of any CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner. There were no redemption restrictions or unfunded commitments as of December 31, 2024 or 2023. Investments measured at NAV per share used as a practical expedient are not required to be classified in the fair value hierarchy.

Economic dependency and concentration of credit risk - Approximately 40% and 41% of the Plan's investments were held and administered by Fidelity as of December 31, 2024 and 2023, respectively. Approximately 25% and 30% of the Plan's investments were held and administered by The Vanguard Group, Inc (VGI) as of December 31, 2024 and 2023, respectively. Approximately 17% and 21% of the Plan's investments were held and administered by Vanguard as of December 31, 2024 and 2023, respectively. Accordingly, the Plan is dependent upon the financial condition of these companies.

Administrative expenses - Administrative costs, including legal and accounting costs, are the obligation of the Plan; however, the Firm may pay for such expenses or reimburse the Plan for payment of these expenses. Costs of managing the investments and of maintaining participant accounts are paid directly out of the plan assets (see Note 4).

Payment of benefits - Benefits are recorded when paid.

Subsequent events - Management has evaluated subsequent events through September 23, 2025, the date that the financial statements were available for issue.

Note 3 - Information certified by the Trustee of the Plan

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the Trustee of the Plan. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 - Related party transactions

The Plan's investments are managed by VGI who, in addition, provides certain recordkeeping services. These services, which are for paid by the Plan, qualify as party-in-interest transactions and are recorded as administrative expenses on the accompanying statements of changes in net assets available for benefits. Fees for services paid to VGI were \$49,002 and \$47,500 for the years ended December 31, 2024 and 2023, respectively. The Plan contracts with Dannible & McKee, LLP to provide auditing services, which qualifies as party-in-interest transactions. Fees for these services were paid for by the Firm for the years ended December 31, 2024 and 2023.

Note 5 - Fair value measurements

The Financial Accounting Standards Board's (FASB) authoritative guidance on fair value measurements provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Registered Investment Companies, (i.e., Mutual Funds) - Valued at the closing price reported on the active market on which the individual security is traded (Level 1).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Note 6 - Tax status of the Plan

The Internal Revenue Service has determined and informed the Firm that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the “Code”). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan’s trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Accordingly, the Plan has been accounted for as a tax-exempt plan.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and/or interest for the years ended December 31, 2024 and 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed tax years before 2021.

The Plan is in the process of completing certain required nondiscrimination testing for the year ended December 31, 2024, results of which have not yet been determined. However, management believes the results from this testing will have an immaterial impact on the Plan’s financial statements. The Plan completed certain required nondiscrimination testing for the year ended December 31, 2023, which resulted in additional employer contributions needed for certain impacted participants in order to pass certain tests. The additional employer contributions needed amounted to \$5,406 for the year ended December 31, 2023, which is included in employer contributions receivable as of December 31, 2023, which was received in 2024.

Note 7 - Reconciliation of the financial statements to Form 5500

The Form 5500 has certain investment balances, income and expense items that differ from amounts shown on the accompanying financial statements. These differences relate to classification and rounding only and have no effect on the net assets available for benefits as of December 31, 2024 and 2023, nor changes in net assets available for benefits for the years then ended.
