INDEPENDENT AUDITORS' REPORT

**To the Trustees of
the Bernstein Litowitz Berger & Grossmann LLP Profit Sharing Plan:**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bernstein Litowitz Berger & Grossmann LLP Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - PLAN DESCRIPTION

The following description of the Bernstein Litowitz Berger & Grossmann LLP Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees and partners of Bernstein Litowitz Berger & Grossmann LLP (the “Firm”). All employees and partners are eligible to participate in the Plan except for associates and employees deemed short term hired for specific cases. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Trustees are responsible for oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

Contributions

Participants are eligible for profit-sharing contributions on the date they have completed their first hour of service as an eligible employee. Profit-sharing contributions are provided at the Firm’s discretion and are allocated to eligible participants if the participant completed at least one hour of service during the plan year. There was no profit-sharing contribution for the year ended December 31, 2024.

Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants direct the investment of contributions credited to their accounts into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with allocations of the Firm’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - PLAN DESCRIPTION (CONTINUED)

Vesting

Participants are 100 percent vested in the Firm's profit sharing contributions after one year of credited service. If a participant attains normal retirement age while an employee, the participant becomes fully vested.

Payments of Benefits

Normal retirement age is 62. When a participant terminates employment or ceases to be an employee due to disability, they are entitled to receive his or her distribution under the Plan in a lump sum as soon as administratively feasible. A retired participant can elect to defer receipt of the distribution until April 1 of the calendar year following the participant attaining age 73. Upon death of the participant the distribution will be made in a lump sum no later than December 31 of the calendar year containing the fifth anniversary of the death unless elected differently by the beneficiary. Upon termination, if the participant's vested account is less than \$1,000 the distribution shall be made in the form of a lump sum payment, and if the vested balance is between \$1,000 and \$5,000, the distribution shall be made as a rollover to an individual retirement arrangement ("IRA") account. Under certain circumstances (hardship), and with approval of the Firm, a participant can elect at any time to receive a portion of his or her vested account balance subject to the provisions of the Plan. In-service withdrawals are permitted once a participant has attained age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$72 and \$11,572, respectively. These amounts will be used to reduce future employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is valued at contract value as described in Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit Responsive Investment Contract

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits presents the investment contract at contract value. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The statement of changes in net assets available for benefits is prepared on a contract value basis.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York (“Empower”), qualified institutions.

NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan also utilizes a practical expedient to estimate the fair value of investments that have calculated net asset value (“NAV”) per share. Accordingly, the Plan estimates the fair value of an investment using the NAV of the investment (or its equivalent) without further adjustment unless the Plan determines that the NAV is deemed to be not reflective of fair value.

The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan's investments have been classified, the Plan has assessed factors including, but not limited to price transparency, the ability to redeem at NAV at the year-end and the existence or absence of certain restrictions at year-end.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued based on the NAV of the collective trusts. The NAV, as provided by the custodian is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV.

The collective trust funds' investment objectives are to invest in underlying funds to achieve the highest total return over time and diversify its investment asset mix based on the specific year of retirement included in its name. There are no unfunded commitments with respect to the collective trust funds. The funds generally provide for daily redemptions by the Plan at reported NAV per share, without any advance notification. The funds may, in their sole discretion, impose restrictions on issues and redemptions of units.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023, excluding investments in collective trust funds. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The GIF (“Guaranteed Investment Fund”) is a group annuity contract issued by Empower. The Plan holds a traditional investment contract. The GIF is a fully benefit-responsive investment contract. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal to the Plan unless terminated under certain conditions by the Plan.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The minimum crediting rate under the contract may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

As a result of current stable value product construction, no adjustments are required to mediate between the average earnings credit to the Plan and the average earnings credited to the participants.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)

Empower believes there are no events that could limit the ability of the Plan to transact at contract value paid within 75 days or in rare circumstances, contract value paid over time.

There are no events that allow the issuer to terminate the contract, and which require the Plan to settle at an amount different than contract value paid either within 75 days or over time. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Firm has an agreement with Fiduciary Administrators, LLC under which it has assigned it as the Designated Plan Administrator. Under this agreement, ERISA 3(16) fiduciary services have been delegated. Fiduciary Administrators, LLC is the Plan administrator for the Plan and therefore, is a related party and these transactions qualify as party-in-interest transactions.

During 2024 and 2023, Associated Pension Consultants, Inc. (“Associated Pension”) (an affiliate of Fiduciary Administrators, LLC) provided certain third-party administration services to the Plan. Associated Pension is the recordkeeper for the Plan and is related to the Plan Administrator, therefore, these transactions qualify as party-in-interest transactions.

A Guaranteed Investment Fund account held at Empower Life & Annuity Insurance Company of New York includes unallocated accounts including funds earned by the Plan from the recordkeeper based on a percentage of the participant account balances to be utilized against future Plan expenses and are maintained in an account managed by the trustee/custodian. Accordingly, these transactions qualify as party-in-interest transactions.

NOTE 7- PLAN TERMINATION

Although it has not expressed an intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and terms of the Plan. In the event of Plan termination or partial termination of the Plan, participants’ accounts shall be fully vested as of the date of such termination. The Firm determines the date and manner in which participants’ accounts will be distributed in accordance with ERISA.

NOTE 8 - TAX STATUS

The Firm has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
