INDEPENDENT AUDITORS' REPORT

To the Trustee and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Arena Sports, Inc. 401(K) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of February 18, 2025 and December 31, 2024, and the related statements of changes in net assets available for benefits for the period ended February 18, 2025 and the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Arena Sports, Inc. 401(K) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 18, 2025 and December 31, 2024, and for the period ended February 18, 2025 and the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTE A.--DESCRIPTION OF PLAN

The following description of the Arena Sports, Inc. (Company or Plan Sponsor) 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution 401(k) and profit sharing plan originally established by the Company effective January 1, 2006, and amended and restated January 1, 2021 as part of the required Cycle 3 restatement and additionally amended effective December 31, 2022 to adopt the Secure and Cares Act provisions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee was any person employed by the Company, and participating employer - Lil'Kicker Inc., excluding employees covered by a collective bargaining agreement, non-resident aliens, and leased employees. An employee became eligible to participate in the plan after reaching age 21 and after completing one year of service. Participants receive credit for one year of service in which they completed 1,000 hours of service. The entry date was the first day of each month following completion of eligibility requirements.

Plan Transfer: Effective December 20, 2024, the Company elected to transfer the Plan's assets to a Pooled Employer Plan (PEP). All Plan assets were transferred February 18, 2025. See Note G for further details regarding the Plan transfer.

Contributions: The Plan was funded by eligible participant elective deferrals up to the max allowed by law, discretionary employer contributions, and safe harbor matching contributions. The Plan automatically enrolled participants at a 3% deferral rate.

Discretionary employer contributions were allocated to participants in his or her own allocation group. To receive the discretionary contribution, participants must have been employed on the last day of the Plan year and completed 1,000 hours of service during the year, unless the participant died, became disabled or reached the normal retirement age. There were no employer discretionary contributions in 2025 or 2024.

The safe harbor employer match was the sum of 100% of the participant's compensation which is deferred as an elective deferral that does not exceed 3% of the participant's compensation, plus 50% of the participant's compensation which is deferred as an elective deferral that exceeds 3% of the participant's compensation but does not exceed 5% of the participant's compensation. The safe harbor match was paid per payroll period and true-up was made as needed on an annual basis. See Note I.

Contributions (Continued): Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Also, all participants who were eligible to make elective deferral contributions may have elected to designate all or any portion of their deferrals as Roth elective deferral contributions. Participants may have also contributed amounts representing distributions from other qualified retirement plans. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account was credited with the participant's contribution, allocation of any Company contributions, an allocation of plan earnings (losses), and charged with an allocation of certain administrative expenses. Allocations were based on participant compensation, account balances or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant was entitled is the benefit that could have been provided from the vested portion of the participant's account.

Vesting: Participants were immediately vested in their rollover contributions, elective deferrals, and safe harbor matching contributions plus actual earnings thereon. Vesting in any Company discretionary contributions was based on years with continuous service. A participant is 20% vested after 2 years of credited service, 40% after 3 years, 60% after 4 years, 80% after 5 years, with full vesting at six years. Participants also became fully vested upon death or disability.

Retirement: The normal retirement date was the date the participant turns 65. There was no early retirement.

Payment of Benefits: On termination of service due to disability or retirement, a participant may have elected to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over their lifetime. Upon death of a participant, payments made to a beneficiary were payable in a lump sum or other form as selected by the beneficiary.

For termination of service due to other reasons, a participant may have received the value of the vested interest in his or her account as a lump-sum distribution, annual installments over their lifetime or may have continued to participate in the plan investments and benefits were to be provided upon retirement or death. For terminated participants, if the balance of the vested accounts was \$5,000 or less, excluding rollover contributions, payment could have been made in a lump-sum without the participant's consent. Without other election, such balance was automatically rolled over to an IRA established by the Company. Hardship distributions were not allowed. Distributions could have been taken from rollover contributions at any time. In-service distributions at age 59 ½ and qualified reservist distributions were allowed in accordance with plan provisions.

Investment Options: Participants were allowed to direct their contributions and account balances in a variety of investment options which included mutual funds. The Plan Sponsor periodically reviewed the investment options available to participants and changed them as warranted. Participants could have changed their investments at any time.

Plan Expenses: Expenses of maintaining the Plan may have been paid by the Company or the Plan. Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Certain fees such as for distributions were charged directly to the participant's account and were included in administrative expenses. Investment related expenses, including 12b-1 fees, were deducted from each funds' earnings and were included in net appreciation (depreciation) in fair value of investments.

Notes Receivable from Participants: Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant's account. Under the terms of the Plan agreement, plan loans must have had a rate of interest similar to local commercial banks for similar loans. All loans were to be repaid within a period of five years, unless the loan was used to purchase a principal residence, in which case, the loan must have been repaid within ten years. Only one outstanding loan was permitted per participant. Principal and interest were paid through payroll deductions.

Forfeitures: Forfeitures are the non-vested portion of a participant's account that were lost upon termination of employment. Forfeitures were used at the Company's discretion to reduce future Company contributions or to pay plan administrative expenses. As of February 18, 2025 and December 31, 2024, forfeited non-vested accounts totaled \$0 and \$2,254, respectively. In 2025 and 2024, \$2,254 and \$2,929 of expenses were paid from forfeited non-vested accounts, respectively.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determined the Plan's valuation utilizing information provided by investment advisors and the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis.

Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and expensed when they were incurred. Delinquent notes receivable from participants were recorded as benefit payments based upon the terms of the Plan document. No allowance for credit losses was recorded as of February 18, 2025 or December 31, 2024.

Payment of Benefits: Benefits were recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at February 18, 2025 and December 31, 2024, and net appreciation (depreciation) in fair value of investments, dividend income, and interest income on notes receivable from participants, for the period ended February 18, 2025 and for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (January 1, 2024 – June 30, 2024) and TransAmerica Trust Company (July 1, 2024 – February 18, 2025), the custodians of the plan.

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There had been no changes in the methodologies used at February 18, 2025 and December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

NOTE E.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were in funds managed by the custodian, Reliance Trust Company (January 1, 2024 – June 30, 2024) and TransAmerica Trust Company (July 1, 2024 – February 18, 2025); therefore, these transactions qualified as party-in-interest transactions. Certain administrative functions of the Plan were performed by officers or employees of the Company. Certain officers served as trustees of the Plan. No such officer or employee received compensation from the Plan.

NOTE F.--TAX STATUS

The Plan was amended and restated effective January 1, 2021 and adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan had been amended since the date of this determination letter. However, the plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes had been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The Plan administrator analyzed the tax positions taken by the Plan and concluded that as of February 18, 2025 and December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G.--PLAN TRANSFER AND BLACKOUT PERIOD

As described in Note A, the Company elected to transfer all Plan assets to a Pooled Employer Plan. Effective February 11, 2025, the Plan implemented a blackout period. During this period, all investments, transfer of assets among investment options, initiation of loans or distribution requests were ceased.

As of February 18, 2025, all Plan assets were transferred out of the Plan and into the Arena Sports, Inc., AE of The Standard Pooled Employer Plan.

NOTE H.--RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could have occurred and that such changes could have materially affected participants' account balances and the amounts reported in the financial statements.

NOTE I.--TRUE-UP OF EMPLOYER MATCH

As part of the normal course of plan operations, an annual true-up must be calculated on the safe harbor match contributions made throughout the year. As a result of the true-up assessment at December 31, 2024, total additional safe harbor contributions of \$7,578 were deposited to participant accounts subsequent to year end and is included in employer contributions receivable as of December 31, 2024 in the accompanying statement of net assets available for benefits.

NOTE J.--SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.
