Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Haldex Brake Products Corporation 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Haldex Brake Products Corporation 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Haldex Brake Products Corporation (the “Company”), subsidiary of SAF-Holland effective March 3, 2023, who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established April 1, 1987.

Delaware Charter Guarantee & Trust Company (dba Principal Trust Company) serves as the custodian for mutual fund investments. Principal Life Insurance Company (“Principal”) serves as the recordkeeper for the Plan and custodian of all investments other than mutual funds. Employees of the Company serve as trustees.

Eligibility – An employee is eligible to participate in the Plan after completing three months of service. Entry dates for employee and employer contributions are the first day of the quarter following eligibility. The Plan excludes leased and union employees.

Contributions – Participants may elect to contribute up to 50% of their annual compensation subject to certain Internal Revenue Code (“IRC”) limitations as pre-tax contributions or after-tax Roth contributions. Upon reaching the eligibility conditions, a participant will automatically be enrolled in the Plan to defer 6% of compensation, unless another amount is elected in writing.

Additionally, for those employees who are automatically enrolled in the Plan, each participant’s deferral amount will automatically increase by 1% each July 1, up to a maximum amount of 10%, unless the participant elects in writing some other deferral amount. A participant must elect a whole percentage to defer to the Plan. Fixed dollar contributions are not permitted.

The Company makes a safe-harbor matching contribution, dollar-for-dollar, up to 5% of eligible compensation. These contributions are calculated and paid into the Plan every payroll.

The Plan also allows the Company to make discretionary contributions which are allocated to participants’ accounts based on their pro rata portion of total compensation. Participants must be active in the Plan at some time during the year and have at least 1,000 hours of service to be eligible for the discretionary contribution. There were no discretionary contributions in 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, matching contribution by the Company, an allocation of the Plan’s earnings, and a pro rata charge for administrative expenses. Earnings are allocated daily based on participant account balances.

Investment Options – Participants direct contributions to a variety of mutual funds, common collective trusts, a guaranteed investment contract, and pooled separate accounts.

Vesting – Participants are immediately vested in their contributions and Company contributions at all times.

Payment of Benefits – Upon termination of service, the participant may receive a lump-sum distribution equal to the value of the account, roll over the balance to another plan, or have Principal continue to administer their account as a personal retirement account. Upon retirement or death, the participant may elect to roll over the balance to another plan, receive a lump-sum distribution or purchase an annuity sold by Principal (for which the Company is no longer responsible). For distributions greater than \$1,000 but not exceeding \$7,000, the account balance will be distributed to the participant or rolled over into an individual retirement account, unless otherwise directed by the participant.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment.

- Hardship withdrawals are available to the Plan participants for reasons as defined in the Plan Document and permitted by the IRC.
- Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

CARES Act – In March 2020, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was enacted to provide expanded access to retirement plan accounts during the COVID-19 pandemic. The CARES Act contained several provisions that temporarily impacted 401(k) plans, such as, the waiver of required minimum distributions, a new COVID-19-related hardship withdrawal option, increased loan limits, and a loan repayment deferral option. The Company incorporated these provisions into the Plan. These temporary CARES Act provisions expired at the end of 2020. The Plan will be amended to reflect these changes prior to the December 31, 2026, deadline.

Notes Receivable from Participants – Participants may borrow a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years, except if the loan is to acquire the participant’s principal residence, which has a maximum of 10 years. Interest rates are determined based on the rates available for similar loans from commercial lending institutions, and are set by Principal. A participant’s loan is repaid via payroll deductions. Participants who initiate a loan are charged a \$50 loan initiation fee, and also charged a loan maintenance fee of \$12 each quarter that the loan is outstanding.

Upon termination of service, the balance of any outstanding loan becomes due and the participant’s vested account balance will be used as a taxable distribution to pay the outstanding loan unless the participant repays the loan with interest within 60 days from the date of termination.

Administrative Expenses – The Company or the Plan may pay expenses of the Plan. During 2024, the Plan paid \$102,538 in expenses related to loan fees, early withdrawal fees, distribution fees, and other administrative expenses.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The investment contract held by the Plan is not considered fully-benefit responsive and, as such, is presented at fair value.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is accrued when earned.

Management fees and operating expenses charged to the Plan for the investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Payment of Benefits – Benefit payments are reported in the year paid.

Other Income – During 2024, the Plan received approximately \$8,300 in revenue sharing payments included in other income, which are used to reduce plan expenses.

Date of Management's Review – Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts and Common Collective Trust – Principal calculates a unit value (similar to a net asset value, “NAV”) of a separate account or collective trust. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any. The NAV is available to current investors via the Principal employer website, or when Plan participants access their account values. The NAV is the basis for current transactions and these investments can be redeemed at NAV as of the measurement date. Therefore, management believes that these investments have a readily determinable fair value. The majority of the underlying securities held in these investments have observable Level 1 inputs. There are no unfunded commitments for these investments, they are valued daily, and there are no redemption restrictions.

Mutual Funds – Valued at the closing price reported on the active market on which the individual securities are traded.

Guaranteed Interest Accounts – Valued at the sum of the estimated fair values of each contract of the guaranteed investment contract fund because they are not fully benefit responsive. Fair value represents the amount plan participants or plan sponsors would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Management assesses the reasonableness of the methodology by reviewing a variety of factors including review of existing contracts, the fund investment profile and financial strength ratios, economic conditions, industry and market developments, and overall credit ratings.

4. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides the Guaranteed Interest Account, a group annuity contract by Principal, as an investment option for participants. The objective of this investment option is to guarantee the return of principal plus compound interest earned over a defined term backed by Principal. There are no specific securities in the general account that back the liabilities of this group annuity contract. Principal is obligated to pay interest at crediting rates, which are announced in advance and guaranteed per the terms of the contract. The investment contract is not considered fully-benefit responsive and, as such, is included in the financial statements at fair value. Fair value is calculated using the Market Value Adjustment formula specified in the group annuity contract and is based on the composite interest rates and new money crediting rates. There are no reserves against fair value for credit risk of the contract issuer or otherwise.

5. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

6. INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- All components of income and net appreciation on fair value of investments (excludes interest on notes receivable from participants)
- Schedule of Assets (Held at End of Year) (excludes notes receivable from participants)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of pooled separate accounts, common and collective funds and guaranteed interest accounts managed by Principal Life Insurance Company and Principal Trust Company. Principal Life Insurance Company and Principal Trust Company are the custodians of the Plan, and therefore, these transactions qualify as party-in-interest. Additionally, the Plan pays certain fees to the custodians associated with operating the Plan.

Notes receivable from participants are party-in-interest.

8. TAX STATUS

The Plan has adopted a prototype non-standardized profit-sharing plan with CODA, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. SUBSEQUENT EVENT

Effective September 1, 2025, SAF-Holland, Inc. 401(k) Savings Plan merged into the Haldex Brake Products Corporation 401(k) Savings Plan. The Plan was renamed to the SAF-Holland, Inc. 401(k) Savings Plan.
