Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Genesis Medical Group 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1. Description of the Plan

General

The following description of the Genesis Medical Group 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants are encouraged to refer to the Plan Document for a more complete description of the Plan's provisions. The Plan is sponsored by Genesis Medical Group (Plan Sponsor). Northwest Diagnostic Clinic IPA, LLC, David P. Ellent, PLLC, and Genesis Medical Group Management (collectively, the Company) are participating employers.

Eligibility

The Plan is a defined contribution plan covering substantially all employees of the Company, other than union employees and non-resident aliens, who have completed one year of service and attained the minimum age requirement of 21. A year of service will have been completed at the end of the first twelve consecutive months of employment with at least 1,000 hours of service. The Plan is subject to the provision of the Employment Retirement and Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may make an elective deferral, for each plan year, an amount equal to the maximum percentage allowable under law of pretax annual compensation, as defined in the Plan. Participants may make a special election to defer up to 100% of any bonus. Participants may also contribute amounts representing distributions from other qualified retirement defined benefit or defined contribution plans. During any calendar year ending or after the participant obtains the age of 50, participants may make catch-up contributions exceeding the annual elective deferral limit. These additional amounts are subject to an annual limit imposed by law. The Company is required to make a non-elective safe harbor matching contribution to the Plan for each eligible participant, equal to 100% of the first 3% of base compensation and 50% of each participant's elective deferrals in excess of 3% but not in excess of 5% of the participant's compensation. For the year ended December 31, 2024, the Company contributed safe harbor matching contributions of \$331,962.

At the sole discretion of the Company's Board of Directors, additional non-safe harbor matching contributions and profit-sharing amounts may be contributed to the Plan. For the year ended December 31, 2024, the Company made no profit-sharing or additional non-safe harbor matching contributions.

Participant Accounts

Separate accounts are maintained for each participant. Participant accounts are credited with participant contributions, rollover contributions, allocations of company contributions and investment earnings and losses, and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

Note 1. Description of the Plan (Continued)

Investment Options

Upon enrollment in the Plan, participants may direct the investment of their individual accounts among investment options provided under the Plan. Participants may change their investment elections at any time, as well as transfer existing balances between investment funds. The Plan also allows participants to invest deferred amounts in self-directed accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Participants may only have one outstanding note receivable at a time. The note is secured by the balance in the participant's account and bears a reasonable rate of interest as determined by the Plan, based on reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions.

Benefits Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A participant may also elect to receive a pre-retirement distribution from their fully vested accounts once they attain the age of 50. For termination of service due to other reasons, a participant with an account balance exceeding \$5,000 may elect to receive the value of the vested interest in his or her account as a lump sum distribution. Vested account balances of \$5,000 or less are distributed to participants as a lump sum distribution without the participant's consent. Hardship withdrawals are permitted from participant deferrals and rollovers, within limitations and conditions as defined by the Plan.

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions, plus actual earnings on the contributions. Vesting in the Company's discretionary contributions is based on years of continuous service on a 6-year graded schedule.

Forfeited Accounts

Forfeited non-vested accounts are available to be used to reduce employer contributions and/or to pay plan expenses. For the year ended December 31, 2024 the Plan used \$760 of forfeitures to reduce employer contributions. Forfeited non-vested accounts totaled \$6,010 and \$12,152 at December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment contracts held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Contributions

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain fees for services charged by the trustees may be directly charged to a participant. Investment management and advisory fees are charged to the Plan. Other administrative costs of the Plan charged by the trustees are generally paid by the Company.

Risks and Uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Tax Status

The Plan adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider received on June 30, 2020 an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America provide accounting and disclosure guidance about positions taken by a plan in its tax returns that might be uncertain. The Plan Administrator believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination or partial plan termination, participants would become 100% vested in their accounts.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

- Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2 Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Accounts: Primarily consists of interest and non-interest bearing cash, corporate stocks, and mutual funds that are all valued on the basis of readily determinable market prices.

Note 5. Fully Benefit-Responsive Investment Contract

The Plan holds an investment in a general account offered through a group annuity contract that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The group annuity contract held by the Plan is a guaranteed investment contract of which contributions are maintained in a general account. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
2. Premature termination of contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on completing investment options; and
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures, or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and
4. A material amendment to the agreements without the consent of the issuer.

Readers of the financial statements should refer to the specific contract terms for limitations. Management does not believe that any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6. Related-Party and Party-in-Interest Transactions

Certain plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustees, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 7. Subsequent Events

The Plan Administrator has evaluated subsequent events through the date that the financial statements were available to be issued, July 6, 2025, and determined that no events occurred that require disclosure. No events occurring after this date have been evaluated for inclusion in these financial statements.
