### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the ZMC Hotels, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

### 1. Description of Plan

The ZMC Hotels, LLC 401(k) Plan (the Plan) was established by ZMC Hotels, LLC (the Company) to provide participants with a method to fund their retirement on a tax-deferred basis. The Plan provides retirement benefits to eligible employees of the Company and unrelated employers consisting of Modology LLC, Hall Equities Group, and COPA Innovation Laboratories, LLC (collectively, the Employers). As a result of participating unrelated employers, the Plan is designated as a multiple employer plan. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees and an Investment Committee, responsible for selecting investment options under the Plan and monitoring performance. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and record keeper. Fidelity holds, invests, and reinvests trust assets in the interest and at the direction of participants and their beneficiaries.

#### *Eligible Participants:*

Eligible employees, as defined by the Plan agreement, aged 21 or older, may participate in the Plan after six months of service.

#### *Contributions:*

Participants may make contributions to the Plan through pre-tax or Roth post-tax salary reduction up to 90% of annual eligible compensation, as defined by the Plan agreement, subject to certain limitations under the Code. Participants who have reached the age of 50 may elect to withhold additional catch-up contributions under the Code. Participants may also contribute after-tax contributions and amounts representing distributions from other qualified plans (rollovers), subject to Code regulations.

The Employers may make discretionary matching and non-elective contributions to the Plan. No Employer matching or non-elective contributions were made to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

## ZMC Hotels, LLC 401(k) Plan Notes to Financial Statements

---

### 1. Description of Plan (continued)

#### *In-Plan Roth Conversions:*

The Plan allows participants who are active employees of the Company to convert any portion of their account to Roth balances. There were no conversions to Roth balances in 2024.

#### *Participant Accounts:*

Participant accounts are credited with participant contributions and rollovers, and an allocation of Employer contributions, if any, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment fund options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

#### *Vesting and Forfeitures:*

Participants are immediately vested in their salary deferral, after-tax and rollover contributions, plus earnings (less any losses) thereon. Vesting in any Employer matching and non-elective contributions, if any, plus allocated earnings (less any losses) thereon, is based on continuous years of service. Participants become 20% vested in Employer matching and non-elective contributions after one year of service and are fully vested after five years, or upon retirement, disability, or death.

Forfeited non-vested accounts may be used to reduce Plan expenses and then to reduce Employer contributions. As of December 31, 2024 and 2023, there was no balance in forfeited non-vested accounts as there have been no Employer contributions to the Plan.

#### *Notes Receivable from Participants:*

Participants may borrow up to one-half of their vested account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which longer terms may be granted. The notes are evidenced by a written note, secured by the balance in the participant accounts, and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator, under the Plan's note policy. Participants may only have one note outstanding at any time. Interest rates on notes outstanding at December 31, 2024 range from 5.25% to 10.50%. Repayment of principal and interest is generally made through payroll deductions.

#### 1. Description of Plan (continued)

##### *Notes Receivable from Participants: (continued)*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

##### *Liability for Corrective Distributions:*

The liability for corrective distributions represents contributions made by certain participants that must be refunded for the Plan to comply with applicable non-discrimination tests. The December 31, 2024 liability of \$36,813 was refunded in 2025 (the December 31, 2023 liability of \$30,925 was refunded in 2024).

##### *Payment of Benefits:*

Upon termination of service, participants may elect to leave their account balances in the Plan or receive their total benefits in a lump sum amount equal to the value of the participant accounts. Terminated participant accounts with balances below a certain threshold may be automatically distributed to Individual Retirement Accounts on behalf of participants without participant approval, or may be distributed directly to participants without participant consent. The Plan agreement also allows for certain in-service and hardship withdrawals of benefits to current employees. Benefits are recorded when paid.

##### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Participant accounts are assessed a separate fee for the administration of notes receivable and certain third-party administration fees. All other expenses to administer the Plan are paid by the Employers and are not reflected in the Plan's financial statements.

##### *Risks and Uncertainties:*

The Plan offers a variety of investment options to participants. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the financial statements.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will remain fully vested in their accounts and distributions will be made to participants as described in the Plan agreement.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The Plan prepares its financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investments:*

The Plan's investments consist of mutual funds and a money market fund. These funds are reported at the net asset value of shares held by the Plan at year end, as quoted in active markets.

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with investing in those financial instruments.

#### *Fair Value Measurement:* (continued)

The three-level hierarchy for fair value measurement is defined as follows:

- *Level I:* Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- *Level II:* Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- *Level III:* Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's investments are recorded at fair value and classified as Level I within the fair value hierarchy as of December 31, 2024 and 2023.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

#### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 4. Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-In-Interest Transactions

Certain of the Plan’s investments are offered by Fidelity, the Plan’s trustee. Purchases and sales of these investments qualify as party-in-interest transactions. Notes receivable transactions with participants also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules under ERISA.

7. Subsequent Events

Effective January 1, 2025, the Plan agreement was amended to include an automatic enrollment provision for eligible employees. Eligible employees, when hired or rehired, will be automatically enrolled with deferrals at 3% of their eligible pre-tax compensation. The deferral rate will automatically escalate by 1% every year on December 26<sup>th</sup> up to a maximum of 10%.

An additional participating employer (Enterprise Restaurant Group LLC) was also added to the Plan effective January 1, 2025.

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
