Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of South Shore Health Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of South Shore Health Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of South Shore Health Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audits evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about South Shore Health Retirement Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE 1 DESCRIPTION OF PLAN

The following description of the South Shore Health Retirement Savings Plan (the Plan) (previously known as South Shore Hospital Retirement Savings Plan) provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) tax deferred annuity plan covering substantially all employees of South Shore Hospital, Inc. (the Hospital). The Plan was established on January 1, 2007 and is subject to the provisions of ERISA.

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation for pretax deferrals, and 90% of post-tax annual income for Roth deferrals, as defined by the Plan. All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect otherwise. Automatically enrolled participants have their deferral rate set at 3% of compensation and their contributions are invested in a designated fund until changed by the participant. The Hospital currently makes an employer matching contribution of 50% of the first 6% of the participant's salary deferral contributions up to a maximum of 3% of compensation. The Hospital also makes an additional nonelective contribution to employees completing 1,000 hours of service during the Plan year and employed on the last day of the Plan year. The nonelective contribution credited is based on a scale of 2% to 3% for the year ended December 31, 2024 of covered pay, based on the employee's age and years of service. The Hospital contribution is invested into the individual's directed investments.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Hospital's matching and nonelective contributions and Plan earnings. Allocations are based on participant earnings or account balances as defined. Allocations of matching and nonelective contributions are based on participant's compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan, which are held at State Street Bank and Trust Company (State Street) and Transamerica Retirement Solutions. These funds include a variety of mutual funds, insurance investment contracts and a cash reserve account as investment options for participants.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions and matching contributions plus actual earnings thereon. Vesting in the nonelective contribution is based on years of credited service. A participant is 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are evidenced by notes and terms may not exceed five years unless the loan is used to acquire a participant's principal residence, which may be offered over a term up to ten years. A participant is allowed two loans at a time. The loans bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions while employed and by coupon when no longer employed.

Payment of Benefits

Withdrawals may be made from the participant's account at retirement, death, disability, or termination of employment in the form of a lump sum distribution or installments. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the account balance may be paid in a lump sum to the participant without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions.

Forfeitures

Forfeitures represent the nonvested portion of terminated participants' account balances. The Plan utilized forfeitures totaling \$344,343 and \$189,796 for the years ended December 31, 2024 and 2023, respectively, to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$76,284 and \$169,914, respectively. These accounts will be utilized to reduce future Hospital contributions and/or Plan expenses.

Administrative Expenses

Investment management fees are paid out of Plan assets and are funded by participant accounts based on their individual asset balances. The Hospital has elected to pay all other administrative expenses of the Plan in excess of expenses covered by the revenue sharing agreement (see Note 2).

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution retirement plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as defined under accounting standards (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's pension committee determines the Plan's valuation policies and procedures utilizing information provided by investment advisers and Transamerica Financial Life Insurance Company, Inc. (TFLIC). See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Other Income

Other income represents income received from revenue sharing arrangements with TFLIC, the custodian of the Plan. Revenue credits are credits received from TFLIC which represent revenue generated by the Plan that is returned to the Plan by TFLIC. These funds may be used to pay reasonable and necessary expenses for the Plan and can also be used to provide plan servicing credits to participants. During the years ended December 31, 2024 and 2023, the Plan received \$153,096 and \$91,700, respectively, in revenue credits. During the years ended December 31, 2024 and 2023, \$-0- and \$71,865, respectively, was used to pay Plan expenses. The remaining balance of \$387,055 at December 31, 2024 will be used to pay for future administrative expenses or allocated to participants. Other income is presented net of expenses on the Form 5500.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported on the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements.

Subsequent Events

Management has evaluated subsequent events through September 2, 2025, the date that the financial statements were available to be issued.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE AND CUSTODIAN

Information presented in the accompanying statements and schedule as of and for the years ended December 31, 2024 and 2023 for investments, notes receivable from participants, investment income, and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by State Street, the trustee of the Plan, and TFLIC, the custodian of the Plan, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENT

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Money Market and Mutual Funds: Valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year-end.

Insurance Company General Account: Valued using Level 1 inputs, which consist of the quoted cash balance held by the Plan at year-end.

There have been no changes in the methodologies used at December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Hospital has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account.

NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Some plan investments are issued by TFLIC, which is an affiliated entity to Transamerica Retirement Solutions, the Plan's recordkeeper. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management, administration, advisory and audit services totaled \$738,393 and \$605,363 for the years ended December 31, 2024 and 2023, respectively.

The Plan issues loans to participants that are secured by the balances in the participants' accounts. Participant loans are also party-in-interest transactions. Certain employees of the Hospital who participate in the Plan perform administrative services to the Plan at no cost to the Plan.

NOTE 8 INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2016, the Plan entered into a fully benefit-responsive group annuity contract with New York Life Insurance Company (NYL), referred to as the Guaranteed Interest Account (GIA). The contract is designed to be an investment contract. The group annuity contract provides for a book value record of the amounts deposited to and withdrawn from the GIA. That is, the GIA is at all times equal to the contributions made to the contract plus interest credited, plus dividends, if any, minus expenses withdrawn and minus withdrawals made.

Contributions to the GIA are currently invested in a broadly diversified fixed income portfolio within NYL's general account. Fixed income investments in the general account are managed by New York Life Investment's Fixed Income Investors Group. The investments in the general account are intended to provide a competitive crediting rate and limited volatility consistent with preservation of capital. The NYL general account is invested primarily in a conservative array of securities and cash-equivalent investments in accordance with the investment restrictions of New York Insurance Law.

Because the GIA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The GIA is presented on the face of the statement of net assets available for benefits at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was \$16,374,890 and \$20,086,800, respectively.

NOTE 8 INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

Certain events limit the ability of the Plan to transact at contract value with NYL. Such events include the following: 1) mergers, 2) layoffs, 3) full or partial plan termination, or 4) early retirement incentive. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. In addition, NYL may terminate the contract by giving written notice if 1) an alternate funding vehicle becomes available to plan participants as a separate investment option that participants can directly elect in lieu of this contract, or 2) if the Plan fails to maintain its tax-exempt status.

The declared crediting interest rate is determined by NYL twice each calendar year, but it will always fall within a range between 1.0% and 3.0%. The declared crediting rate for NYL was 3% and 2.45% as of December 31, 2024 and 2023, respectively.

NOTE 9 SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to provide the employer matching contribution on an annual basis to employees completing 1,000 hours of service during the Plan year and employed on the last day of the Plan year. Effective January 1, 2025, the nonelective contribution credited is based on a scale of 1.5% to 2% of covered pay, based on the employee's age and years of service and is provided to employees completing 1,000 hours of service during the Plan year and employed on the last day of the Plan year.
