## **Independent Auditor's Report**

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**Note 1: Description of Plan**

The following description of Choptank Health Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan established by Choptank Community Health System, Inc. (the Company or Plan Sponsor) as of July 1991 and restated effective April 1, 2020. The Plan qualifies under Section 403(b) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: The Plan generally allows eligible participants to contribute a percentage of their compensation not to exceed the maximum limitation on annual additions to a participant’s account under applicable provisions of the IRC. All employees are eligible to participate in the Plan upon employment. Participant contributions are made through payroll deductions. Participants are also allowed to contribute distributions received from other qualified retirement plans (rollover). Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. New employees are automatically enrolled in the plan at a 3% contribution rate unless the employee elects not to participate in the Plan or changes the contribution rate.

Employer Contributions: The Plan provides for discretionary matching contributions on employee salary deferral contributions in an amount to be determined by the Company, on an annual basis. The Company may also make discretionary nonelective contributions which will be allocated among all eligible employees, whether or not they make contributions, based on the compensation of the employees. Participants must complete 12 consecutive months of service and be employed on the last day of the year to be eligible to share in the discretionary matching and nonelective contributions. The amount of contributions to the Plan is subject to the annual limitations set by the IRC. As of December 31, 2024 and 2023, the Company contributed to the Plan, on behalf of each eligible participant who made a deferral contribution and was employed on the last day of the Plan year, an amount equal to 100% of deferral contributions that were not in excess of 3% of annual compensation.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, the Company’s contributions and an allocation of Plan earnings and losses. Plan earnings and losses are allocated based on participant account balances. The benefit to which a participant is entitled is that which can be provided from the participant’s vested account balance. All accounts are entirely participant directed. All plan assets as of December 31, 2024 and 2023 have been allocated to participants’ accounts, except for employer contributions receivable.

Vesting: Participants are immediately vested in all their contributions and investment earnings thereon. Employer contributions are subject to the following vesting schedule:

Forfeitures: The non-vested portion of a participant's account balance is forfeited upon termination of employment. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$5,362 and \$126, respectively. These amounts can be used to reduce future employer contributions and pay administrative expenses of the Plan. During the years ended December 31, 2024 and 2023, forfeitures of \$10,458 and \$7,629 were used to reduce employer contributions and pay administrative expenses, respectively.

Payment of Benefits: Amounts credited to an individual participant's account are distributed at termination of employment as a lump sum, in installments, or, if qualified, as an annuity. Vested balances under \$5,000 may be paid out as a lump sum distribution at the discretion of the Company. Participants are generally required to take minimum distributions upon reaching the age of 73. In-service withdrawals are permitted after a participant has attained 59 ½ years of age. Hardship withdrawals by a participant are permitted if specified criteria are met.

**Note 2: Summary of Significant Accounting Policies**

Following is a description of the significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from participants, including any related employer matching contributions, are recorded in the period the employer withholds payroll deductions from plan participants. Discretionary employer contributions are recorded in the period when the contribution is approved by the Company's management and collectability is reasonably assured.

**Note 2: Summary of Significant Accounting Policies (Continued)**

The Plan has not established an allowance for credit losses at December 31, 2024 and 2023. Expected collection losses are determined from a review of historical collection experience, existing economic conditions and reasonable and supportable forecasts of future events affecting the Plan Sponsor. The Plan's fiduciaries believe the employer contributions receivable will be fully collected based on the ability of the Plan Sponsor to pay amounts when due.

Payment of Benefits: Benefits are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 1, 2025, the date the financial statements were available to be issued. During the period from January 1, 2025 through October 1, 2025, the Plan did not have any material recognizable subsequent events.

**Note 3: Fair Value Measurements**

Generally Accepted Accounting Principles (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodology used at December 2024 and 2023. Following is a description of the valuation methodology used for measuring the Plan's assets:

Mutual Funds - Registered Investment Companies: Mutual funds valued at the quoted market value of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities that are to be reported at fair value. The tables below present the assets and liabilities measured at fair value on a recurring basis by level within the hierarchy as of December 31, 2024 and 2023:

**Note 4: Information Certified by the Plan Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information certified by Lincoln Financial Group Trust Company, Inc. (Lincoln), the custodian of the Plan, except to compare such information to information included in the Plan's financial statements and supplemental schedule.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments in mutual funds and insurance contracts held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was derived from information certified as complete and accurate by Lincoln.

**Note 5: Lincoln Stable Value Account**

The Plan has investments in fully benefit-responsive contracts with Lincoln. Lincoln maintains the contributions in a stable value account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The account meets all of the standards currently required by the Financial Accounting Standards Board (FASB) in order to be considered fully benefit-responsive, and therefore, is reported at contract value. The account has no stated maturity date and the interest rates are reset monthly. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with Lincoln. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that the possibility of any events that would limit the Plan's ability to transact at contract value with plan participants to be probable.

The investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6: Plan Termination**

The Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan, subject to applicable statutory provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine. In the event of a termination, all Plan participants become fully vested. The Company has not indicated any intention to terminate the Plan.

**Note 7: Income Tax Status**

The Company has adopted a Volume Submitter 403(b) Plan sponsored by Lincoln Financial Group Trust Company, Inc., the custodian of the Plan. The Plan is intended to comply with the applicable requirements of Section 403(b) of the Internal Revenue Code (IRC) of 1986, as amended. Lincoln has received a favorable opinion letter from the IRS, dated March 3, 2017, relative to its Volume Submitter 403(b) Plan, therefore, the plan administrator believes that the Plan is currently designed and is being operated in compliance with applicable requirements of the IRC. The Plan's federal information returns are subject to examination by the IRS generally for a period of three years after the returns are filed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**Note 8: Administrative Expenses**

The Plan provides that the Company, at its discretion, may pay administrative expenses of the Plan. For the years ended December 31, 2024 and 2023, the Company paid Plan administrative expenses totaling approximately \$16,500 and \$16,000, respectively. Expenses paid directly by the Company are excluded from these financial statements.

**Note 9: Parties-in-Interest**

The Plan offers various investment options, all of which are products of Lincoln Financial Group Trust Company, Inc., the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. In addition, certain officers and employees of the Plan's sponsor are administrators of the Plan and are participants in the Plan. During the years ended December 31, 2024 and 2023, the Plan paid administrative expenses of \$33,893 and \$29,381, respectively, to Lincoln.

**Note 10: Risks and Uncertainties**

The Plan invests in various investment securities, as directed by participants. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11: Reconciliation of Financial Statements to Form 5500**

The financial statements of the Plan as of and for the years ended December 31, 2024 and 2023 did not differ from the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employee Benefit Plan).
