INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the

Painters and Allied Trades and its Affiliated Employers

Opinion

We have audited the financial statements of the HealthInvest HRA VEBA Trust for The International Union of Painters and Allied Trades and its Affiliated Employers (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF PLAN

The following description of the HealthInvest HRA VEBA Trust for The International Union of Painters and Allied Trades and its Affiliated Employers (the Plan) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan's provisions.

General - HealthInvest HRA VEBA Trust for The International Union of Painters and Allied Trades and its Affiliated Employers was established on January 1, 2019 under an agreement between the International Union of Painters and Allied Trades, IUPAT Industry Pension Plan, Finishing Trades Institute, Labor Management Cooperation Initiative and the HealthInvest HRA Master Trust. The Plan is designed to permit an eligible participant to obtain reimbursement of qualified medical expenses on a nontaxable basis from their individual health reimbursement account ("HRA"). It is subject to the provisions of a medical reimbursement plan under Internal Revenue Code Sections 105 and 106 and regulations issued thereunder, and as a health reimbursement arrangement as defined under IRS Notice 2002-45.

Benefits - The Plan will reimburse eligible participants and their dependents for medical care expenses up to the available balance in the participant's HRA. To be eligible, the participant must work for a contributing employer who has made contributions to the Plan on his or her behalf. A participant is currently only eligible for benefits once they have either retired or separated from the Plan (post-separation benefits).

Contributions - Each participant's HRA is funded by employer contributions in accordance with the plan documents or such other agreement between the contributing employer and the plan requiring such contributions. Employer contributions are accounted for as exchange transactions. The Trust document required contributions at a rate of \$1.00 for each hour worked in covered employment.

Participants Accounts - A participant's HRA will be credited for all employer contributions made on his or her behalf. A participant's HRA will be debited for any reimbursement of medical expenses. The amount available for the participant is the amount credited to the account less the reimbursements.

Plan Termination - The Trustees expect and intend to continue the Plan indefinitely but reserve the right to amend or terminate the Plan. In the event of termination, the Trustees shall first apply the net assets to any obligations outstanding and any remaining balance in such manner as will best effectuate the purpose of the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Under no circumstances shall any portion of the Plan directly or indirectly revert or accrue to the benefit of any contributing employer or the Union.

Method of Accounting - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Investment Valuation and Income Recognition - The fair value of the Plan's interest in the HealthInvest HRA Master Trust is based on the beginning of the year value of the Plan's interest in the trust, plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses. Investments in the HealthInvest HRA Master Trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by its investment advisers and custodians. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Administrative Expenses - Administrative expenses are paid by the Plan.

NOTE 3. TAX STATUS

The Plan applied for its determination letter on February 1, 2021, in which the Internal Revenue Service stated that the Plan, as then designed, was exempt from federal income tax under Section 501 (c) (9) of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving this determination letter. However, the Plan's legal counsel believes that the trust is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the trust is tax-exempt under Section 501 (c) (9) of the IRC as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, Plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 4. INTEREST IN HEALTHINVEST HRA MASTER TRUST

The International Union of Painters and Allied Trades, IUPAT Industry Pension Fund, Finishing Trades Institute and Labor Management Cooperation Initiative each contributed investment assets to a combined investment account entitled HealthInvest HRA Master Trust. Each of the 4 contributing employers has an undivided interest in the Master Trust. The assets of the Master Trust are held by Washington Trust Bank, as Trustee.

The value of the Plan's interest in the HealthInvest HRA Master Trust is based on the beginning of year value of the Plans' interest in the Master Trust plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses. The Plan's interest in the net assets of the HealthInvest HRA Master Trust was 0.51% and 0.45% as of December 31, 2024 and 2023, respectively. Total investment income (including net appreciation (depreciation) in the fair value of the investments) of the HealthInvest HRA Master Trust is allocated to the individual plans based upon ending monthly balances invested in each plan.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4. INVESTMENTS IN HEALTHINVEST HRA MASTER TRUST (continued)

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Trustees determines the fair value measurement policies and procedures, based on information provided by the Plan's custodian bank and investment advisors. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurement are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well, as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at quoted market prices in active markets, which are derived by the fair value of the underlying assets and liabilities of the specific fund.
