Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Circle 9 Resources 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024, the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

DESCRIPTION OF PLAN

The following description of Circle 9 Resources 401(k) Plan (the “plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provision.

The Plan is a defined contribution plan covering all non-excluded employees of Circle 9 Resources LLC, (the “Company”) and other adopting employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Administrative Committee is responsible for the oversight of the Plan. Minnesota Life Insurance Company (the Trustee) serves as the trustee of the Plan and holds the Plan assets. The Standard, an affiliate of Minnesota Life Insurance Company maintains the records of the participant data.

Non-excluded employees are immediately eligible to participate in the Plan.

Eligible employees may make voluntary contributions through payroll deductions of 100% of their eligible compensation as defined in the plan document. The plan allows participants to designate contributions as Roth contributions. These employee contributions in any calendar year may not exceed a prescribed dollar amount that is increased from year to year for cost-of-living changes. Employer discretionary matching contributions are equal to 100% of participant salary deferrals up to a 4.5% matching contribution limit. Each year, the Company may make discretionary Employer non elective contributions to the Plan. There were no employer non elective contributions for the year ended December 31, 2024. The plan also allows rollover contributions from other plans.

Each participant’s account is credited with the participant’s 401(k) contribution and is allocated the Company’s contribution and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Participants are vested immediately in all participant deferral and employer contributions plus actual earnings thereon.

Upon enrollment in the Plan, participants may direct their contributions among the various investment options as identified in the statement of assets available for plan benefits. Participants may change their investment options at any time.

On termination of service, a participant may elect to receive a lump-sum distribution of his or her vested account balance.

ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENTS

The plan assets, administered by the Company, are part of a separate account established by Standard Insurance Company. This separate account has varying investment divisions that invest in shares of diversified, open-end management investment companies. These investments are valued at the closing net asset value per share as determined by the appropriate fund portfolio at the end of each day. The cost of investments represents shares of the funds that were purchased for this separate account. Purchases are made at the net asset value from the net purchase payments or through reinvestment of all distributions from this separate account.

The Plan represents in the statement of changes in net assets available for plan benefits the net appreciation (depreciation) in the fair value of its security investments in registered investment companies. This net appreciation (depreciation) consists of the realized gains and losses and the unrealized appreciation (depreciation) on those investments.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

A participant may request to borrow a minimum of \$1,000 and a maximum amount of the lesser of one-half of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. All loans from plans maintained by the participant's employer or a related employer will be considered for purposes of determining the maximum amount of the loan. Up to 50% of their vested account balance may be used as collateral for any loan. The interest rate is determined by the plan administrator. The interest rate will be fixed for the duration of the loan except as otherwise required by law. Participants may only have one loan outstanding for the purchase of a participant's primary residence and one loan outstanding for any other purpose at any given time. Terms range from one to five years or up to 30 years for the purchase of a primary residence.

RECOGNITION OF REVENUE

Employer contributions are accrued in the year in which the contributions are determined to be payable. Dividend income is recorded at the ex-dividend date.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Administrative expenses of the Plan, including accounting fees, have been paid by the Company. Certain expenses that are paid directly by the Company are excluded from the financial statements and no reimbursement is expected. Other expenses related to general administration or investment related expenses are included in the statement of changes in net assets available for plan benefits.

NOTE 1 – INFORMATION CERTIFIED BY PLAN’S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company (the trustee of the Plan).

NOTE 2 – PARTY-IN-INTEREST TRANSACTIONS

Investments are managed by Minnesota Life. The Plan also holds notes receivable from participants. These transactions qualify as party-in-interest transactions

Certain fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to service providers which were not covered by revenue sharing.

Certain administrative duties are performed by officers and employees of the Plan Sponsor. No officer or employee receives compensation from the Plan for these services.

NOTE 3 - PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE 4 - TAX STATUS

The trust established under the Plan to hold the Plan's assets qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from federal income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

NOTE 5 – ACCOUNTING FOR UNCERTAINTY IN INCOME TAXES

Accounting principles generally accepted in the United State of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for the years before 2021.

NOTE 6 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

NOTE 7 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, Fair Value Measurements (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: Stated at fair value as determined by the issuer of the pooled separate accounts based on the fair market value of the underlying investments, which is valued at the net asset value (NAV) of units of the pooled separate accounts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
