INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the
Dulany Industries, Inc. 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Dulany Industries, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Dulany Industries, Inc. 401(k) Retirement Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Dulany Industries, Inc. (the Sponsor) who have completed three months of service with at least 144 hours of service in each consecutive month. Employees who are union, leased, or reclassified employees are excluded from participating in the Plan. Prior to the Plan amendment below, eligible employees could enter the Plan on the first day of the quarter after eligibility requirements were met. The Plan was amended effective June 1, 2024 to allow for eligible employees to enter the Plan on the first day of the month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make pre-tax and/or Roth contributions of up to 100% of their eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus catch-up contributions of \$7,500 for those qualifying participants who are at least 50 years of age. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Sponsor will contribute a safe harbor matching contribution. The Sponsor makes a safe harbor matching contribution of 100% of a participant's contributions to the Plan to the extent the contributions do not exceed 6% of their eligible compensation. The Sponsor may also make a discretionary profit sharing contribution at the option of the Sponsor's Board of Directors. The Sponsor made a \$325,000 profit sharing contribution to the Plan, for the year ended December 31, 2024. The 2024 Plan year profit sharing contribution was allocated to participants' accounts in February 2025.

In accordance with FASB ASC 326, *Financial Instruments—Credit Losses*, the Plan estimated the current credit risk associated with the employer contribution receivables. After giving consideration to the risk characteristics, including historical payment experience, the Plan determined that no allowance for credit loss was necessary and there was no current year activity in the allowance for credit losses.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Sponsor's contributions, and earnings and losses on the investments in their account and is charged with transaction fees for services received by the participant and certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollovers, and the Sponsor's safe harbor matching contributions, plus earnings thereon. The Sponsor's discretionary profit sharing contributions and the earnings thereon, vest 50% at the completion of one year of service and are 100% vested after the completion of two years of service.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$712 and \$332, respectively, and are included in interest-bearing cash on the statements of net assets available for benefits. Forfeitures may be used to pay Plan expenses or to reduce any future Sponsor discretionary profit sharing contribution. In 2024, forfeitures of \$300 were used to reduce the 2023 Sponsor's discretionary profit sharing contribution. In 2024, forfeitures of \$0 were used to reduce the 2024 Sponsor's discretionary profit sharing contribution.

Payment of Benefits

At the time of retirement, death, disability, or termination of employment, a participant or their beneficiary, whose vested balance exceeds \$5,000, may elect to receive payment of the vested interest in their account in a lump sum distribution or installment payments. If the account balance is \$5,000 or less, the participant will automatically receive a lump sum distribution equal to the value of their account. In-service withdrawals are also permitted for participants who have attained age 59½. The participant's contributions may also be withdrawn for certain hardship situations.

Administrative Expenses

The Sponsor pays all administrative expenses of the Plan that are not paid by participants. The Sponsor does not expect reimbursement from the Plan for any expense paid on behalf of the Plan. Administrative expenses for advisory services, recordkeeping, and certain participant transaction fees are paid by participants. Expenses are allocated proportionately based on the participants' account balances. Certain expenses specifically incurred by a participant, such as fees for taking a withdrawal from the Plan, are paid directly by that participant. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Sponsor's safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The Sponsor's discretionary profit sharing contributions are payable to the Plan after approval of the Board of Directors of the Sponsor. Any unfunded participant or Sponsor contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information regarding investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net change in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank (Charles Schwab), the Plan's qualified institution.

4. Investments

The Plan's investments include an interest-bearing cash account managed by Charles Schwab, which is the Plan's qualified institution. Accordingly, transactions in this investment qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment. These fees are paid to a service provider of the Plan and qualify as party-in-interest transactions.

Investments are exposed to several risks, such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the interest-bearing cash account are based on quoted market prices for the identical security in an active market (Level 1).

The Plan invests in collective investment trusts. The funds trade at net asset value (NAV) per share. The Plan has elected to use NAV as a practical expedient to measure the fair value of the funds. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Participants' balances in the funds can be redeemed daily without restrictions or any prior notice. No unfunded commitment existed with respect to the funds as of December 31, 2024. The funds are not categorized within the fair value hierarchy. The Plan's investment in this account is stated at net asset value.

Although it has not expressed any intent to do so, the Sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants would become fully vested in their employer contributions.

6. Income Tax Status

The Plan uses a prototype plan created by The Retirement Plan Company LLC (TRPC). The Internal Revenue Service has determined and informed TRPC by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not received an individual determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, accordingly, has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities and may change upon examination.
