### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of ICON Clinical Research, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

#### (1) Description of Plan

The following description of the ICON Clinical Research, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan is a participant-directed defined contribution plan covering substantially all full-time employees of ICON Clinical Research, LLC (the Company) from the date of hire, except employees covered by a collective bargaining agreement, leased employees as defined by the Plan, or nonresident aliens who do not receive any earned income from the Company. There are no minimum service or age requirements required by the Plan document. Participants who elect to contribute are immediately eligible to contribute to the plan and are eligible to receive employer matching contributions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The 401(k) Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### *Transfer from Merging Plan*

In December 2024, as a result of the Company's acquisition of HumanFirst, the assets and related participant account balances included as part of Elektra Labs 401(k) Plan was merged into the Plan. As a result of the merger, \$863,221 was recorded as transfer from merging plan for the year ended December 31, 2024.

### (1) Description of Plan, Continued

#### *Contributions*

Each year, participants may contribute a percentage (up to 75%) of eligible compensation, as defined, up to the annual limit established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For the 2024 plan year, eligible participants were entitled to receive Company matching contributions equal to 100% of the first 3% of contributions and 50% of the next 3% of contributions, as follows:

Employee Contribution Percentage	Employer Match (% of Eligible Compensation)
1.0%	1.0%
2.0%	2.0%
3.0%	3.0%
4.0%	3.5%
5.0%	4.0%
6.0% or more	4.5%

The Plan includes an automatic deferral provision, whereby 3% of new participants' compensation will be deferred unless the participants make a contrary election.

In addition, the Company may elect to make a profit-sharing contribution to the Plan. There was no such contribution for 2024.

#### *Participants' Accounts*

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Participants have special vesting provisions for the Company's contributions and related earnings based on years of credited service with the Company and years of credited service with previous plans that have merged with the Plan. The special vesting provisions range from 1 to 6 years, as defined in the Plan.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or longer if the proceeds are used for the purchase of the participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local borrowing rates as determined by the plan administrator (typically, the prime rate plus 1%). Principal and interest are paid ratably through weekly payroll deductions.

##### *Payment of Benefits*

Upon termination of service, a participant will be entitled to receive a benefit equal to the total value of vested benefits in the participant's account. The benefit will automatically be payable in the form of a lump-sum payment. Under the Plan, participants are not subject to federal income tax on the contributions and investment income credited to their accounts until such amounts are withdrawn pursuant to Section 401(a) of the Internal Revenue Code (IRC). Withdrawals (including withdrawals by participants separated from the service of the Company for any reason) that are not rolled over into another qualified plan may be subject to federal income taxes.

##### *Forfeitures*

Upon termination from the Company, participants will forfeit any nonvested portion of their account balance as of the termination date. Forfeitures may be used first to reduce administrative expenses of the Plan and any remaining amount will be used to reduce future employer matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,525,600 and \$3,705,887 respectively. During 2024, \$4,744,595 of forfeitures were used to reduce employer matching contributions.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual method of accounting.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are treated as distributions based upon the terms of the plan document.

##### *Contributions*

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Administrative expenses charged for investment management, recordkeeping and audit services are deducted directly from each participant's plan account. Other administrative expenses are paid by the Company, including insurance premiums and external legal services. In addition, the Company provides internal accounting and administrative services at no cost to the Plan. Fees related to the administration of notes receivable from participants are charged directly to participants' accounts and are included in administrative expenses. The Plan has a revenue sharing arrangement with Empower, the record keeper, and established a plan level account (ERISA account) that captures excess income collected by the record keeper that can be used to pay eligible plan expenses or can be allocated to participants. At December 31, 2024 and 2023, the ERISA account totaled \$144,274 and \$33,636, respectively. During 2024, Plan expenses aggregating \$667,393 were paid from this account.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Subsequent Events*

The Plan has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued.

#### (3) Financial Information Certified by the Trustees

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are an open-end mutual fund that is registered with the Securities and Exchange Commission. The funds are required to publish their net asset value (net asset value) and to transact at that price.

*Common/collective trust funds:* Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Fund of funds:* Valued at the daily closing price as reported by the underlying mutual fund and then adjusted to apply any applicable expense factor. The mutual funds are registered investments with the Securities and Exchange Commission.

#### (5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balances.

#### (6) Tax Status

The Internal Revenue Service has determined and informed Empower by a letter dated November 14, 2022, that the prototype plan and related trust are designed in accordance with applicable provisions of the IRC, and the Plan, therefore, is exempt from federal income taxes. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (7) Nonexempt Transactions

As required by ERISA Section 2510.3-102, the plan sponsor is required to segregate employee contributions to the Plan from its general assets as soon as administratively practicable. During the 2018 through 2023 plan years, certain employee withholdings aggregating \$27,172 were not remitted to the Plan timely. These transactions are considered prohibited transactions as defined by ERISA. The Company compensated the Plan for lost investment earnings related to these transactions during 2024.

#### (8) Related Party Transactions and Party-In-Interest Transactions

Administrative expenses paid by the Plan for investment management and recordkeeping amounted to \$982,836 for 2024. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

#### (9) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statement of net assets available for benefits.
