## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed an audit of the accompanying financial statements of Oatey Co. Profit Sharing Retirement Trust and Savings Incentive Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Oatey Co. Profit Sharing Retirement Trust and Savings Incentive Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information, copies of which may be obtained from the Plan Sponsor.

General

The Plan is a defined contribution plan and covers certain eligible employees of Oatey Co. ("Plan Sponsor" or "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

In accordance with the terms of the Plan document, employees of the Company become eligible for the Plan upon completion of three months of service. Participants are eligible to receive profit-sharing contributions when they have completed at least 1,000 hours of service during the Plan year and are employed as of the last day of the Plan year.

Contributions

Participants may, subject to certain limitations set by the Internal Revenue Code ("IRC"), elect to contribute 1% to 90% of their compensation to the Plan. Participant contributions may be made as pre-tax or Roth 401(k) contributions. During any calendar year in which a participant attains age 50 or older, he or she may elect to make additional pre-tax contributions and/or Roth 401(k) contributions, called "catch-up" contributions.

The Company contributes a safe harbor match of 100% of the first 5% of the participant's contribution to the Plan.

The Company also contributes an additional discretionary contribution in excess of the matching amount. These additional contributions are allocated to each participant's account based on an equal dollar amount per participant, as determined by the Company. During the year ended December 31, 2024, the Company did not make any discretionary employer contributions.

The Plan includes a direct enrollment provision in which employees who fail to affirmatively make a deferral election (including the election of 0%) upon their entry date are deemed to have elected to defer 3% of their pre-tax compensation. The Plan also includes an automatic 1% annual deferral increase as a pre-tax deferral contribution until a deferral rate of 10% is reached with additional parameters, as defined in the Plan document.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, rollovers, and Plan earnings based on the participant's relative investment holdings. The Administrative expenses are also allocated to participant's accounts based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions, safe harbor match contributions, and rollover contributions, plus actual earnings thereon.

Payment of Benefits

Participants, or their beneficiaries, may elect to receive the amount as a lump-sum or designated sums from time to time. Upon the age of 59  $\frac{1}{2}$ , a participant may elect to receive a lump-sum amount or installment payments. All distributions are in the form of cash.

Notes Receivable from Participants

The Plan allows for loans to participants from their individual account balances that are limited to the lesser of \$50,000 reduced by the excess (if any) of the highest outstanding loan balance of loans during the one year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the loan is made, or one-half of the vested portion of his or her account. The participant loans have repayment terms of 5 years, except for loans taken for the purchase of a primary residence, which may be repaid over a period not to exceed ten years. The loans are secured by the balance in the participant's account and bear interest at a market rate.

Forfeitures

Any forfeitures during the Plan year are used to pay administrative expenses of the Plan and fund employer contributions to the Plan. During the year ended December 31, 2024, \$14,893 of forfeitures were used to pay administrative expenses and fund employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,373 and \$2,069 respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and the accompanying notes. Actual results may differ from those estimates.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Valuation of Investments and Income Recognition

The Plan's investments are valued at fair market value.

The change in the difference between fair value and the cost of the investments, along with gains (losses) from sales of investments, is reflected in the statements of changes in net assets available for benefits as net appreciation (depreciation) in the fair value of investments. Purchases and sales of investments are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

Fair Value of Financial Assets and Liabilities

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Notes Receivable from Participants

Notes receivable from participants represent participant loans and are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

A portion of the administrative fees are paid by the Plan. Other administrative fees, including legal and professional fees, are paid by the Plan Sponsor.

Subsequent Events

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are participant-directed accounts that are held by the Trustee.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three- tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 - Observable inputs such as quoted prices in active markets;
- Level 2 - Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 - Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Investments that were measured at net asset value (“NAV”) per share as a practical expedient are not classified in the fair value hierarchy. The fair value amounts presented in the below tables are intended to permit reconciliation of the fair value hierarchy to total investments at fair value. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

*Mutual funds:* Valued at fair value as determined by quoted market prices on active markets.

*Common collective trusts:* Valued at NAV of the underlying investments held by the funds, less their liabilities. NAV is used as a practical expedient to estimate fair value.

The investment strategies for the common collective trusts are to invest in international funds, bonds, mid cap funds, and large cap funds.

NOTE 6 - TAX STATUS

The Plan is a volume-submitter plan provided by Fidelity which has received an opinion letter, dated June 30, 2020, from the IRS. The opinion letter states that the volume-submitter plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. Subsequently, the Plan has been amended. The Plan's Advisory Committee believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and therefore operates as tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan Sponsor has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 and for the year ended December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include the purchases and sales of investments through the Plan's Trustee and the payment of services and expenses. There are also indirect fees deducted directly from investment earnings of the Plan.
