Report of Independent Auditors

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Point32Health 401(k) Plan (the Plan) provides general information about the Plan's provisions. Point32Health Services, Inc. (the Company) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan established for the benefit of the employees of the plan sponsor Point32Health Services, Inc and its affiliates (the Company).

The Board of Directors is the Plan's administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Fidelity Management Trust Company (Fidelity) and Teachers Insurance and Annuity Association (TIAA) are the trustees of the Plan's assets and provides recordkeeping services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

All regular full-time and part-time employees of the Company become eligible to participate in the Plan immediately and become eligible for both the deferral matching and the supplemental contribution. Temporary and per diem employees become eligible to participate in the plan on the first entry date after they have completed at least 1,000 hours of service during an eligibility computation period.

Contributions and Funding Policy

Participants can elect to contribute from 1% to 50% (70% for those age 50 and over) of eligible compensation on a pre-tax basis, as defined by the Plan, up to IRS limits, (including catch-up contributions for participants aged 50 and over). Participants are eligible to designate some or all of their Deferral Contribution as an after-tax Roth Deferral Contribution at the time the deferral election is made. Changes to employee salary deferral percentages may be made at any time. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Any employee upon first becoming eligible to participate in the Plan, who fails to affirmatively make any deferral election, shall be deemed to have elected to defer 3% of their compensation as a pretax contribution. Contribution percentages will increase 1% each year subsequent if the active participant does not elect otherwise. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

The Company may match, at its discretion, and as voted on by the Company's Board of Directors, contributions equal to a stated percentage of the participants' respective salary deferrals. In 2024 and 2023, the Company matched, at the end of each pay period, 100% of the first 2% and 50% of the next 4% of the participants' contributions to the Plan.

Annually, the Board of Directors votes on the amount of any Supplemental Retirement Contribution to be made to the Plan. For the plan years ended December 31, 2024 and 2023, the Company contributed 3% of a participant's eligible compensation for a total of \$13,297,206 and \$13,853,976, respectively, in Supplemental Retirement Contributions to the Plan.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants who are automatically enrolled have their contributions invested in the applicable lifecycle fund based on their age until they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued)

A self-directed brokerage account (SDBA), also known as Fidelity Brokeragelink, is an additional investment option offered to participants of the Plan. By establishing a Fidelity

Brokeragelink, account participants can transfer a portion of their 401(k) funds into their SDBA account to invest in a wider array of securities typically not offered by the Plan.

Payment of Benefits

Upon separation from service with the Company due to death, disability, retirement, or termination, a participant whose vested account balance exceeds \$1,000 may elect to receive either a lump-sum or may elect installment payments on a quarterly or annual basis. A participant whose vested account balance is \$1,000 or less and has not commenced receiving installment payments will automatically receive an immediate lump-sum distribution equal to their vested account balance.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions is based on years of continuous service. A participant is 100% vested after three years of credited service.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. Unallocated forfeited balances as of December 31, 2024 and 2023, were approximately \$1,387,292 and \$1,143,955, respectively. Forfeitures used to reduce Company contributions for 2024 and 2023, were \$622,429 and \$750,000, respectively.

Participant Loans

A participant may borrow from their vested account balance subject to the administrative rules of the Plan. The minimum loan amount is \$1,000, and the maximum amount is the lesser of 50% of the value of their vested account at the time of the loan, or \$50,000. The loans bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loan terms may range up to five years and may be prepaid in full at any time without penalty. All loans are repaid through payroll withholdings. If a participant terminates employment with the Company, the participant may continue to repay the loan that was outstanding at the point of termination. If the loan is not repaid, it will automatically be treated as a distribution to the participant.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Reclassifications

Certain prior year amounts in the statement of net assets available for benefits have been reclassified to conform to the current year presentation.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity and TIAA, the trustees of the Plan.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, defines fair value, establishes a framework for measuring fair value and expands the required disclosures about fair value measurements. Per ASC No. 820, fair value is based on an exit price, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. ASC No. 820 also establishes a hierarchal disclosure framework which prioritizes and ranks the level of market price observability used in measuring financial instruments at fair value.

Market price observability is affected by a number of factors, including the type of instrument and the characteristics specific to the instrument. Financial instruments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Financial instruments measured and reported at fair value are classified and disclosed in one of the following categories:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, a financial instrument's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Our assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the financial instrument.

4. Fair Value Measurements (continued)

Mutual Funds: Shares are valued at the daily quoted market closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

CREF Variable Annuity Accounts: Invest principally in equity securities, fixed-income instruments and short-term investments that are valued based on quoted market values, which approximate market prices.

Pool Separate Accounts: The fair values for pooled separate accounts are based on on the NAV, per unit, used as practical expedient to estimate fair value.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds and cash equivalents that are valued on the basis of readily determinable market prices.

Common/Collective Trusts: The fair value of the Plan's interest in common/collective trusts is based on the NAV, per unit, used as practical expedient to estimate fair value. There are no redemption restrictions.

5. Fully Benefit Responsive Investment Contract

TIAA Traditional Annuity

The TIAA Traditional Annuity is a fixed annuity contract that is fully and unconditionally guaranteed by TIAA, a nonprofit legal reserve life insurance company. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest, and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. When the accumulation in TIAA Traditional Annuity is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. When a participant’s accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

The TIAA Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (RA), Group Retirement Annuities (GRA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA and GRA contracts, the crediting interest rates were 5.25% and 6.50% as of December 31, 2024 and 2023, respectively. For accumulating SRA and

GSRA contracts, the crediting interest rates were 4.50% and 5.75% as of December 31, 2024 and 2023, respectively.

The TIAA Traditional Annuity is included in the financial statements at contract value for fully benefit responsive contracts. Contract value represents contributions made under the contract, plus interest at the annually declared net credited rate, less participant withdrawals. Participants may direct the withdrawal or transfer of all or a portion of their account balances held under the contract in accordance with the terms of the Plan. The contract has certain restrictions that affect the ability of the Plan to collect the full contract value. Some of the contracts within the TIAA traditional investments restrict withdrawal of funds to a 10-year installment period. The Plan Administrator believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. In addition, the TIAA Traditional Annuity is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. While transactions involving the purchases and sales of individual TIAA Traditional contracts are not observable in a public marketplace, contract value may provide a good approximation of fair value.

6. Related-Party and Party-in-Interest Transactions

All Plan investments are in the custody of Fidelity and TIAA, the trustees and recordkeepers for the Plan. Therefore, any transactions between Fidelity, TIAA, and the Plan qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Fidelity. Fidelity receives revenue from mutual fund and collective trust fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services provided to the Plan.

If the revenue received by Fidelity from such mutual fund or collective trust fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. The Plan or the Company may make a payment to Fidelity for administrative expenses not covered by sharing of the excess revenue.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, management believes that the Company had no significant concentrations of credit risk in the investment portfolio.

8. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Report of Independent Auditors

To the Plan Participants and the Plan Administrator of Point32Health 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Point32Health 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Point32Health 401(k) Plan (the Plan) provides general information about the Plan's provisions. Point32Health Services, Inc. (the Company) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan established for the benefit of the employees of the plan sponsor Point32Health Services, Inc and its affiliates (the Company).

The Board of Directors is the Plan's administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Fidelity Management Trust Company (Fidelity) and Teachers Insurance and Annuity Association (TIAA) are the trustees of the Plan's assets and provides recordkeeping services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

All regular full-time and part-time employees of the Company become eligible to participate in the Plan immediately and become eligible for both the deferral matching and the supplemental contribution. Temporary and per diem employees become eligible to participate in the plan on the first entry date after they have completed at least 1,000 hours of service during an eligibility computation period.

Contributions and Funding Policy

Participants can elect to contribute from 1% to 50% (70% for those age 50 and over) of eligible compensation on a pre-tax basis, as defined by the Plan, up to IRS limits, (including catch-up contributions for participants aged 50 and over). Participants are eligible to designate some or all of their Deferral Contribution as an after-tax Roth Deferral Contribution at the time the deferral election is made. Changes to employee salary deferral percentages may be made at any time. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Any employee upon first becoming eligible to participate in the Plan, who fails to affirmatively make any deferral election, shall be deemed to have elected to defer 3% of their compensation as a pretax contribution. Contribution percentages will increase 1% each year subsequent if the active participant does not elect otherwise. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

The Company may match, at its discretion, and as voted on by the Company's Board of Directors, contributions equal to a stated percentage of the participants' respective salary deferrals. In 2024 and 2023, the Company matched, at the end of each pay period, 100% of the first 2% and 50% of the next 4% of the participants' contributions to the Plan.

Annually, the Board of Directors votes on the amount of any Supplemental Retirement Contribution to be made to the Plan. For the plan years ended December 31, 2024 and 2023, the Company contributed 3% of a participant's eligible compensation for a total of \$13,297,206 and \$13,853,976, respectively, in Supplemental Retirement Contributions to the Plan.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants who are automatically enrolled have their contributions invested in the applicable lifecycle fund based on their age until they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

A self-directed brokerage account (SDBA), also known as Fidelity Brokeragelink, is an additional investment option offered to participants of the Plan. By establishing a Fidelity

Brokeragelink, account participants can transfer a portion of their 401(k) funds into their SDBA account to invest in a wider array of securities typically not offered by the Plan.

Payment of Benefits

Upon separation from service with the Company due to death, disability, retirement, or termination, a participant whose vested account balance exceeds \$1,000 may elect to receive either a lump-sum or may elect installment payments on a quarterly or annual basis. A participant whose vested account balance is \$1,000 or less and has not commenced receiving installment payments will automatically receive an immediate lump-sum distribution equal to their vested account balance.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

1. Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions is based on years of continuous service. A participant is 100% vested after three years of credited service.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. Unallocated forfeited balances as of December 31, 2024 and 2023, were approximately \$1,387,292 and \$1,143,955, respectively. Forfeitures used to reduce Company contributions for 2024 and 2023, were \$622,429 and \$750,000, respectively.

Participant Loans

A participant may borrow from their vested account balance subject to the administrative rules of the Plan. The minimum loan amount is \$1,000, and the maximum amount is the lesser of 50% of the value of their vested account at the time of the loan, or \$50,000. The loans bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loan terms may range up to five years and may be prepaid in full at any time without penalty. All loans are repaid through payroll withholdings. If a participant terminates employment with the Company, the participant may continue to repay the loan that was outstanding at the point of termination. If the loan is not repaid, it will automatically be treated as a distribution to the participant.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Reclassifications

Certain prior year amounts in the statement of net assets available for benefits have been reclassified to conform to the current year presentation.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity and TIAA, the trustees of the Plan.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, defines fair value, establishes a framework for measuring fair value and expands the required disclosures about fair value measurements. Per ASC No. 820, fair value is based on an exit price, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. ASC No. 820 also establishes a hierarchal disclosure framework which prioritizes and ranks the level of market price observability used in measuring financial instruments at fair value.

Market price observability is affected by a number of factors, including the type of instrument and the characteristics specific to the instrument. Financial instruments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Financial instruments measured and reported at fair value are classified and disclosed in one of the following categories:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, a financial instrument's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Our assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the financial instrument.

4. Fair Value Measurements (continued)

Mutual Funds: Shares are valued at the daily quoted market closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

CREF Variable Annuity Accounts: Invest principally in equity securities, fixed-income instruments and short-term investments that are valued based on quoted market values, which approximate market prices.

Pool Separate Accounts: The fair values for pooled separate accounts are based on on the NAV, per unit, used as practical expedient to estimate fair value.

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds and cash equivalents that are valued on the basis of readily determinable market prices.

Common/Collective Trusts: The fair value of the Plan's interest in common/collective trusts is based on the NAV, per unit, used as practical expedient to estimate fair value. There are no redemption restrictions.

- (a) In accordance with Subtopic 820-10, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.
- (b) This category includes common collective trusts (CCTs), for which the collective investment and reinvestment of assets contributed from employee benefit plans are maintained by more than one plan. The objective of the common collective trust funds is to provide investment results that correspond to the total return performance of its underlying securities. There are no unfunded commitments and no significant withdrawal restrictions.
- (c) The Plan uses a market approach to value Level 2 and Level 3 securities. In 2024, the non-benefit responsive annuity contract earned \$185,667 in investment income and distributed \$301,488 in distributions and settlements. In 2023, the non-benefit responsive annuity contract earned \$194,565 in investment income and distributed \$254,474 in distributions and settlements. During 2024 and 2023, there were transfers in and out of Level 3 of \$68,454 and \$74,600, respectively. The Plan's policy is to recognize transfers between levels as of the end of the reporting period.

5. Fully Benefit Responsive Investment Contract

TIAA Traditional Annuity

The TIAA Traditional Annuity is a fixed annuity contract that is fully and unconditionally guaranteed by TIAA, a nonprofit legal reserve life insurance company. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest, and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. When the accumulation in TIAA Traditional Annuity is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. When a participant’s accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

The TIAA Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (RA), Group Retirement Annuities (GRA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA and GRA contracts, the crediting interest rates were 5.25% and 6.50% as of December 31, 2024 and 2023, respectively. For accumulating SRA and

GSRA contracts, the crediting interest rates were 4.50% and 5.75% as of December 31, 2024 and 2023, respectively.

5. Fully Benefit Responsive Investment Contract (continued)

The TIAA Traditional Annuity is included in the financial statements at contract value for fully benefit responsive contracts. Contract value represents contributions made under the contract, plus interest at the annually declared net credited rate, less participant withdrawals. Participants may direct the withdrawal or transfer of all or a portion of their account balances held under the contract in accordance with the terms of the Plan. The contract has certain restrictions that affect the ability of the Plan to collect the full contract value. Some of the contracts within the TIAA traditional investments restrict withdrawal of funds to a 10-year installment period. The Plan Administrator believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. In addition, the TIAA Traditional Annuity is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. While transactions involving the purchases and sales of individual TIAA Traditional contracts are not observable in a public marketplace, contract value may provide a good approximation of fair value.

6. Related-Party and Party-in-Interest Transactions

All Plan investments are in the custody of Fidelity and TIAA, the trustees and recordkeepers for the Plan. Therefore, any transactions between Fidelity, TIAA, and the Plan qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Fidelity. Fidelity receives revenue from mutual fund and collective trust fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services provided to the Plan.

If the revenue received by Fidelity from such mutual fund or collective trust fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of participants. The Plan or the Company may make a payment to Fidelity for administrative expenses not covered by sharing of the excess revenue.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, management believes that the Company had no significant concentrations of credit risk in the investment portfolio.

8. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt..

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
