Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Industries for the Blind and Visually Impaired, Inc. Retirement Savings Plan, ("the Plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through May 29, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the Plan - Industries for the Blind and Visually Impaired, Inc. is the Plan sponsor, employer and the Plan administrator. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust") holds custody of the Plan's investment assets, including insurance products made available through Principal Life Insurance Company under a trust agreement between Principal Trust and Principal Life Insurance Company. The two Principal entities are collectively referred to as "Principal". Principal serves as the recordkeeper that maintains participant records, third party administrator that maintains plan documents, and tax counsel that performs various compliance tests. Principal Securities Inc. is the Plan's investment advisor.

Investments - The Plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the Plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value (and are deemed to be actively traded).

Investment at contract value - The Principal Fixed Income Guaranteed Option is a guaranteed general account backed group annuity contract issued by Principal. A rate of interest is contractually guaranteed by Principal. The interest rate is reset at least semiannually. The interest rate was 1.55% as of December 31, 2024 and 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value in accordance with GAAP. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The Plan sponsor can request a lump sum distribution subject to either a 12-month irrevocable advance notice or 5% surrender charge, whichever the employer chooses. An additional 5% surrender charge will also result from the occurrence of certain other events as more fully described in the investment contract. The contract will continue in full force until all assets have been distributed or no further payments are due.

The Plan's ability to receive amounts due is dependent on Principal's ability to meet its financial obligations. Principal's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with Principal. As of the date these financial statements were available to be issued, the plan sponsor is not aware of any events that are probable of occurring that might limit the ability of the Plan to transact at contract value with Principal or limit the ability of the Plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General - The Plan was adopted effective February 1, 2013 as a defined contribution plan established under Internal Revenue Code Section 403(b). It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Substantially all employees are eligible to contribute to the Plan on the first of the month after their date of hire. For purposes of employer contributions, an employee is eligible once they have completed one month of service and attained age eighteen. Certain employee groups, as defined in the Plan, are not eligible to receive employer contributions.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the Plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). Upon meeting the eligibility requirements, employees are automatically enrolled in the Plan and have 3% of their compensation withheld as elective deferral contributions. These participant deferral percentages automatically increase by 1% each year until they reach a maximum of 6%. Such participants have the option to increase, decrease, or stop the deferral by completing the necessary documentation. The Plan does not allow Roth elective deferrals.
- b. Rollover contributions are accepted by the Plan from other qualified plans.
- c. Safe harbor matching contributions are made equal to 100% of the first 3% of compensation that a participant contributes to the Plan and 50% of the next 2% of compensation that a participant contributes to the Plan.
- d. Additional employer matching contributions can be made at the employer's discretion. No such contributions were made in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral, safe harbor matching and rollover contributions and an allocation of employer discretionary matching contributions, if any, and administrative expenses. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each payroll.

Vesting - Participants are always 100% vested in their elective deferral contributions, rollover contributions, safe harbor matching contributions and related earnings. Participants begin vesting in any discretionary employer matching contributions and related earnings upon one full year of service, at which time they are 50% vested. Upon reaching two years of service, a participant will be 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions may be in the form of a single lump sum or installment payments. In-service withdrawals can commence upon attaining the age of 59½. Hardship withdrawals are permitted under the Plan in certain circumstances.

Administrative fees - Certain administrative fees of the Plan are paid by the employer. Certain other administrative fees are paid by the Plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed charges are allocated to the participants on an account value basis.

Forfeitures - Forfeited nonvested accounts can be used to reduce employer contributions or pay Plan expenses. There were no forfeitures used in 2024 or 2023. Unapplied forfeitures were insignificant as of December 31, 2024 and 2023.

Notes receivable from participants - Loans to participants are not permitted under the Plan.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Principal. Principal holds custody of plan investment assets and executes investment transactions and, therefore, these transactions qualify as party-in-interest transactions.

The Plan has an administrative service agreement with Principal in which Principal provides certain administrative services to the Plan. Principal receives revenue from mutual fund providers for services Principal provides to the funds. The revenue is used to offset certain amounts that would otherwise be owed to Principal for its administrative services to the Plan. The Plan pays Principal direct for certain other service fees that are not covered by the revenue sharing provisions per the administrative service agreement. Direct fees paid were approximately \$51,000 and \$40,000 in 2024 and 2023.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any discretionary employer matching contributions and related earnings.

5. INCOME TAX STATUS

The Plan adopted a Principal Life Insurance Company volume submitter plan that received a favorable opinion letter on March 31, 2017. The opinion letter from the Internal Revenue Service state that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the Plan, however, the Plan administrator and tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the Plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the Plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY PRINCIPAL

Management has obtained certifications from Principal, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the Plan is complete and accurate.

- a. Investments held and the fair and contract values of such as of December 31, 2024 and 2023;
- b. Dividends, capital gains and interest income from investments and net appreciation (depreciation) in fair value of investments during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023.
