**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Benjamin F. Edwards & Co., Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Benjamin Edwards, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Principal Trust Company (Principal) is the custodian and trustee of the Plan. Principal Life Insurance Company (Principal Life) provides recordkeeping services and is the issuer of the guaranteed investment contract. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Participants may contribute up to 100% of annual compensation (the maximum allowed by law) as defined in the Plan. Participants may designate a portion or all of their elective deferrals as pre-tax or Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company automatically enrolls eligible employees with a fixed pre-tax deferral contribution at 6% unless the employee elects otherwise. In addition, the Plan annually increases a participant's deferral rate by 1% each January 1, up to a maximum of 10%, unless the participant elects otherwise.

The Company contributions are discretionary. The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company for each plan year, of the participant's elective deferrals. Profit sharing contributions are determined annually by the Company and are allocated to each participant employed on the last day of the year based upon the ratio of the participant's compensation to the total compensation for the Company. Participants must generally be employed on the last day of the plan year to receive Company contributions. There were no Company matching contributions for the year ended December 31, 2024. Profit sharing contributions were \$5,386,000 for the year ended December 31, 2024 and were allocated to participant accounts in 2025.

Contributions are subject to certain limitations. Participants may also transfer funds to the Plan from other qualified retirement plans.

**Investment Options**

Participants of the Plan elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and Company matching contributions, an allocation of the Company's profit sharing contribution, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in all contributions plus earnings thereon.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate. Principal and interest are paid ratably through monthly payroll deductions.

**Payment of Benefits**

On termination of service, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump-sum amount, installments, or a partial withdrawal, depending on the size of the participant's account balance at the time of termination. Participants with a vested account balance of less than \$7,000 must take a lump-sum distribution.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship or at the age of 59½. Hardship withdrawals are subject to specific statutory and regulatory requirements.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for its benefit-responsive investment contract, which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Contributions**

Contributions from participants are recorded in the period in which they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant's wages are paid.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

**Subsequent Events**

Subsequent events were evaluated through October 6, 2025, the date the financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

*Pooled separate account:* Valued at the NAV of units of the fund, which is based on the estimated market value of the underlying investments less its liabilities.

**NOTE 4 — INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan maintains a benefit-responsive investment contract with Principal Life which is renewable annually. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$2,949,918 and \$2,819,663 at December 31, 2024 and 2023, respectively. Interest is credited on contract balances using a single “portfolio rate” approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. Such interest rates are reviewed on a semi-annual basis for resetting.

Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within ninety days or in rare circumstances, contract value paid over time. An employer-level liquidation of the plan’s interest in the guaranteed investment contract will be subject to either a 12-month advance notice or a 5% surrender charge to be elected by the plan fiduciary.

**NOTE 5 — CERTIFIED INFORMATION PROVIDED BY TRUSTEE**

Information regarding investments and notes receivables from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Principal, the trustee.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are a guaranteed income fund and units of participation in Principal Global Investors Money Market Fund, a pooled separate account managed by a related party of the trustee. These transactions qualify as allowable party-in-interest transactions. Fees paid to Principal Life totaled \$205,715 for the year ended December 31, 2024.

**NOTE 7 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their company contributions.

**NOTE 8 — TAX STATUS**

As this Plan is a pre-approved defined contribution plan, the IRS issued an opinion letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan document. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the Internal Revenue Service for the statutory period.

**NOTE 9 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 — SUBSEQUENT EVENT**

Effective January 1, 2025, the Plan was amended to allow the utility clerk position to participate in the Plan, define temporary and seasonal employees as ineligible employees and change the ADP/ACP testing methodology from the prior year to the current year method. The Plan also began remitting a discretionary employer match contribution of 50% of each participant's first 2% of elective deferrals on a payroll basis.
