- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of Plan

The following description of the Tokyo Electron Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General Provisions and Plan Administration*

The Plan was adopted on June 1, 1991 and is a defined contribution profit-sharing plan, which has a qualified salary deferral feature under Section 401(k) of the Internal Revenue Code of 1986, as amended (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan covers all eligible employees of Tokyo Electron U.S. Holdings, Inc.; Tokyo Electron America, Inc.; TEL Technology Center America, Inc.; TEL Venture Capital, Inc.; and TEH Manufacturing and Engineering of America, Inc. (collectively, the Company). The Plan is administered by the Tokyo Electron Retirement Plan Investment Committee, which is appointed by the Board of Directors of the Company.

Fidelity Management Trust Company (the Trustee) serves as the Trustee and Fidelity Investments Institutional Operations Company, Inc. serves as the recordkeeper for the Plan.

#### *Eligibility and Contributions*

Employees of the Company are considered eligible for participation, except for: (1) nonresident aliens with no U.S. source of income; (2) employees covered by a collective bargaining agreement that does not provide for participation in the Plan; (3) leased employees; and (4) independent contractors and employees who are international employees on assignment from Tokyo Electron, Ltd (a Japanese Corporation) or any employee who is also an employee of Tokyo Electron, Ltd.

Participants must be 18 years of age to participate in the Plan.

Employees may elect to contribute up to 50% of eligible compensation to the Plan each year, subject to the IRC limitation of \$23,000 for Plan year 2024. Participants who reach the age of 50 by the end of the Plan year are eligible to contribute up to an additional \$7,500 as a "catch-up" contribution. In addition to traditional pre-tax salary deferrals, participants may elect to make Roth 401(k) deferrals, which are subject to current income tax rates in the year of deferral; however, such deferrals and, subject to qualifications, earnings thereon are not subject to federal income taxes when distributed to the participant.

The Company's matching contribution equals 100% of the first 5% of eligible compensation an employee elects to contribute to the Plan. The Plan permits rollovers from other qualified plans. Company matching contributions are not made on catch-up contributions. Additional employer nonelective contributions may be contributed at the discretion of the Company. No employer nonelective contributions were made for the 2024 Plan year.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of the Plan's earnings or losses and charged with administrative expenses. Allocations of earnings or losses are based upon account balances, as defined in the Plan document. The benefit the participant is entitled to receive is based upon the participant's

contributions, the allocated earnings or losses, and the vested portion of the Company's matching contribution.

### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings. The participant does not vest in any portion of the Company's matching contribution until the participant has completed two years of service. Certain participants whose employment was transferred to the Company as the result of the Company's acquisition of their predecessor employer may receive credit for prior service for vesting purposes.

### ***Notes Receivable from Participants***

Participants are eligible to borrow up to 50% of their vested account balance with a maximum borrowing of \$50,000 reduced by the highest outstanding loan balance in the prior 12-month period. The minimum loan amount is \$1,000. Loans must be repaid through payroll deductions over no more than five years. For loans used to acquire the participant's principal residence, the repayment period may be extended to ten years. A participant may pay off any remaining loan balance at any time directly to the Trustee. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. At December 31, 2024, interest rates on notes receivable from participants ranged from 4.25% to 9.50%, and maturity dates were through November 2033. Each participant may not have more than one loan outstanding at any time.

### ***Payment of Benefits***

Distributions of vested benefits may be made to a participant upon attainment of normal retirement age, disability, death, or termination of employment. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants may also elect to roll over their vested balance to another qualified retirement plan or individual retirement account (IRA). For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met.

### ***Forfeited Accounts***

Forfeitures of nonvested Company matching contributions can be used to pay administrative expenses or reduce Company matching contributions. Forfeitures of \$150,000 were used to reduce Company matching contributions during 2024. At December 31, 2024 and 2023, nonutilized forfeitures and related earnings were \$56,886 and \$66,541, respectively.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities available for benefits and changes therein. Actual results could differ from those estimates.

#### *Contributions and Contribution Receivables*

Contributions are recorded on the accrual method of accounting. Contribution receivables are obligations arising from amounts owed to the Plan from participants or the Company that have not been included in the Plan's investments at year-end.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on the accrual basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes realized gains (losses) on the sale of investments, and unrealized appreciation (depreciation) in fair value of investments. See Note 4 for a discussion of fair value measurements.

Participants direct the investment of 100% of their employee and Company matching contributions and may transfer existing account balances into any of the funds offered. The funds offered include mutual funds, a money market fund, and a common collective trust (CCT) fund.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan were paid directly by the Company and reimbursed by the Trustee or paid directly by the Trustee through revenue sharing, all of which are included in administrative expenses. No forfeitures were used to pay administrative expenses during 2024. Fees related to the Fidelity Portfolio Advisory Service® and administration of notes receivable from

participants are charged directly to the participant's account and are also included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **Revenue Credits**

Additionally, effective July 1, 2012, the Trustee implemented a Revenue Credit Agreement, whereby the Trustee makes payments quarterly to a suspense account in the Plan. The payment amount was \$407,663 and \$307,499 for the 2024 and 2023 Plan years, respectively. This account shall be funded quarterly in arrears of the pro-rata portion of the annual revenue credit as soon as administratively feasible (generally within 15 business days) after the quarterly invoice has been issued. The account shall be invested in the Fidelity Government Money Market Fund. The administrator may direct the Trustee to use amounts held in the revenue credit account to reimburse the employer for fees and expenses associated with services provided to the Plan, or pay such vendors, including the Trustee or third parties, directly. Effective January 1, 2013, amounts unused for expenses may be allocated to participant accounts in accordance with the agreement, provided that such allocation shall not occur more frequently than quarterly. The balance of the revenue credit account at December 31, 2024 and 2023 was \$27,889 and \$23,163, respectively.

### **3. Information Certified by Trustee**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, other income, and interest income on notes receivable for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

### **4. Fair Value Measurements**

The accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* - This level consists of unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

*Level 2* - This level consists of quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

*Level 3* - This level consists of prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for Plan investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds* - Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets. Shares held in mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts* - These accounts are comprised of cash equivalents, common and preferred stock, mutual funds, bonds, warrants, and stock options. The individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

*Common Collective Trust* - The CCT fund is valued at the NAV of the units held. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCT will sell for an amount different than the reported NAV. The CCT provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to this investment which is a direct filing entity.

## 5. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee. Participant loan and distribution processing fees are paid to Recordkeeper by participants. The Plan receives revenue credits. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Tax Status

The Plan adopted the Fidelity Basic Plan Document #17 on June 25, 2021. Prior to its adoption by the Plan, the prototype plan documents had been reviewed and approved by the Internal Revenue Service (IRS), allowing plans that adopt the documents to qualify under IRC Section 401(a) and, therefore, be exempt from federal income tax. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the current prototype plan documents are being operated in compliance with the applicable provisions of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan provides for investment in mutual funds, a self-directed brokerage option, and a CCT fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and market risks, which may be impacted by certain financial, business, and other factors, such as economic downturns, natural disasters, and pandemics. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and such changes could be material.

### 8. Amendment or Termination

The Company has reserved the right to amend, modify, or terminate the Plan at any time, subject to the provisions of the Plan document and applicable laws and regulations. The Company has no intentions of terminating the Plan and is not aware of any occurrences that could reasonably result in the termination of the Plan. In the event of Plan termination, participants will become 100% vested in their entire account balance, including employer contributions, if any, regardless of years of service.

### 9. Subsequent Events

For purposes of determining the effects of subsequent events on these financial statements, Plan management has evaluated events subsequent through October 1, 2025, the date the financial statements were available to be issued.
