We have performed audits of the financial statements of Celestar 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Celestar 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Celestar Holdings Corporation (the Plan Sponsor) with the exception of nonresident aliens and those whose employment is governed by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility: Prior to January 1, 2024, eligible employees were permitted to participate in the Plan immediately upon hire. Effective January 1, 2024, employees became eligible to participate on the first day of the month following the completion of one month of service. Effective May 13, 2024, employees become eligible to participate on the first day of the month following completion of two months of service. Employees covered under a collective bargaining agreement or classified as nonresident aliens with no U.S.-sourced income are excluded from participation.

Contributions: Participants may contribute 1 to 92% of annual compensation as either pre-tax or Roth after-tax contributions, as defined in the Plan. Participants age 50 or older before the end of the Plan year are permitted to defer "catch-up" contributions under the Internal Revenue Code section 414(v). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan Sponsor may make discretionary matching and non-elective contributions. In practice, for the year ended December 31, 2024, the Plan Sponsor matched 100% of participant deferrals up to \$1,500 annually for participants employed on the last day of the year, though this limit is not explicitly defined in the Plan document.

Automatic Enrollment: Effective January 1, 2024, the Plan implemented an Eligible Automatic Contribution Arrangement (EACA). Under this feature, newly hired employees who do not affirmatively elect otherwise are automatically enrolled in the Plan with a 3% deferral rate. These contributions are invested in the Plan's Qualified Default Investment Alternative (QDIA) until participants make an alternative investment election. Participants may opt out or change their deferral percentage at any time.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Plan Sponsor's contributions, and (b) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan. Participants may change their investment options daily.

Vesting: Participants are always 100% vested in their own contributions and earnings thereon. Effective January 1, 2023, employer contributions are subject to a two-year cliff vesting schedule: 0% vesting before completion of two years of service and 100% thereafter. All employer contributions become fully vested upon death or disability, or upon Plan termination.

Payment of Benefits: On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the participant's vested interest in his or her account. Involuntary distributions of balances less than \$5,000 will be made in accordance with the Plan agreement upon termination of services.

Active participants may also take distributions from the Plan upon attainment of age 59 ½. Hardship withdrawals are also allowed under the Plan.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% percent of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear a fixed rate of interest equal to the prime rate of interest in effect plus two percent. Principal and interest are through payroll deductions. The term of the loan must not exceed five years, except for loans used for the purchase of a primary residence. Loans used to purchase a primary residence may be repaid within a period of no more than 30 years.

Forfeited Accounts: Participant forfeitures of the non-vested portion of a Participant's account balance are determined as of the last day of the plan year and may be made available to reinstate previously forfeited account balances of rehires who are eligible for a restoration of forfeitures, reduce administrative expenses of the Plan, or reduce employer contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 5. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions and earnings thereon.

NOTE 4 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained from management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the trustee of the recordkeeper and custodian of the Plan.

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Pooled Separate Accounts: The fair values of participation units held in subaccounts of the Future Funds Series Account II of John Hancock Life Insurance Company are based on their net asset values, as reported by the fund managers as of the financial statement dates and recent transaction prices. Each subaccount invests in a single, open-ended mutual fund. Each subaccount provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund's net asset value per unit.

Collective Trust: The fair values of participation units held in collective trusts are based on the net asset values (“NAV”) per unit as reported by the fund managers. The collective trust provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Plan Sponsor. The Plan held investments in pooled separate accounts managed by John Hancock Life Insurance Company, therefore, these transactions qualify as party-in-interest transactions. Fees paid to John Hancock Life Insurance Company also qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

In addition, the Plan engaged a registered investment adviser to provide discretionary investment advisory services. Fees of \$20,564 were paid from Plan assets during the year. The Plan also engaged a third-party administrator to perform recordkeeping and administrative services, for which fees of \$4,212 were paid. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction provisions under ERISA Section 408(b)(2).

NOTE 7 - INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through August 8, 2025, which is the date the financial statements were available to be issued.
