Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following brief description of The Wagman, Inc. Employee Welfare Benefit Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan provides health and other benefits to substantially all active full-time employees, who are regularly scheduled at least 30 hours per week, of Wagman, Inc. (the Sponsor) and its affiliates, Wagman Heavy Civil, Inc. and Wagman Construction, Inc. (collectively referred to as "the Company") as set forth in the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust.

Participation

An employee may become a participant in the Plan after completing two months of service if the employee is not on active duty with the military.

Benefits

The Plan provides medical, prescription drugs, dental, vision, life insurance, accidental death and dismemberment, short term disability (STD), long term disability, voluntary benefits and an employee assistance plan. Additionally, the Plan provides a healthcare flexible spending account (FSA), a dependent care flexible spending account (FSA), and a health savings account (HSA).

Self-insured Benefits

The claims for self-insured benefits (medical, prescription drugs, FSA, and STD) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Sponsor. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. This coverage provides for reimbursement of certain amounts for individual participant claims in excess of a specific dollar amount, as well as claims in the aggregate.

Insured Benefits

All other Plan benefits are fully insured. The Sponsor purchases annual insurance contracts for the fully insured benefits. Premiums related to dental and vision benefits are paid from the assets of the VEBA trust. All other fully insured plan benefits premiums are paid from general assets of the Sponsor. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Budget Reconciliation Act (COBRA).

Other Benefits

The Plan offers an HSA benefit funded solely through participant contributions. The contributions made to the HSA are used on a tax-free basis to pay or reimburse qualifying health expenses. Participant HSA contributions are held in the VEBA trust until distributed to the participants' personal HSA accounts. Personal HSA accounts are maintained and held outside of the Plan and VEBA trust. The participant owns the account and is responsible for substantiating distributions from his or her HSA account.

The Plan has a healthcare and dependent care FSA that is funded solely through participant contributions. The FSA allows eligible participants to be reimbursed tax free for qualified medical and dependent care expenses subject to a specified ceiling. Amounts remaining at the end of the year cannot be carried over to the next year. These amounts are maintained in the Plan and netted against flexible spending account expenses.

Contributions

In addition to deductibles and co-payments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Benefits for life insurance, accidental death and dismemberment, long term disability, STD, and employee assistance are fully funded by the Company. Participants pay the full cost of all dental, vision, life insurance, voluntary benefits, HSA, and healthcare and dependent care FSA benefits based on the current group rate premium cost. Participants and the Company each pay a portion of the premiums for medical insurance based on current group rate premiums.

The Plan Sponsor makes contributions to the Plan as needed to fund claims and pay expenses in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Plan Sponsor on a pay-as-you-go basis.

FSA contributions are elected annually by the employee in advance and are limited to \$3,200 for 2024, except for dependent care which has a limit of \$5,000.

HSA participant contributions are based on annual elections and are limited to \$4,150 for individuals and \$8,300 for families for 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employee Benefits Committee determines the Plan's valuation policies and procedures and reports to the Company's Board of Directors. See Note 4 for discussion of fair value measurements.

Interest income is recorded on the accrual basis of accounting.

Payment of Benefits

Premiums paid by either the Company or the VEBA trust are recorded as premiums paid in the accompanying statement of changes in net assets available for benefits.

Claims paid are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable to third-party service providers in the accompanying statements of net assets available for benefits. Claims payable to third-party service providers totaled \$96,598 and 200,693 as of December 31, 2024 and 2023. Short-term disability payments are processed through the Sponsor's payroll system and paid from the general assets of the Sponsor. These payments are recorded as premiums paid in the accompanying statement of changes in net assets available for benefits.

Flexible Spending Accounts

Flexible spending account claim payments are recorded when paid by the third-party claims processor and included in claims paid, net on the statement of changes in net assets available for benefits. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable to third-party service providers in the accompanying statements of net assets available for benefits.

Claims incurred before plan year-end that were submitted after year-end totaled \$25,381 and \$23,468 for 2024 and 2023, respectively. Forfeited amounts were used by the Company to pay administrative expenses.

Stop-Loss

Premiums for stop-loss insurance are included in premiums paid in the accompanying statement of changes in net assets available for benefits. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. There were stop-loss refunds of \$472,589 during the year ended December 31, 2024.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$265,360 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Administrative Expenses

Substantially all expenses are paid by the Plan.

Subsequent Events

Management evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at December 31, 2024 and 2023, for claims incurred but not reported are estimated by the Sponsor based on claims data provided by the Plan's third-party claims processors. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash – Valued at cost, which approximates fair value, and classified within Level 1 of the valuation hierarchy.

5. ADMINISTRATIVE EXPENSES

The Plan pays expenses related to administrative fees paid to the Plan's third-party claims processors, benefits consultant, accountant, and legal counsel. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to modify the benefits provided to participants, the right to modify the contributions required of participants, the right to discontinue its contributions, and the right to terminate the Plan, subject to the provisions of ERISA. In the event the Plan terminates, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

7. TAX STATUS

The VEBA trust, which funds certain benefits of the Plan, received an exemption letter from the Internal Revenue Service (IRS) dated February 17, 2006, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

8. PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

As described in Notes 1 and 5, the Plan has several arrangements with service providers. During the years ended December 31, 2024 and 2023, the Plan's interest-bearing cash was held by M&T Bank, the custodian of the Plan. These transactions are party-in-interest transactions under ERISA.

9. RISKS AND UNCERTAINTIES

The Plan maintains cash balances at a financial institution. The cash balances are secured by the Federal Deposit Insurance Corporation (FDIC) up to applicable FDIC limits. At times, the Plan's deposits may exceed insured limits.

The Sponsor's estimate of benefit obligations is subject to certain assumptions that are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.


