### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Strides Pharma, Inc 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## NOTES TO FINANCIAL STATEMENTS

### Note 1 – Description of Plan

The following description of the Strides Pharma Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General and eligibility

The Plan was established on January 1, 2006, as a defined contribution plan. The Plan was amended and restated on January 1, 2022, to comply with certain tax legislation. The Plan is available to eligible employees of Strides Pharma, Inc. and its subsidiaries (collectively, the Company, Employer or Plan Sponsor). Eligible employees may immediately enter the Plan after the first day of the calendar month following completing one (1) hour of service, as defined by the Plan document. There is no age requirement for eligibility to participate in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan Administrator and is responsible for oversight of the Plan. The Plan has contracted with FGMK Financial Services (FGMK) to provide certain third-party administrative services to the Plan. Voya Retirement Insurance and Annuity Company (Voya or the Trustee) provides trustee, custodian and recordkeeping services to the Plan. The Trustee holds the Plan's investment assets, executes investment transactions (subject to the direction of participants) and provides recordkeeping services to the Plan.

#### Contributions

Each year, participants may voluntarily contribute up to 92% of their eligible annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans (rollover). The Plan's provisions also provide for Roth 401(k) elective deferrals.

The Company makes a safe harbor matching contribution which is equal to 100% of a participant's eligible compensation, as defined, that a participant contributes to the Plan. Employer safe harbor matching contributions for the year ended December 31, 2024 totaled \$639,779.

The Company may also make additional discretionary matching and/or discretionary profit-sharing contributions. The Company's discretionary matching contribution and/or discretionary profit-sharing amounts are calculated based on an allocation formula as determined by the Plan Sponsor at its sole discretion. Participants are eligible to receive the Company's discretionary matching and profit-sharing contributions if they are employed with the Company as of the last date of the Plan year. Discretionary matching contributions and profit-sharing contributions, if any, are recorded in the year for which the contributions apply. There were no Company discretionary matching or profit-sharing contributions made for the year ended December 31, 2024.

Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant account is credited with the participant's contribution and an allocation of: (a) the Company's contributions, and (b) Plan earnings or losses. Participants are charged with his or her withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. Each participant directs the investment of his or her account to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1 – Description of Plan, Continued

#### Vesting

Participants are immediately vested in their voluntary individual contributions, Employer's safe harbor contributions, Employer's discretionary matching contribution, and discretionary profit-sharing contributions, plus actual earnings or losses thereon.

#### Notes receivable from participants

Plan participants may borrow from their accounts between \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from one to five years unless the loan is used to acquire the principal residence of the participant. Loans are secured by the vested account balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid through regular payroll deductions and remitted to Voya. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

#### Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an annual amount equal to the value of the participant's account in a lump-sum distribution. Participants may elect to receive the value of his or her account in monthly installments in the case of termination of service due to death. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Participants may also withdraw their vested account balances at any time on or after age 59½.

### Note 2 – Summary of Significant Accounting Policies

#### Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences could be material.

#### Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the Trustee.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Note 2 – Summary of Significant Accounting Policies, Continued

#### Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

#### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Any delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

#### Payment of benefits

The Plan records benefits when paid.

#### Plan expenses

The Plan classified certain administrative expenses as an expense rather than as a reduction of investment income. Substantially all administrative expenses for maintaining the Plan are paid by the Plan Sponsor and are not reflected in these financial statements. Certain expenses paid by the Plan consist of recordkeeping, trustee, and third-party administrator fees. Certain participant directed transactions such as loan processing fees are charged directly to participants' accounts.

#### Uncertain tax positions

U.S. GAAP requires the Plan to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

### Note 3 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental information is complete and accurate:

- Investments and notes receivable from participants shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023; and
- Investment information included in the Schedule H, 4i – Schedule of Assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental information.

### Note 3 – Certified Investment Information, Continued

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Significant unobservable inputs.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds* – are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds traded on national exchanges. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded.

The preceding method described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Group Annuity Contract with Insurance Company

The Plan invests in a fully benefit-responsive investment contract issued by Voya (the issuer). The fixed account is issued by Voya and reported at contract value totaling \$755,099 and \$615,689, as of December 31, 2024 and 2023, respectively.

Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully-benefit-responsive contracts. Voya maintains the contributions in a general account. The fixed account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Voya is contractually obligated to repay the principal and interest under the terms of the contract. Contributions received are credited with the applicable crediting rate. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than zero. Such interest rates are reviewed on a quarterly basis for resetting. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow Voya to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without Voya's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts would become 100% vested in their accounts.

### Note 7 – Party-In-Interest Transactions

Parties-in-interest are defined under the Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor, and certain others. The Plan invests in mutual funds and a guaranteed investment contract managed, administered and/or issued by Voya. Therefore, transactions with Voya are considered party-in-interest transactions. The Plan Sponsor has approved these investment options. Such transactions are exempt from prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

The Trustee receives revenue from service providers for services the Trustee provides to the mutual funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services. Fees incurred for the Plan for investment management services are included in net appreciation in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing.

### Note 8 – Tax Status

The Non-Standardized Pre-Approved Profit-Sharing Plan with CODA that the Plan adopted received a favorable opinion letter from the IRS on June 30, 2020, stating that the form of the Non-Standardized Pre-Approved Profit Sharing Plan with CODA was designed in accordance with the provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income tax has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### Note 9 – Delinquent Participant Contributions

For the years ended December 31, 2024, 2023 and 2022, the Employer was untimely in remitting certain participant contributions and loan repayments totaling \$11,498, \$10,951 and \$111,287, respectively. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The related lost earnings for the 2023 and 2022 delinquent participant contributions were remitted to the Plan in 2024. The Employer and its third-party administrator are in the process of correcting the 2024 delinquent contributions and intend to fully correct these delinquent participant contributions and reimburse the Plan for related lost earnings.

### Note 10 – Subsequent Events

Management evaluated activity of the Plan subsequent to December 31, 2024 through September 30, 2025, the date on which the financial statements were available to be issued, for events that require recognition in the financial statements or disclosure in the notes thereto.
