INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Employee Benefit Plan of Institute for Community Alliances, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Employee Benefit Plan of Institute for Community Alliances financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C) .

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1 - DESCRIPTION OF THE PLAN

(a) General

The following description of the Employee Benefit Plan of Institute for Community Alliances (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan became effective on November 1, 2014.

(b) Plan Description

The Plan is a defined contribution plan covering all full-time employees of the Institute for Community Alliances(Company) who are age 20 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(c) Contributions

Participants may make salary reduction contributions on a pre-tax basis up to the maximum allowable deferral that is set by law through payroll deductions to the Plan. The Company contributes 5% of compensation of all participants eligible to share in allocations. Contributions are subject to certain limitations. At the discretion of the Plan administrator, a participant may make rollover contributions, transferring funds either directly or indirectly to the Plan from another qualified plan. Participants direct all contributions into the investment options of their choice.

The Plan currently offers various pooled separate accounts, mutual funds, common/collect trust and an investment contract with insurance company as investment options for Plan participants.

(d) Participant Accounts

Each participant's account is credited with the participant contributions, an allocation of (1) the Company's contributions, (2) Plan earnings, and charged with an allocation of management expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations are based on participant earnings or account balances, as defined.

NOTE 1 - DESCRIPTION OF THE PLAN - CONTINUED

(e) Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and earnings thereon. Vesting of the remainder of the participants' accounts is determined in accordance with the following schedule:

(f) Participant Loans

No loans are permitted from the Plan.

(g) Payment of Benefits

Upon retirement or termination of employment, a participant may elect to receive their distribution in a lump-sum amount equal up to the value of their account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value, as reported to the Plan by Principal Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value assessments.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Benefits

Benefits are recorded when paid.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE

The 2024 and 2023, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified as complete and accurate by Principal Trust Company (trustee of the plan), in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$7,092,072 and \$5,644,191 at December 31, 2024 and December 31, 2023, respectively and related net gains of \$882,739 for the year ended December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the period presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The Plan's valuation methodology used to measure the fair value of mutual funds was derived from quoted market prices of active markets.

Valued at the daily closing price as reported by the fund, mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

The fair value of pooled separate accounts and common/collective trust accounts are valued using the net asset value (NAV) of units held by the Plan at year-end as provided by Principal Trust Company.

The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee. The investment management fee is deducted prior to setting the daily unit value.

The mutual funds, pooled separate accounts and common /collective trust accounts held by the Plan are deemed to be actively traded.

The investment contracts are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer as provided by Principal Life Insurance Company.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Level 1 and 2 and no transfers into or out of Level 3.

NOTE 5 - INCOME TAX

The plan operates under an adoption agreement in connection with a prototype non-standardized profit sharing plan sponsored by Qualified Plan Consultants, LLC (The “Sponsor”). This prototype plan document was filed with the appropriate agency, and the Sponsor has obtained a determination letter from the IRS dated March 31, 2014 stating that the prototype plan constitutes a qualified plan under Section 401 of the Internal Revenue Code(IRC), and the related trust was tax exempt as of the financial statement date. The plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status; however, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. As such, there has been no provision for income taxes made in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in any invested employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - ADMINISTRATIVE EXPENSE

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements.

NOTE 9 - PARTY IN INTEREST

The Plan's investments were managed by Principal Financial Group. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund.

Various Plan investments are shares of common/collective trust pooled separate accounts and investment contracts with an insurance company are managed by Principal Financial Group. Purchases and sales of these funds are performed in the open market at fair value and qualify as party in interest transactions under ERISA regulations.

The Plan paid contract administration fees to Principal Life Insurance Company that amounted to \$17,098 for the year ended December 31, 2024.

These transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

NOTE 10 - PROHIBITED TRANSACTIONS

During a prior year, Plan contributions were not remitted in a timely matter. The Company has filed form 5530 with the Internal Revenue Service.

NOTE 11 - DATE OF MANAGEMENT'S REVIEW

Subsequent events were evaluated through October 2, 2025, which is the date the financial statements were available to be issued.
