### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of First Northern Bank Profit Sharing / 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of First Northern Bank Profit Sharing / 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of First Northern Bank Profit Sharing / 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about First Northern Bank Profit Sharing / 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about First Northern Bank Profit Sharing / 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Notes to Financial Statements**

---

### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the First Northern Bank Profit Sharing / 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. First Northern Bank of Dixon (the Bank) is the plan sponsor.

**General** – The Plan is a defined contribution plan covering substantially all nonunion employees of the Bank. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Bank is the Plan's sponsor and serves as plan administrator. The Plan was restated effective July 1, 2011, to change from a non-participant-directed plan to a participant-directed plan where participants make all investment decisions based on the investment options available in the Plan. Prior to July 1, 2011, the Plan was non-participant-directed as the trustees of the Plan made all investment decisions, except that participants were able to elect to use a portion of the Bank's contributions to purchase individual life insurance policies. Subsequent to July 1, 2011, the life insurance option was no longer offered as an investment option; however, existing policies were permitted to remain in place. The Plan was restated as of January 1, 2015, with no significant changes to the Plan.

**Eligibility** – All regular nonunion employees who have completed 90 days of service with the Bank are eligible to contribute to the Plan. In order to be eligible for discretionary matching and nonelective profit sharing contributions (if any), employees must complete 1,000 hours of service with the Bank in the 12-month period immediately following their commencement date of employment. If an employee does not complete 1,000 hours of service in the period immediately following their commencement date of employment, that employee will become eligible upon completion of 1,000 hours of service.

**Contributions** – Each year, participants may contribute up to 100% of pretax eligible compensation, as defined by the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investments of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds for participants. The Bank may elect to make discretionary matching and nonelective profit sharing contributions to the Plan. For the year ended December 31, 2024 the Bank made a profit sharing contribution of \$1,867,347. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contributions and allocations of: (a) the Bank's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan purchased individual life insurance policies from an insurance company at the election of the participant. The premium for the insurance policy is paid from the Bank's contribution allocated to the participant on whose life such policy is issued. The amount of premium available to purchase a policy for a participant is limited to 25% of the Bank's contribution allocated to the participant on whose life such policy is issued.

**Automatic enrollment and auto-escalation features** – The Plan contains an automatic enrollment feature whereby all eligible employees who have not completed a salary deferral agreement, or opted out, will be automatically enrolled in the Plan with a 5% salary deferral. Participants may make changes to the deferral percentage or cancel the deferral by completing a salary deferral agreement at any time. A participant who makes an affirmative election to defer, who has not elected a specific deferral rate, or who was automatically enrolled into the Plan, shall have the deferral amount increase by 1% each year each January 1st thereafter. The increase will continue each year until the participant has reached a maximum deferral rate of 10%, unless the participant elects otherwise.

**Vesting** – Vesting of a participant's matching and profit sharing account is based on years of continuous service. A participant is 100% vested after six years of credited service. Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

**Payment of benefits** – On separation of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount or installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures** – Forfeitures are the nonvested portion of a participant's account that is lost on termination of employment. Forfeitures are retained in the Plan are used to reduce future Bank contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$126,042 and \$128,524, respectively. The 2024 forfeited nonvested accounts were used to offset part of the 2024 Bank profit sharing contribution which was funded during 2025.

**Plan administration** – The administrative committee of the Plan presides over the Plan and directs the custodian as to investment policies.

## NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – Investments are reported at fair value. For the years ended December 31, 2024 and 2023, Empower Trust Company, LLC (Empower) certified the fair value of the Plan's investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains or losses and unrealized depreciation of those investments.

**Payments of benefits** – Benefits are recorded when paid.

**Expenses** – Administrative expenses related to operating and maintaining the Plan are paid by the Bank. Investment management and distribution transaction fees are paid by the Plan participants.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements were available to be issued.

The Plan has evaluated subsequent events through September 19th, 2025, which is the date the financial statements as approved by management were available to be issued.

## NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Registered investment companies (mutual funds)** – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

**Collective trusts** – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

**Stable value funds** - A stable value fund is a portfolio of bonds that are insured to protect the investor against a decline in yield or a loss of capital. The fund will continue to pay the agreed-upon interest payments regardless of the state of the economy.

**Life insurance** – The life insurance policies held by the Plan are stated at the estimated cash surrender value, which approximates fair value.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 4 – INCOME TAX STATUS**

The plan document is a prototype nonstandardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on November 14, 2022 which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

#### **NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Bank has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

#### **NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

**NOTE 7 – SUMMARY OF INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower has certified the completeness and accuracy of:

- Investments totaling \$35,520,940 and \$35,493,528 reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, respectively;
- Net appreciation in fair value of investments of \$2,869,990 and dividends of \$914,999 included on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Registered investment companies, collective trusts and the cash surrender value of life insurance on the supplemental schedule of assets (held at end of year).

**NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

Plan investments include certain shares of registered investment company funds managed by Empower. Transaction with this entity qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services to the custodian were \$91,424 for the year ended December 31, 2024.
