We have performed audits of the financial statements of Johnstech International 401(k) Savings & Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the Johnstech International 401(k) Savings & Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established by Johnstech International Corporation (the “Company,” “Plan Sponsor” or “Plan Administrator”) to provide retirement benefits for eligible employees. The Plan is a defined contribution 401(k) profit sharing plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was last restated effective May 1, 2022.

Eligibility

All employees of the Company, except for nonresident aliens, leased, part-time, temporary, and seasonal employees, are eligible to participate in the Plan after attaining age 18. Part-time, temporary, and seasonal employees are eligible to participate in the Plan, receive the safe harbor employer matching contribution and discretionary profit-sharing contribution upon the completion of 1,000 hours of service. Eligible employees can enter the Plan as soon as administratively feasible after the eligibility requirements are met.

Contributions

Participants may contribute up to 100% of their annual compensation to the Plan through participant elective deferral contributions, subject to certain limitations by law. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also implemented an automatic annual escalation clause which increases 1% each year up to 10% unless the participant makes a contrary election.

Participants satisfying certain criteria are permitted to make catch-up contributions, as stated in the Plan agreement. Participants may also make rollover contributions to the Plan. Discretionary profit-sharing contributions are determined by the Board of Directors.

No discretionary profit-sharing contributions were made during the years ended December 31, 2024 and 2023. The Plan allows the Company to make safe harbor employer matching contributions, as defined in the Plan. The Company made safe harbor employer matching contributions of 100% of the participant’s elective deferral, not to exceed 3% of the participant’s eligible compensation, and 50% of the participant’s elective deferrals in excess of 3% of the participant’s eligible compensation, not to exceed 5% of the participant’s eligible compensation.

Vesting

Participant elective deferral, rollover contributions, and safe harbor contributions plus actual earnings thereon are 100% vested at all times. Contributions attributable to discretionary profit sharing, plus actual earnings thereon, vest on a graduated scale to 100% after six years of service, with a provision for 100% vesting at the normal retirement date as defined in the Plan agreement, and at an early retirement date due to disability, or upon death of the participant.

Forfeitures

Forfeited non-vested accounts are used to reduce employer matching contributions or pay administrative expenses and experience unrealized gains/losses while they are within the forfeiture account. Forfeitures available to be allocated were \$7,906 and \$25,467, as of December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, there were no forfeitures used to reduce the employer match.

Participants' Accounts

Participants' accounts are credited with participant contributions (elective deferral, catch-up and rollover), employer matching contributions, employer profit sharing contributions and an allocation of Plan earnings or losses. Allocations are based on participant compensation or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the vested portion of the participant's account.

Payment of Benefits

Distribution of a participant's vested interest in the Plan is normally made upon attainment of retirement age. Early distributions are made upon death, disability, separation from service or reaching the age of 59½ years. A participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in monthly, quarterly, semiannual or annual installments. Upon separation of employment due to termination of employment, death, disability or retirement, participants may, at their election, withdraw their benefits as a lump sum payment or maintain their vested balance in the Plan. For termination of the participants whose account balance is less than \$5,000, the participant shall receive the account balance as a lump-sum distribution or rollover. If the participant does not elect a lump-sum distribution or rollover and the total value of their account balance exceeds \$1,000, but does not exceed \$5,000, the trustee is directed to pay the distribution as a direct rollover to an individual retirement account or annuity. If the participant's account balance is less than \$1,000 and no election was made, a single lump-sum distribution will be provided to the participant. Participants are permitted withdrawals from their Plan accounts for financial hardships.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Note terms range from one to five years and up to 15 years for the repayment of a home loan. The notes are secured by the balance in the participant's account and bear interest at the current prime lending rate, plus 1% at the time of the note. Only one note may be outstanding to a borrower at any time.

At December 31, 2024 and 2023, the interest rates on all loans outstanding ranged between 4.25% and 9.50%. Principal and interest are paid ratably through payroll deductions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Investment Options

All funds of the Plan are participant directed. Participants may direct the investment of their account balance into various funds and may transfer assets in their accounts between funds on a daily basis.

Assets of the Plan are held in various funds, as defined in the Plan Summary. The Plan allows participants to direct their investments and to make transfers between these accounts and funds daily, except for the notes receivable from participants. Participant loan transactions are treated as transfers between the investment funds and notes receivable from participants. The total of all inter-fund transfers between the investment accounts and funds and the notes receivable from participants was zero for the years ended December 31, 2024 and 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan agreements. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Net Appreciation in Fair Value of Investments

Net appreciation in the fair value of investments represents the net realized gains plus the net unrealized appreciation of investments. Realized gains and losses are the difference between the proceeds received and either the cost of the investments sold, determined on an average cost basis, or the fair value at the end of the previous year, whichever is applicable. Net unrealized appreciation is the change in the difference between fair value and the cost of investments or the fair value at the end of the previous year, whichever is applicable.

Administrative Expenses

All administrative expenses incurred with regard to the purchase and sale of certain investments are paid by the Plan. Other administrative expenses, such as audit, legal and trustee fees, are paid by the Plan Sponsor.

Benefits Paid to Participants

Benefits paid to participants are recorded by the Plan when paid.

Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from these estimates.

Subsequent Events

The Plan has evaluated its December 31, 2024 financial statements for subsequent events through September 29, 2025, the date the financial statements were available to be issued.

NOTE C - FAIR VALUE MEASUREMENTS

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement and Disclosure*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end based on quoted market prices.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INCOME TAX STATUS

The Plan adopted the DST Retirement Solutions, LLC Volume Submitter 401(k) Profit Sharing Plan, which received an opinion letter dated June 1, 2015, which stated that the volume submitter plan document is designed in accordance with the applicable sections of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PARTY-IN-INTEREST TRANSACTIONS

The Company has been designated as the Plan administrator and Plan Sponsor. Certain employees of the Company provide administrative services to the Plan at no expense. Administrative expenses, such as audit, legal and trustee fees, are paid by the Plan Sponsor.

Certain Plan assets consist of funds managed by Reliance Trust Company, trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.

Notes receivable from participants are also considered party-in-interest transactions.
