INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Curium US LLC 401k Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Curium US LLC 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Curium US LLC 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Curium US LLC 401k Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Curium US LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Curium US LLC (the "Company", formerly known as Mallinckrodt Nuclear Medicine, LLC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan recordkeeper is Transamerica Retirement Solutions ("Transamerica") and the trustee is Transamerica Trust Company beginning June 28, 2024. Prior to that date, Reliance Trust Company ("RTC") was the trustee. Selected Plan provisions are described below.

Effective April 1, 2024, the Plan entered into an agreement to name Newport Group Consulting, LLC. the Plan's fiduciary.

Eligibility

Participants are immediately eligible to participate in the Plan upon the attainment of the age of 18. Union employees, nonresident aliens, leased employees, cooperative students, and other temporary employees whose compensation are paid by temporary agencies are excluded from the Plan.

Contributions

Contributions are subject to Internal Revenue Code ("IRC") limitations. Contributions to the Plan are funded on a per pay period basis.

Participant contributions – Employees may contribute any portion of their eligible compensation, not to exceed the annual compensation allowed by the IRS. Automatic enrollment for a new participant results in withholding 3% of the participant's eligible pay with automatic annual increases of 1% until the participant's contribution percentage equals 6%, or the election is changed by the participant. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute to the Plan through a rollover contribution from another qualified source.

Company contributions – The Company contribution includes a core contribution of 3% whether participants elect to contribute to the Plan or not. The Company matches 50% of the employee's contribution up to 6% of compensation for a total match of 3% of compensation. The maximum match plus core contribution is 6% of compensation.

1. DESCRIPTION OF THE PLAN (continued)

Participant accounts

Each participant's account is credited with the participant's contribution, employer contribution, and an allocation of investment earnings and losses, and is charged with certain utilization-based fees, as applicable. Participants are entitled to the benefit that can be provided from the participant's vested account. Plan participants are able to direct the investment of their Company and employee contributions into various investment options offered under the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus actual earnings thereon is based on years of vesting service. Participants become 100% vested in the Company's matching contributions after they complete two years of service.

Forfeited accounts

Upon termination of employment for reasons other than a distributable event, non-vested Company contributions and related investment earnings are forfeited. Such forfeitures may be used to reduce Plan expenses or to satisfy matching contributions that would otherwise be made by the Company. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$21,025 and \$7,106, respectively. During 2024 and 2023, the Company used forfeitures totaling \$34,369 and \$45,000, respectively, to reduce its contributions and administrative fees.

Notes receivable from participants

Participants are allowed to borrow from their Plan accounts. The minimum amount that a participant may borrow is \$1,000. The maximum amount that a participant may borrow is the lesser of: (i) 50% of the participant's vested balance; or (ii) \$50,000 less the highest loan balance outstanding in the previous twelve months. Participants are allowed to have two loans outstanding at a time. Loans are secured and bear a reasonable interest rate. Except for unpaid leaves of absence, loans must be repaid through payroll deductions. All outstanding loan balances are due within 90 days upon termination or are treated as taxable distributions unless repaid in full. Interest rates ranged from 3.25% to 8.50% with amounts payable through June 2038 at December 31, 2024.

Payment of benefits

After termination of employment for any reason, (e.g. resignation, death, disability, retirement etc.), a participant (or his/her beneficiary in the case of the participant's death) may elect to receive either a lump sum amount equal to the participant's vested account balance or to rollover their vested account balance to another qualified retirement plan or IRA, as described in the Plan document. Participants may also leave their account balance in the Plan until they reach age 70.5.

Payment of benefits (continued)

Participants who meet the Plan's requirements may receive an in-service hardship distribution from the vested portion of their account balance. Hardship distributions are not permitted from a Participant's Qualified Nonelective Contribution Account. The maximum hardship withdrawal is limited to the participant's elective deferral balance and the related earnings of which the participant is 100% vested.

Rollover contributions

The Plan accepts qualifying rollover contributions made by participants from tax-qualified retirement plans or individual retirement accounts. Participants may under certain conditions, contribute the distribution from another qualified retirement plan, an individual retirement account or a portion of the distribution to the Plan. The rollover contribution will be credited to a rollover account. Rollover contributions are permitted for any employees in eligible employment, not just employees who have qualified as participants in the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with the accounting principles generally accepted in the United States of America ("US GAAP").

Use of estimates

The preparation of financial statements in accordance with US GAAP requires Plan Management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances. Related fees are recorded as administrative expenses and expensed when they are incurred.

Payment of benefits

Benefit payments to participants are recorded when paid.

Expenses

Administrative expenses are generally paid by the Plan, except to the extent that the Company, at its discretion, directly pays for certain expenses. Expenses paid by the Company are excluded from these financial statements. Recordkeeping fees, loan administration fees, overnight check fees, and hardship fees are charged directly to the participant's account and are included in administrative expenses in the accompanying statements of changes in net assets available for benefits. Investment related expenses are included in the net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES (UNAUDITED)

The Plan administrator having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the trustees, determined to be qualified institutions by the Plan administrator, as accurate and complete, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedules. The trustees have certified that the following data included in the accompanying financial statements is complete and accurate:

Investments reflected on the accompanying statements of net assets available for benefits of December 31, 2024 (Transamerica Trust Company) and 2023 (Reliance Trust Company).

Net appreciation in fair value of investments and interest and dividends as shown in the accompanying statement of changes in net assets available for benefits for the period of January 1, 2024, through June 27, 2024, (Reliance Trust Company) and for June 28, 2024, through December 31, 2024 (Transamerica Trust Company).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology included:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable relevant inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan has received a determination letter from the IRS dated June 30, 2020, stating that the plan is qualified under Internal Revenue Code ("IRC") Section 401(a) and, therefore, the related trust is exempt from taxation. Once qualified, the plan is required to operate in accordance with the IRC to maintain its qualification. The plan administrator believes the plan is being operated in compliance with the applicable requirement of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although the Company has not expressed any intent to terminate the Plan, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, active participants not fully vested in the Plan would become 100% vested; inactive participants continuing to hold assets with the Plan, and who have been employed by the Company at any time during the two years preceding the Plan termination, would become 100% vested.

7. PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation, arrangements, expense allowances or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Company pays certain fees and expenses on behalf of the Plan. These transactions qualify as party-in-interest transactions.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available for issue.
